The Hon'ble Supreme Court has held that "The course adopted by the High Court is to displace one ad-hoc arrangement by persons who have gained experience which will be more beneficial and useful to the colleges concerned rather than to appoint persons afresh on ad-hoc basis". The Hon'ble Supreme Court has given directions that ad-hoc employee / Doctors "shall be continued in service till regular appointments are made in minimum of the pay scale." All the applicants are working on ad-hoc basis on the post of Assistant Professors in the various Departments of Government Medical College.

4. Now, the Government has issued Advertisement to replace them by another ad-hoc appointment. In view of the Judgment of the Hon'ble Supreme Court ad-hoc employee

cannot be replaced by another ad-hoc employee till the regular employee is appointed by the Government. **Hence, we direct the respondents not to replace the applicants by another ad-hoc Assistant Professor till the regular appointment is made by M.P.S.C..**

6. Issue notice to respondents returnable on **10.10.2024**. Learned C.P.O. waives notice for State. Hamdast allowed.

7. Tribunal may take the case for final disposal at this stage and separate notice for final disposal shall not be issued.

8. Applicant is authorized and directed to serve on Respondents intimation / notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Respondent is put to notice that the case would be taken up for final disposal at the stage of admission hearing.

The Hon'ble Supreme Court has given directions that ad-hoc employee / Doctors "shall be continued in service till regular appointments are made in minimum of the pay scale." All the applicants are working on ad-hoc basis on the post of Assistant Professors in the various Departments of Government Medical College.

4. Now, the Government has issued Advertisement to replace them by another ad-hoc appointment. In view of the Judgment of the Hon'ble Supreme Court ad-hoc employee cannot be replaced by another ad-hoc employee till the regular employee is appointed by the Government. **Hence, we direct the respondents not to replace the applicant by another ad-hoc Assistant Professor till the regular appointment is made by M.P.S.C..**
