It explains that the qualification prescribed is a minimum qualification and, therefore, a person holding a degree in Agricultural or equivalent is not barred from competing for the post. As regards the recruitment by promotion, no fault can be found with the powers of the State being exercised under Article 309 of the Constitution of India. In the circumstances, the following order.

ORDER

The present Original Application is hereby dismissed without any order as to costs."

4. Ld. Advocate for the Applicant further mentions that the issue is also been heard at Nagpur Bench in OA No.288 of 2018.
5. Whether the present OA as well as OA at Nagpur bench needs to be clubbed together will have to be decided.
6. Place the above matter before Hon'ble Chairman for appropriate orders.
7. Issue of interim relief is kept open.
8. S.O. to 11.10.2018 before Division Bench. High on board.
9. Registrar is directed to call for record and proceedings in OA No.682 of 2018 from Aurangabad Bench of this Tribunal.
