In that matter, the notices were issued to the Respondents but the notice of the Respondent No.1 was not served. Therefore, it was fixed for taking steps for service of notice of the Respondent No.1. 4. The Applicant has not moved the present Misc. Application No.593 of 2018 for restoration of Misc. Application No.324 of 2019 within stipulated period of limitation. There is no provision in the Maharashtra Administrative Tribunal (Procedure) Rules, 1988 to condone the delay caused for filing the restoration application. Therefore, the application is not maintainable. Not only this, but in para no.3 of the present application, the Applicant has contended that the Applicant could not remain present on 09.10.2019 as the matter was not marked on board. The statement made by the Applicant appears to be false. The matter was marked and listed on board on 09.10.2019 and it was dismissed on that day as nobody appeared for the Applicant. Therefore, the ground raised by the Applicant for his non-appearance on that day is not satisfactory and justifiable.

5. There is no just ground to allow the Misc. Application No.593 of 2019 and to restore the Misc. Application No.324 of 2019. Therefore, the same deserves to be rejected.

6. In view of the above, the Misc. Application No.593 of 2019 is rejected. Consequently, the Misc. Application No.324 of 2019 In O.A.No.577 of 2019 also stands rejected. No order as to costs.

2. Applicant has filed present misc. applications for setting aside the order of dismissal passed by the Tribunal in O.A. nos. 574/2015 and 575/2015 on 11.3.2019 and also prayed to condone the delay caused for filing the applications for restoration of O.As.

3. On perusal of record it reveals that the applicant and his Advocate remained absent on 29.1.2019 therefore this Tribunal issued notices to the applicant by R.P.A.D. But the notice was not served on the applicant as he was not found on the address. Therefore, both the O.As. were placed before the Tribunal on 11.3.2019, but none appeared for the applicant and therefore the Tribunal dismissed both the O.As. on that day.

4. From the date of dismissal the applicant ought to have filed the applications for restoration of O.As within 30 days in view of the provisions of the rule 16 (2) of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988. But the applicant has not filed the present applications for restoration of O.As. within 30 days from the date of dismissal of O.As. Therefore there is no provision to condone the delay caused for filing restoration application. Therefore present M.A. is not maintainable. Moreover, no justifiable cause is shown by the applicant for restoration of O.As and to set aside the order of dismissal of O.As. Therefore on that count also the restoration applications deserve to be dismissed.

5. In view of above, both the misc. applications stand dismissed. There shall be no order as to costs.
