After going through the judgment of Dr Sanjay Kadam (cited supra), we found that the State Government had not follow the ratio laid down in the judgment while increasing the age from 58 to 60 years and 60 to 62 years when it was increased earlier by issuing GR dated 03.09.2015, 29.08.2018, 01.07.2019 and even after the judgment was passed on 20.03.2020 as State Government again issued GR dated 09.08.2021. 5. Learned CPO submits that the 'State Cabinet' took the decision of increasing the age from 58 to 60 and 60 to 62 years by giving retrospective effect. However, still we have query how extension of age can be given when the person retires on next date after attaining the age of 58 years and therefore, we want to verify whether the ratio laid down in judgment in WP No.5402/2018 (Dr. Sanajay Ramrao Kadam & Ors. V/s State of Maharashtra), dated 20.03.2020 was breached and contrary decisions were taken by the State Government in increasing age of retirement of Medical Officers.
