- 1. The applicant prays that this Tribunal be pleased to direct the Respondent to allow the applicant to appear for the interview for the post of Assistant Chemical Analyzer, General State Services, Group-B, for one post of S.T category.
- 2. Learned counsel for the applicant states that by the impugned communication, issued by the Respondent, the applicant was informed that as he is not fulfilling the requisite educational qualification, he is disqualified and not allowed to appear for the interview.

- 3. Learned counsel for the applicant seeks permission to amend the Original Application by adding Secretary, Home Department, Mantralaya, Mumbai, Secretary, Higher & Technical Education Department, Mantralaya, Mumbai and the Director, Directorate of Forensic Science Laboratory, Mumbai, Respondents. Permission granted. Amendment to be carried out forthwith and copy to be served on the added Respondents.
- 4. Learned counsel for the applicant has submitted that the applicant has completed M. Sc (Medicinal Chemistry) and as per clause 8. 1 of the advertisement dated 14.12.2022, the candidate is required to possess "a post graduate at least in second class in any branch of Chemistry or Bio-Chemistry of a recognized University or an equivalent qualification". Further, it is stated in clause 8.3 of the said advertisement that the equivalence is decided as per G.R dated 18.10.2016. The said G.R dated 18.10.2016, is at Exh. L, page 40, about equivalence on educational qualification. In the said G.R, at Sr. No. 31. Column no. II states about Disciplines, that is Chemistry, Column No. III states about Bachelor's Degree and Column No. IV states about Master's Degree, i.e., in equivalent Disciplines. Learned counsel for the applicant submits that the applicant also holds degree in B. Sc (Chemistry). In Column No. IV, regarding Master's Degree, Medicinal Chemistry is not shown as equivalent.
- 5. It is true that Medicinal Chemistry is not shown as equivalent. However, the applicant has produced a letter dated 6.7.2023 from the Centre for Advanced Studies in Chemistry of Department of Chemistry, Savitribai Phule Pune University, Pune, stating that "the Medicinal Chemistry course conducted by the Department of Chemistry is equivalent to the Maters course in Chemistry." The said letter is signed by Prof. V.S Shinde,

Coordinator, Medicinal Programme and Prof. A.S Kumbhar, Head, Department of Chemistry.

- 6.
