Admitted facts:

2. The Applicant was working as Chief Officer in the Vengurla Municipal Council from 28.8.2002 to 14.7.2006. For the activities done by him and following the report, the enquiry was concluded by Sub Divisional Officer and report was submitted on 18.11.2017 and Criminal Case No.42 of 2017 was registered against the Applicant and the President of Municipal Council under Section 5 of the Environment Act in the Court of JMFC, Vengurla. The Magistrate has taken cognizance on 13.6.2018

and issued process against the Applicant. The Applicant has received the pensionary benefits except regular pension and gratuity. He is getting provisional pension. He is praying for the amount of gratuity and regular pension. In support of the same, the Ld. Advocate for the Applicant relies on Rule 27(3) and 27(6) of the MCS (Pension) Rules, 1982, which reads as under:

"27. Right of Government to withhold or withdraw pension:-

(3) No judicial proceedings, if not instituted while the Government servant was in service, whether before his retirement or during his re-employment, shall be instituted in respect of a cause of action which arose or in respect of an event which took place, more than four years before such institution.

(6) For the purpose of this rule,

(a) departmental proceedings shall be deemed to be instituted on the date on which the statement of charges is issued to the Government servant or pensioner, or if the Government servant has been placed under suspension from an earlier date, on such date and

(b) judicial proceedings shall be deemed to be instituted-

(i) in the case of criminal proceedings, on the date on which the complaint or report of a police officer of which the Magistrate takes cognizance is made, and

(ii) in the case of civil proceedings, on the date of presenting the plaint in the Court."

3. The Ld. Advocate, therefore, contends that there is complete bar for departmental proceedings. Hence, he feels that there should be no holding back his payment of gratuity.

4. Ld. PO for the Respondents refers to Rule 130(c) of the MCS (Pension) Rules, 1982, which reads thus:

“130. Provisional pension where departmental or judicial proceedings may be pending,-

(1) (c) No gratuity shall be paid to the Government servant until the conclusion of the departmental or judicial proceedings and issue of final orders thereon.”

5. Ld. PO, therefore, contends that gratuity and regular pension cannot be released to the Applicant till the completion of judicial proceedings.
