2. The learned Presenting Officer has submitted that in the present M.A. the notices are yet to be issued to the respondents and therefore he is not in a position to offer any comment. He therefore prays for issuance of notices to the respondents.

3. The applicant has based his claim for grant of relief on the basis of G.R. dated 17.12.2021. However, on going through the said G.R., it appears that, said GR deals with the recruitment in Government services through nomination and not for appearing for competitive examination like NEET and so on and therefore, the basic policy decision based on which relief has been sought by the applicants does not sustain.

4. In the present context, the implication of the prayer clause of the O.A. is to provide for relaxation of upper age limit as eligibility criterion drawing a parallel with provision of relaxation of upper age limit for recruitment by nomination as stipulated in GR dated 17.12.2021. However, the same falls under domain of executive being a policy decision. For adjudication the respondents need to be given opportunity of being heard.

5. In the circumstances, Issue notice to the respondents in the present MA, returnable on 7.12.2022.
6. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

2. Learned Advocate for the applicant expresses apprehension that respondents may terminate the extension granted to the contractual service of 5 months & 15 days after receiving notice of Contempt.

3. However, the applicant has submitted the amendment application wherein a new element of "period of 3 years" was sought to be introduced through amendment para 38-B and 38-C. Likewise, though amendment prayer clauses E & F, an injunction has been sought restraining the applicant from making appointment on the post of Sports Teacher beyond their contract period extending up to final disposal of the OA.

4. Later on, the applicant submitted second version of amendment, which speaks of 33 months' tenure in para 38-C and retains the prayer clauses E & F in addition seeks to introduce a new amendment prayer clause G.

5. In view of above, the matter needs to be examined after taking the reply of the respondents on record.

6. In the circumstances, Issue notice to the respondents in the present MA, returnable on 21.11.2022.

7. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

2. The present matter has been circulated today on Supplementary Board and therefore the learned P.O. has expressed his ability to comment on facts pleaded in the O.A. and the prayer clause made therein. However, from the submissions made by the learned counsel and the facts on record following background facts emerge :-

(i) The applicant joined the PG Diploma through NEET in May, 2018 and executed a bond for serving for the State Government in Public Health Department for minimum period of 03 years (excluding leave and absence).

(ii) The applicant executed a bond for serving Public Health Department on 21.5.2018 and resumed duty on completion of P.G. (Diploma) on 24.9.2020.

(iii) The applicant has been declared 'NOT ELIGIBLE' for admission to PG Degree course on first ground that he has not completed bond period of 3 years as per clause 9 of GR dated 19.3.2019. The applicant impliedly seeks to relaxation in the condition of

completion of bond period of 3 years as eligibility criterion.

(iv) The second important aspect is that the applicant had applied for getting NOC from the Deputy Director of Health Services on 15.2.2022. Though the applicant has not submitted a copy of application submitted by him for PG NEET examination to ascertain on which date he had applied for PG NEET examination, still it is to be inferred that it is prior to 15.2.2022. Accordingly, the applicant has been decided as ineligible for counseling and the decision is available for ready reference on page 112 of paper book, which reads thus :-

“as per 9 of GR 19.3.2019 & 9.1 of 26.3.2020 not eligible as bond not completed. Also NOC not issued.”

(v) From record it appears that NOC has been issued by the Deputy Director of Health Services, Pune on 20.5.2022, copy of said NOC is placed on record at page 96 of paper book.

(vi) Careful reading of clause 4.1 of GR dated 19.3.2019, which reads as under :-

“(४.१) प्रवेश परिक्षेस (NEET PG) बसण्यास संबंधित उपसंचालक, आरोग्य सेवा, परिमंडळ यांची लेखी परवानगी घेणे अनिवार्य आहे. तसेच प्रवेश परीक्षेला (NEET PG) बसण्यासाठी उपसंचालकांची परवानगी न घेता थेट अर्ज करणाऱ्या सेवांतर्गत वैद्यकीय अधिकाऱ्यांना पदव्युत्तर अभ्यासक्रमासाठी कार्यमुक्त केले जाणार नाही.”

(vii) From above mentioned facts, it prima-facie appears that the respondent authorities are treating

that the applicant has submitted his application for NEET PG 2022 examination before submitting application for getting NOC and therefore they are treating that NOC was not obtained at appropriate point of time. However, clause 4.1 of the said GR dated 19.3.2019 says that NOC be obtained before NEET PG examination and not before applying for the said NEET PG Examination. In any case the Deputy Director has issued the NOC on 20.5.2022 and therefore it may not be appropriate on the part of the respondents to back-out and say that the NOC at appropriate stage was not obtained.

3. On considering the facts before me it appears that the issue of stage on which NOC has to be obtained being of a technical nature could have been decided in absence of regular D.B. However, considering the requirement of interpretation of clause 9 of the GR dated 19.3.2019 it would be more appropriate to take up the matter before D.B. for final decision. Doing so is more important as the said GR has been issued by the State Government in exercise of powers vested in it as per entry 25 of concurrent list of 7th Schedule of Indian Constitution and its interpretation will have wider implication.

2. Applicant was appointed as Medical Officer Group-A on ad-hoc basis on 05-03-2012 and posted in Ahmednagar District. Even after regularization as Medical Officer Group-A, she continued to work in the District Ahmednagar till date. Thus, her total service of around 10 years has been in the District Ahmednagar. It is also admitted by the two sides that the applicant had obtained "No Objection Certificate" for permission for appearing in NEET PG 2022 for admission in post graduate degree course in Pathology as she has already acquired post graduate diploma in Pathology. Admittedly, the applicant has secured

289 marks out of 800 in NEET PG 2022 and her entire service has been in Ahmednagar District which does not fall under the category of remote, difficult or rural areas including naxalite affected areas, therefore, she is not eligible to be awarded any additional weightage to be added to NEET PG 2022 marks for preparation of State level merit list. It is also admitted that as per the applicable regulation, the applicant, who has not served at all in remote, difficult or rural areas, is not eligible for admission against in service quota, limit of which has been kept as 20% of total available seats in Government medical colleges.

3. However, the candidature of the applicant is admittedly eligible for consideration under category mentioned in paragraph 6.1, 6.2 & 6.3, which deals with candidates who have not completed 3 years' service in remote, difficult or rural areas. It is also admitted that out of 3 categories of 6.1, 6.2 & 6.3, the applicant who has not completed even one year service in remote, difficult or rural areas precisely, falls in the category of 6.3 of Public Health Department Resolution dated 19-03-2019 which outlines revised rules for

selection of candidates for P.G. degree and diploma courses.

4. Accordingly, the Directorate of Health Services vide communication dated 06-10-2022 has through the learned P.O. submitted before the Tribunal that the applicant is eligible to be considered under clause 6.3 of the said G.R.

5. In the above mentioned background facts, the applicant has prayed for interim relief as follows:

“(a) By an order of interim relief, the operation of the order dated 29-09-2022 of the Director, Health Services declaring the applicant as not eligible for admission to PG Course be stayed and suspended.

(b) By an order of interim relief, the Commissioner, State CET Cell Mumbai – respondent No.3 may kindly be directed to consider the candidature of the applicant for admission to the PG Pathology Course as per her merit and to give admission to the applicant to the post graduate concerned course.”

6. However, on perusal of the order dated 29-09-2022 issued by Director, Health Services, it appears that it only deals with the list of the candidates who are eligible for consideration under in-service quota. Therefore, inference can be drawn that there is no communication on record which debars the applicant for consideration on merit for admission to PG degree course. The said communication issued by the Directorate of Health Services mentions the kind of leave admissible to candidates covered by clause 6.3 of the said G.R. of 19-03-2019.

7. Further, no fact has been brought on record to substantiate the apprehension of the applicant that applicant's case will not be considered for admission to PG Pathology post graduate degree course on its own merit as per extant rules.

8. I don't find any merit for grant of interim relief at this stage. In my considered opinion the present O.A. is misconceived as devoid of merit. However, as the applicant has expressed desire that only application for interim relief be decided, in absence of Division

Bench, the order is limited to the aspect of interim relief only and the matter may be placed before the Division Bench on 12-10-2022 for decision on the Original Application.
