*B. To direct the respondent no.4 to decide the Appeal filed 21.09.2023 by the applicant for investigate EWS certificate of the Respondent no.5 before completing the requirement process post of police patil in District Jalgaon (ANNEXURE-“A-12”)*

*A. To direct the respondent no.3 not to proceed further requirement process post of police patil in District Jalgaon pending hearing and final disposal of this original application.*

*B. To grant interim stay the requirement process post of police patil in District Jalgaon, pending hearing and final disposal of this original application.*

*C. In the alternative, to direct the respondent No.3 not to advertise and recruit the post of Police Patil, Pashtane (Bu), Tq;Dharngaon, Dist: Jalgaon, pending hearing and final disposal of this Original Application;*

*D. To grant such further reliefs as the Hon'ble Tribunal may deem fit in peculiar circumstances of this case."*

{Note: - Prayers are reproduced ad-verbatim from paper book page 13 & 14 of O.A. It appears that the applicant has inadvertently used word "requirement process" instead of "recruitment process" and also there are typographic mistakes while giving numbering to prayer clauses. While considering the submissions made on behalf of the applicant, I have considered the said prayers by reading the words "requirement process" as "recruitment process."}

3. As is revealing from the contents of the O.A., the applicant has filed an appeal before the Sub Divisional Magistrate, Dhule raising objection in regard to the EWS Certificate issued in favour of respondent no.5. It is the contention of the applicant that respondent no.5 has obtained the said certificate by making false submission before the concerned authority. It is further contended that respondent no.5 is taking the benefit of the said certificate in the recruitment process for the post of Police Patil in Jalgaon District.

4. I have read entire text of the O.A. Why such prayers are being made in the present O.A. is nowhere disclosed by the applicant. Learned Counsel for the applicant was asked to clarify the reason for making such prayers before this Tribunal. Learned Counsel submitted that the applicant was one of the participants in the said recruitment process and he, therefore, has right to make such prayers in the present O.A. and this Tribunal has jurisdiction to try and entertain the O.A. with the aforesaid prayers.

5. Learned Counsel was thereafter called upon to explain how the applicant is aggrieved by the order passed by respondent no.3 against which the applicant has preferred an appeal. Learned Counsel for the applicant submitted that to the candidature of the applicant objection was raised by one Dinkar Nawal Patil alleging that the applicant does not belong to EWS category for which the post of Police Patil is reserved and the applicant had applied for the said post claiming himself to be belonging to the said category. The record reveals that the objection so raised was sustained by the Sub Divisional Magistrate, Erandol vide his order dated

18-09-2023. Learned Counsel further submitted that the said objection was raised at the instance of respondent no.5. Learned Counsel further submitted that respondent no.5 has obtained the EWS certificate by making false submission before the Government authority. Applicant has, therefore, challenged the said EWS certificate issued in favour of respondent no.5 before the Sub Divisional Magistrate, Dhule.

6. After having considered the facts as aforesaid, it is quite evident that the present application cannot be entertained by this Tribunal under the provisions of the Administrative Tribunals Act, 1985. In the present O.A. applicant has not challenged any order pertaining to any matter within the jurisdiction of this Tribunal. Applicant is seeking directions from this Tribunal against the respondent no.4 to decide appeal filed by him on 21-09-2023 whereby he has raised an objection about the EWS certificate issued in favour of respondent no.5. Considering the provisions of the Administrative Tribunals Act, 1985, the O.A. with the aforesaid prayers cannot be entertained by this Tribunal.

7. Applicant has also prayed for directions against respondent no.3 restraining him from carrying out the further recruitment process for the post of Police Patil in District Jalgaon. Applicant has not explained his locus for seeking such orders from this Tribunal. It is not the case of the applicant that his application has been rejected for wrong reasons by respondent no.3. It is also not the claim of the applicant that he is entitled to be appointed on the said post. Considered the matter from all angles, it does not appear to me that such an application can be entertained by this Tribunal. Hence, the following order:

ORDER

[i] Original Application is rejected being not maintainable under the provisions of the Administrative Tribunals Act, 1985.

[ii] There shall be no order as to costs.

2. The applicant has preferred the present application seeking condonation of delay, which has occasioned in filing the annexed Original Application by him in which he has prayed for grant of deemed date in the cadre of Deputy Engineers as 1.12.1999, the day on which the persons junior to him are stated to be promoted to the said post. It is the case of the applicant that he belongs to Scheduled Caste and for the S.C. candidates there is some relaxation in the period and chances for passing the departmental examination.

3. Learned counsel for the applicant pointed out that insofar as the candidates falling in Open category are concerned, they are supposed to pass the departmental examination within 03 years and within 03 chances, whereas for the candidates

belonging to S.C. category, the period is extended by 01 year and 01 chance. The applicant was thus to pass the departmental examination within 04 years and 04 chances. Learned counsel submitted that accordingly though the applicant passed the departmental examination within the stipulated period and within stipulated chances, the juniors to the applicant, who passed the departmental examination prior to the applicant, were promoted first and were shown in the seniority list above the applicant. In such circumstances the applicant has prayed for giving the deemed date on which his juniors were promoted on the promotional post to the applicant.

4. The learned counsel submitted that the proposal regarding grant of deemed date of promotion to the applicant was under active consideration of the State authorities till year 2016 and, as such, applicant did not move/approach to the Court or Tribunal expecting that favourable orders may be passed by the Government. The learned counsel further submitted that when no

orders were passed though the applicant did wait for quite a long period, the applicant has ultimately approached this Tribunal. The learned counsel submitted that in fact the State is under an obligation to pass necessary orders even without requiring the applicant to make any such formal request and to discharge the duties cast upon it. The learned counsel further submitted that when the State has failed in discharging the duties cast upon it, the applicant has knocked the doors of the Tribunal. According to the learned counsel, in the aforesaid circumstances, if some delay has occurred in filing the Original Application, it is liable to be condoned having regard to the fact that lawful claim of the applicant is denied to him.

5. Learned Presenting Officer has opposed for condoning the delay stating that the applicant has not made out any case or any cause to condone the delay. Learned P.O. submitted that in absence of any cogent reason the delay cannot be condoned. Learned P.O. further submitted that the delay cannot be said to be only from year 2014, but has to

be reckoned from the date on which the applicant claims to have been eligible for such deemed date i.e. from year 2003. Learned P.O. further submitted that because of inaction and laches on part of the applicant in approaching the Tribunal and for not citing any such reason for condoning the delay, the Misc. Application is to be rejected.

6. I have considered the submissions advanced by learned counsel appearing for the applicant and learned Presenting Officer. By filing the Original Application the applicant has sought directions against the respondent to grant him the deemed date of promotion in the cadre of Deputy Engineers as 1.12.1999 by placing him ahead of his juniors. As is revealing from the pleadings in the O.A., the juniors to the applicant were granted promotions to the cadre of Deputy Engineers w.e.f. 1.12.1999. The promotion order of the applicant was issued on 4.11.2003. It is thus evident that cause of action for seeking deemed date of promotion has arisen on 4.11.2003. Though it is the contention of the applicant that he started making representations

inter alia pointing out that his juniors namely S/s Nitin Dinkar Pote and Rajendra Hari Chavan having been promoted ahead of him w.e.f. 1.12.1999, he be given the deemed date of promotion as 1.12.1999 and though it is his further contention that his representation and the request made therein was under active consideration of the respondents up to the year 2016, it is significant to note that the very first representation seeking deemed date of promotion was filed by the applicant in the year 2010.

7. It is thus evident that though the right has accrued in favour of the applicant on 4.11.2003, the applicant asserted the said right after the period of about 6-7 years. The applicant has not given any explanation why he did not make a representation immediately and waited for such a long period of more than 6 years. Further, it is the case of the applicant himself that his representation and request made therein was under active consideration of the respondents till the year 2016. If no progress was noticed by the applicant after 2016, the

applicant has not provided any cogent explanation why he took long 6 years thereafter in approaching the Tribunal. The only reason which has been assigned by the applicant is that the delay has been caused due to wishful thinking of the applicant that his grievance would be redressed by the respondents.

8. The aforesaid explanation in my opinion cannot be held “a sufficient cause” for condoning the huge delay of about 17 years. As per Administrative Tribunals Act, 1985 the limitation period is one year. It is well settled that if the sufficient cause is made out the delay of longer period also can be condoned, whereas the delay of smaller period also cannot be condoned, if no sufficient reasons are given. In the instant matter, as I have noted above, though right has accrued in favour of the applicant in the year 2003 itself, the very first representation was filed by the applicant after 7 years i.e. in the year 2010 and when no progress was seen on part of the respondents in considering his request after 2016, the applicant did not move thereafter for more than

06 years. I, therefore, see no reason for condoning the huge delay. In the result, the following order is passed: -

**ORDER**

- (i) M.A. stands dismissed. Consequently, O.A. on stamp number 340/2022 also stands disposed of.
- (ii) There shall be no order as to costs.
