2. Learned counsel appearing for the applicant sought leave of this Tribunal to correct the address of respondent No. 1. Leave as prayed for is granted. The necessary amendment be carried out forthwith.

3. Applicant has filed the present Original Application seeking quashment of the order dated 5.5.2022, as well as, order dated 11.7.2022, whereby the recovery is directed against the applicant on account of alleged unauthorized occupation of the Government quarter after being transferred from the said place. Learned counsel submitted that the applicant's transfer was one way transfer and nobody has been appointed in his place. Learned counsel further submitted that wife of the applicant is undergoing a serious ailment and

she is under treatment at Parbhani and that was the reason that the applicant was required to retain the quarter at Parbhani in his possession even after he is transferred to Deglur. Learned counsel further submitted that on account of ill-health of the wife of the applicant he also made an application for cancellation of his transfer and for his retention at Parbhani and the same request is under consideration. Learned counsel submitted that before ordering recovery of the impugned amount the applicant was not given any opportunity of hearing nor any notice was given to the applicant. Learned counsel submits that three installments have already been recovered from the salary amount of the applicant. It is further contended that after deduction of the said amount very meager amount is being received by the applicant, which is too insufficient for bearing household expenses, as well as, medical expenses towards ill-health of his wife. Learned counsel in the circumstances has prayed for an interim relief thereby restraining the respondents from recovering the amount on the basis of the impugned order dated 11.7.2022.

4. Learned Presenting Officer has opposed for granting any interim relief as has been prayed for by the applicant. Learned P.O. pointed out that in the very first notice dated 5.5.2022 the applicant was given clear understanding that he has not submitted any application for retention of quarter and if he fails to vacate the quarter within 7 days of receipt of the said notice he may be subjected for penal charges according to prevailing practice. Learned P.O. submitted that even after receipt of the said notice, till today the applicant did not make any formal request for retaining the quarter and he is illegally occupying the quarter. As such, according to the learned P.O., no case is made out by the applicant for granting interim relief as has been prayed by him.

5. I have carefully considered the submissions advanced by learned counsel appearing for the applicant and the learned Presenting Officer appearing for the respondent authorities. I have also gone through the documents filed on record.

6. It is not in dispute that the applicant did not make any formal application for retention of the quarter after he was transferred from Parbhani to Deglur. However, from the record which the applicant has produced, it is revealed that there are several other quarters, which are vacant and no inconvenience is likely to be caused because of retention of the quarter by the applicant. It was, of course, the responsibility of the applicant to make application for retention of quarter, which he has not made. Learned counsel pointed out that subsequently such application is made by the applicant and request has also been made by giving reply to the notice dated 7.7.2022. As has been submitted by learned counsel for the applicant it is beyond capacity of the applicant to pay damages at the rate they are charged. Learned counsel also invited my attention to the Government Resolution dated 15.6.2015 laying down the guidelines for payment of damages in case of retention of quarter after transfer or after retirement. There appears some substance in the arguments advanced by the learned counsel that before imposing such heavy penalty clear notice was required to be given to the

applicant in that regard. As such, it appears to me that *prima facie* case is made out by the applicant at least till affidavit in reply is filed by the respondent authorities. In the circumstances, I deem it appropriate to pass the following order: -

ORDER

- (i) Issue notice to respondents, returnable on 2.12.2022.
- (ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- (iii) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- (iv) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

(v) The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

(vi) Respondents are restrained from recovering any more amount in pursuance of the notice dated 7.7.2022 till filing affidavit in reply by them.

(vii) S.O. to 2.12.2022.

(viii) Steno copy and Hamdast is allowed to both parties.

ORIGINAL APPLICATION NO. 31 OF 2022
(Vijay Ravindra Bangar Vs. State of Maha. & Ors.)

2. The applicant has filed the present Original Application seeking quashment of the order passed by respondent No. 4 on 29.8.2015 and consequently has prayed for direction against the said respondent to include name of the present applicant for getting compassionate appointment in place of the deceased Government employee namely Ravindra Sitaram Bangar.

3. Respondent No. 4 has rejected the request of the present applicant for compassionate appointment or for substituting his name for compassionate appointment in place of his stepbrother namely Abhijit Ravindra Bangar on the ground that the Service Rules governing the Police employee do not permit such substitution. Few

facts are necessary to be noted down for the effective decision of the present application, which are thus,

4. The deceased Government employee namely Ravindra Bangar was having two wives. As has been claimed by the applicant his mother was first wife of the deceased Ravindra and mother of respondent No. 5, Abhijit was second wife of the deceased. Deceased Ravindra died on 25.5.2010. On 2.6.2010 the applicant presented application with respondent No. 4 for seeking compassionate appointment and inclusion of his name in the list of such candidates. Respondent No. 5 also preferred application with the same request on 3.6.2010. Respondents considered the application of respondent No. 5 and included his name in the list of the candidates to be eligible for giving appointment on compassionate ground. The said decision was challenged by the present applicant by filing O.A. No. 481/2016 before this Tribunal. The said O.A. came to be disposed of by this Tribunal with the direction to the respondent authorities to reconsider the decision in light of the decision rendered by the Tribunal in O.A. No. 184/2005 and

with the said direction the aforesaid application was permitted to be withdrawn by this Tribunal with liberty to file fresh O.A. if contingency so arises. The applicant, therefore, made a fresh representation on 27.12.2017 with reference of the order passed by this Tribunal in O.A. No. 481/2016. Respondent No. 5 however, rejected the request of the applicant vide impugned order on the same ground on which earlier request of the applicant was rejected. Respondent No. 4 has stated that in the rule which governs the service condition of deceased employees do not have any provision of substitution of the nominee of the deceased for getting compassionate appointment.

5. Learned Counsel appearing for the applicant submitted that in fact the applicant who is son of first wife claimed the compassionate appointment earlier to the application of the respondent no.5, however, without even informing the present applicant or requiring him to show cause as to why appointment shall not be issued to respondent no.5, respondent no.4 straightway considered the case of respondent no.5 and included the name of the said

respondent in the list of eligible candidates for compassionate appointment. Learned Counsel further pointed out that the dispute was going on between two families i.e. the family of the first wife and second wife of the deceased Ravindra Bangar. Learned Counsel further submitted that M.C.A. No.162/2010 was filed by mother of the present applicant, present applicant and his sister seeking succession certificate being legal heirs of the deceased Ravindra Bangar. Similar application was filed by Shantabai W/o Sitaran Bangar (Deceased), the mother of deceased Ravindra Bangar, second wife of the deceased, namely, Smt. Anjali Ravindra Bangar, the mother of respondent no.5 along with others and the said MCA was numbered as MCA No.258/2010. Learned Civil Judge Senior Division, Parbhani was pleased to allow both applications in part and the present applicant was declared the successor of deceased Ravindra Bangar and succession certificate was accordingly directed to be issued in his name along with his mother and his sister. The said decision was challenged by Shantabai W/o Sitaram Bangar (Deceased) i.e. mother of deceased employee Ravindra Bangar

along with mother of respondent no.5, namely, Smt. Anjali Bangar, respondent No. 5 himself & his brother namely Abhilash S/o Ravindra Bangar, by filing M.C.A. No.25/2013 before the District Judge at Parbhani. Learned Counsel further pointed out that in the said MCA, the parties arrived at compromise and the said appeal was disposed of in terms of the said compromise. Learned Counsel further pointed out that in the compromise so arrived between the parties, it has been agreed that the right to receive the compassionate appointment is to be exercised by the present applicant and the respondent no.5 accorded his no objection for substitution of name of the present applicant in his place. Learned Counsel submitted that all these documents, though were duly brought to the notice of respondent no.4, respondent no.4 did not change his earlier order and ultimately, rejected the request of the applicant. The applicant has, therefore, preferred the present Original Application with the prayer as noted hereinabove.

6. Learned counsel has prayed for allowing his application relying on the judgment of the Hon'ble

Bombay High Court in the case of **Vinod Dashrath Chavan Vs. State of Maharashtra and others, W.P. No. 10592/2019**. Learned counsel has also relied upon the judgment delivered by this Tribunal in O.A. No. 12/2020 on 26.11.2021 in the matter of Vaibhav Venkat Chandle & Anr. Vs. State of Maharashtra and others. Learned counsel invited my attention to the discussion made by the Hon'ble Division Bench of the Bombay High Court in paragraph Nos. 5 to 8, which read thus,

“5. The respondent No. 4 has also given no objection for entering the name of the present petitioner in the list of the persons to be appointed on compassionate ground. The heirship proceedings have been decided and in the heirship proceeding it has been settled between the parties that the petitioner would claim appointment on compassionate ground and pension would be claimed by the mother of the respondent No. 4.

6. As the name of the respondent No. 4 was only included provisionally and that was subject to decision in the legal heirship proceedings, the legal heirship proceeding culminated in settlement and the petitioner was allowed to claim

appointment on compassionate ground, whereas respondent No.4's mother was allowed pensionary benefits.

7. In view of the above, we set aside the impugned order passed by the Tribunal and order of the respondent authorities holding that the name of the respondent No. 4 is to be included in the seniority list.

8. The respondents shall include the name of the petitioner in the seniority list of the persons to be appointed on compassionate ground and as per his turn shall consider to appoint the petitioner on the post commensurate to his qualification.”

7. Learned Presenting Officer has opposed the application on the ground that in the service record pertaining to the deceased employee the mother of respondent No. 5 was named as nominee and also name of respondent No. 5 was there in the office record as his son and nominee of the deceased employee and in the circumstances name of respondent No. 5 was considered by respondent No. 4 and was accordingly included in the list of eligible candidates for giving compassionate appointment. Learned P.O. further submitted that, as such, no

error can be found in the order so passed by respondent No. 4 and he, therefore, prayed for dismissal of the O.A.

8. I have duly considered the submissions advanced on behalf of the applicant and on behalf of the respondents. I have also perused the documented filed on record.

9. It is not in dispute that in the M.C.A. No. 25/2013 compromise was arrived at and according to said compromise the right of seeking compassionate appointment was given in favour of the present applicant. It is further not in dispute that the present applicant has been duly declared as successor of deceased Ravindra Bangar. In view of the fact that in the present O.A. by filing his written statement, respondent No. 5 has also given no objection for substituting name of the present applicant in the list of eligible candidates for giving compassionate appointment, in fact, there was no hurdle for respondent No. 4 for causing such substitution. This issue has been dealt with by this Tribunal in O.A. No. 12/2020 and relying on the

judgment of the Hon'ble Bombay High Court in W.P. No. 6267/2018 it has been unambiguously held that there is no impediment for substituting the name of the legal heirs if any such contingency arises. **In** the aforesaid Writ Petition the Hon'ble Bombay High Court has declared the clause imposing prohibition for substituting the name of one legal representative by another legal representative to be unjustified and has been directed to be deleted.

10. In view of the facts as aforesaid and more particularly having regard to the decision rendered by the Hon'ble Bombay High Court on 11.3.2020 in W.P. No. 6267/2018 [Dnyaneshwar Ramkishan Musane Vs. the State of Maharashtra and others], as well as, the decision given by the Hon'ble Division Bench of the Bombay High Court in W.P. No. 10592/2019 decided on 29.1.2020 [Vinod Dashrath Chavan Vs. the State of Maharashtra & Others] there remained no doubt that name of one legal heir of the deceased can be substituted by another legal representative if the contingency so arises. In the present matter, respondent No. 5 has given his no

objection for substituting the name of the present applicant for offering him appointment on compassionate ground. In such circumstances, the order passed by respondent No. 4 on 29.8.2015 deserves to be quashed and set aside and it is accordingly set aside. Respondent No. 4 is directed to include the name of the present applicant in place of respondent No. 5 in the list of the candidates eligible to be appointed on compassionate ground and to offer him such appointment as and when his turn comes. It is clarified that the seniority of the applicant in the list of such candidates shall be reckoned from 2.6.2010 on which the application was made seeking appointment on compassionate ground for the present applicant.

11. The present O.A. stands disposed of in above terms however, without any order as to costs.
