4. Thereafter present alleged development has taken place i.e. the applicant has been dismissed from service by order dated 31.03.2022 which was communicated by order dated 01.04.2022. The applicant wants to challenge the said order and communication. This is a subsequent development connected with the controversy raised in the Original Application. In view of the same, in our considered opinion, the proposed amendment is not going to change the nature of original proceeding. In fact the proposed amendment is just and necessary to determine the real question of controversy between the parties. We therefore, proceed to pass the following order:-
