7. On perusal of the record, it appears that the applicant was pursuing the remedy partly and it cannot be said that the applicant deliberately delayed to file the present Original Application. However, some negligence is attributable to the applicant, but the same cannot be said to be gross one.

8. It is a settled principle of law that the expression “sufficient cause” is to be construed liberally. Considering the facts on record, refusing to condone the delay is likely to defeat the cause of justice at the threshold. In view of the same, in my considered opinion, this is a fit case to condone the delay by imposing the moderate costs of Rs. 500/- on the applicant. Hence, I proceed to pass following order :-

Learned counsel appearing for the applicant and the learned Presenting Officer have consented for passing the final order in the present OA, having regard to the nature of dispute raised in the O.A. In view of submissions made I heard the final arguments of learned counsel appearing for the applicant and learned presenting Officer appearing for the respondents.

3. The applicant is serving as Medical Officer and is aspiring for promotion to the post of Civil Surgeon. According to the applicant, he is duly qualified and also possesses the requisite experience for the promotion to the said post. It is the contention of the applicant that in the list of eligible candidates, initially published in January, 2020 his name was appearing at Sr. No. 175. However,

in the final list published on 3.6.2022 the name of the applicant is excluded. According to the applicant, his name has been excluded only for the reason that he has not passed the lower or higher standard examination as provided under Rule 3 of the Maharashtra Government Servants (Other than Judicial Department Servants) Marathi Language Examination Rules, 1987.

4. Learned counsel submitted that after having come to know that his name has not been included in the final list the applicant made representation to the Director of Health Services on 18.5.2022. Learned counsel submitted that till today nothing has been informed to the applicant whether his representation has been accepted or rejected. Learned counsel further submitted that according to the information of the applicant the meeting of Departmental Promotion Committee (DPC) may take place in next month. It is apprehension of the applicant that if his representation is not decided till then he may not be considered for the promotion to the post of Civil Surgeon in the meeting of DPC. The applicant, has therefore, filed the present O.A. with the following prayers:-

“A) This Original Application may kindly be allowed.

B) To hold and declare the applicant is eligible for promotion to the cadre of Civil Surgeon, Class-I,

Group-A, and for that purpose necessary orders may kindly be passed.

C) To direct the respondent authorities to include the name of the applicant in the final list of eligible candidates for promotion to the cadre of Civil Surgeon, Class-I, Group-A and further the Departmental Promotion Committee meeting which is to be schedule in near future may direct to consider the claim of the applicant for promotion and for that purpose necessary orders may kindly be passed.

D) To direct the respondents to grant exemption from passing Marathi Language Examination pursuant to the proposal dated 12.12.2020 and 16.12.2021 sent by the respondent authorities.

E) Any other relief may kindly be granted in favour of the applicant in the interest of justice.”

The applicant has also prayed the following interim relief: -

“a) Pending hearing and final disposal of this Original Application, the respondent No. 1 may be directed to include the name of the applicant in the final list of eligible candidates for the promotion to the cadre of Civil Surgeon, Class-I, Group-A and further to direct the Departmental Promotion Committee Meeting Schedule in near future to consider the claim of the applicant for promotion without inserting the passing of Marathi Language and for that purpose necessary orders may kindly be passed.”

5. Learned counsel invited my attention to the averments in the O.A., wherein the applicant has categorically mentioned that he had taken education in

Marathi medium, his mother-tongue is Marathi and that he can read, right Marathi well, as well as, can make correspondent in Marathi language. Learned counsel also brought to my notice the certificate issued by the Civil Surgeon, Civil Hospital, Ahmednagar dated 25.5.2022. Learned counsel submits that even prior to that in the month of January, 2022 also such certificate was issued in favour of the applicant. In the circumstances, learned counsel has prayed for interim relief.

6. Shri M.P. Gude, learned Presenting Officer submitted that having regard to the dispute raised by the applicant the present O.A. can be disposed of by directing the concerned authorities to decide the representation of the applicant within a time bound period and no further order is required to be passed in the matter.

7. Learned counsel appearing for the applicant has consented for passing such order. The only concern which learned counsel expressed is that in the meanwhile if the meeting of the DPC is held his chance to be considered for the promotion is likely to be lost. Learned counsel submitted that if the apprehension in the mind of taken care, the present O.A. can be disposed of by directing the respondent authorities to consider the representation dated 18.5.2022 at the earliest or before the date of DPC meeting.

8. In view of the submissions so made by both the parties, the present Original Application is disposed of with the following order:-

ORDER

- (i) Respondent No. 1 is directed to decide the representation submitted by the present applicant on 18.5.2022 at the earliest and in any case before the date of the meeting of DPC.
