Thus, we have permitted the applicant to delete other prayer clauses except prayer clause (B-1) and reserved the matter for orders.

3. Learned counsel for the applicant now submitted pursis and requested for taking the matter on board. At his request we have taken the matter on board again.

4. Learned counsel for the applicant submits that on 23.08.2023 the applicant has submitted the exhaustive

representation to respondent No. 1 and purpose of filing the present O.A. will be served, if the directions are given to respondent No. 1 to decide the representation submitted by the applicant on 23.08.2023 in time bound manner.

5. Learned Presenting Officer submits that he has no instructions as to whether such representation has been filed by the applicant before respondent No. 1. Learned P.O. submits that however, in case if such representation has been filed and this Bench decides to issue directions, then respondent No. 1 may be directed to decide the said representation on its own merits.

6. In view of the above submissions and since the learned counsel for the applicant has requested to consider this O.A. only to the extent of giving directions to respondent No. 1 to decide the representation of the applicant dated 23.08.2023 in time bound manner, we have no difficulty to dispose of this O.A. by giving such direction. Hence, the following order: -

**ORDER**

(i) Respondent No. 1 is directed to decide the representation dated 23.08.2023 submitted by the applicant on its own merits as expeditiously as possible

and preferably within a period of 06 weeks from the date of this order.

(ii) Needless to state that the applicant is at liberty to challenge any adverse order passed in connection with his representation dated 23.08.2023.

(iii) Accordingly, the Original Application stands disposed of however, without any order as to costs.
