'Shri Bhagwan Sawant, Deputy Secretary, Revenue and Forest Department' (Forest)' informs upon ascertaining from few other 'Administrative Departments' as to whether they have specifically designated (a) 'Regional Heads of Department' (b) 'Heads of Office' as 'Disciplinary Authority' with reference to provisions of 'Rule 4(1)' read with 'Rule 2(k)' and 'Rule 2(e)' of 'Maharashtra Civil Services (Discipline & Appeal) Rules 1979', affirmatively states that those 'Administrative Departments' have also followed similar modalities like in 'Revenue and Forest Department (Forest) GR dated 01.01.2021' based on 'Delegation of Powers' of 'Bombay Financial Rules 1959' through 'Manual of Financial Power 1978'.</p> <p>3. The issue of competency in law of any 'Disciplinary Authority' to order 'Suspension' under 'Rule 4(1)' of 'Maharashtra Civil Services (Discipline & Appeal) Rules 1979' remains to be examined comprehensively as definition of 'Disciplinary Authority' in 'Rule 4(1)' under 'Maharashtra Civil Services (Discipline & Appeal) Rules 1979' contemplates that</p>

'Disciplinary Authority' can be either at level of (a) 'Heads of Department' or (b) 'Regional Heads of Department' or (c) 'Heads of office'; with the later two to be so designated under 'Bombay Financial Rules 1959'. Even granting that Revenue & Forest Department (Forest) has designated (a) 'Heads of Department' (b) 'Regional Heads of Department' & (c) 'Heads of Offices' as 'Disciplinary Authority' based on 'Delegation of Powers' of 'Bombay Financial Rules 1959' through 'Manual of Financial Powers, 1978' and issued Government Revenue and Forest Department (Forest) GR dated 01.01.2021 and even considering that (i) Order in O.A. No. 179/21 and (ii) Order in O.A.No.237/23 by which exercise of 'Statutory Powers' of 'Suspension' by such 'Disciplinary Authority' under Rule 4(1) have been upheld based on 'Revenue and Forest Department' (Forest) GR dated 01.01.2021; still basic question which remains unanswered is whether the wide ambit of the word 'Disciplinary Authority' used in 'Rule 4(1)' of 'Maharashtra Civil Services (Discipline & Appeal) Rules, 1979' could be understood to mean that 'Statutory Power' of 'Suspension' is amendable to concurrent exercise by more than one 'Disciplinary Authority' serving at different hierarchical levels of any 'Administrative Department'. Specifically; with reference to earlier actions taken by officers of Revenue & Forest Department (Forest) which were upheld by Orders in O.A. No. 179/2021 and O.A. no. 273/2021; there yet is no permissibility for set of multiple 'Disciplinary Authority' ranging from (a) 'Heads of Department' or (b) 'Regional Heads of Department' or (c) 'Heads of offices' to act unilaterally without any pre-defined 'Order of Precedence' based strictly on grades of respective Government Servants. The pick and choose option being exercised presently to pass order of 'Suspension' under 'Rule 4(1)' of 'Maharashtra Civil Services (Discipline & Appeal) Rules, 1979' evidently has not been addressed in O.A. No. 179/2021 and O.A. No. 273/2021 which dealt with orders of 'Suspension' passed by (a) 'Chief Conservator Forest, Thane and (b) Deputy Conservator Forest, Sangli'.

4. The exercise of 'Statutory Powers' of 'Suspension' by 'Disciplinary Authority' at liberty to pick and choose any Government Servant is definitely not contemplated under 'Rule 4(1)' as word used is

'Disciplinary Authority' which is 'Singular' and not 'Plural'. More importantly 'Disciplinary Authority' under 'Rule 2(c)' means the authority competent under 'Maharashtra Civil Services (Discipline & Appeal) Rules, 1979' to impose on Government Servant any of the penalties specified in 'Rule 5' which includes both (i) 'Minor Penalties' (ii) 'Major Penalties'. Thus in context of present O.A. No. 547/2024 further question arises if 'Deputy Conservator of Forest Sawantwadi, Forest Division, District Sindhudurg' is then to be considered 'Disciplinary Authority' who is not only competent under 'Rule 4(1)' to pass order of 'Suspension' but has to be considered as authority competent to even impose 'Major Penalty' such as (a) 'Compulsory Retirement' or (b) 'Removal from Service' or (c) 'Dismissal from Service' upon Applicant who is serving in cadre of 'R.F.O.' If so has authority competent in 'Revenue & Forest Department' (Forest) to impose such 'Major Penalty' even delegated the powers of 'Rule 5' to award 'Major Penalties' in respect of cadre of 'R.F.O.' to 'Deputy Conservator of Forest Sawantwadi, Forest Division, District Sindhudurg'. Thus *prima facie* it appears Orders passed in (i) OA No. 237/23 and (ii) OA No.279/21 do not assist in resolving the larger issues raised in O.A. No. 547/2024 regarding competence in law of 'Disciplinary Authority' under 'Rule 4(1)' of 'Maharashtra Civil Services (Discipline & Appeal) Rules 1979'.

5. The question which has now got framed due to exacting definition in 'Rule 2(c)' read with 'Rule 4(1)' read with 'Rule 5' of 'Maharashtra Civil Services (Discipline & Appeal) Rules 1979'; may find its answer in some 'Judgment' or 'Order' passed in appropriate 'Judicial Proceeding'; which may thus be produced either by 'Revenue & Forest Department' or learned Advocate for Applicant.

2. This M.A.No.110/2024 is moved by Applicant for condonation of delay of 9 months in filing O.A.

3. The learned Counsel for Applicant submits that in this matter, the cause of action aroused on 27.05.2019. The punishment from removal from service was modified to punishment of Rs.5000/- by way of penalty in appeal. Learned Counsel for the Applicant has pointed out that in view of order passed by the Hon'ble Supreme Court in Suo-Motu W.P. No.3/2020 dated 10.01.2022 limitation was extended in Covid period. As per the order of the Hon'ble Supreme Court dated 10.01.2022 in cases where the limitation would have expired during the period between 15.03.2020 till 28.02.2022, notwithstanding the actual balance period of limitation remaining, all persons have a limitation period of 90 days from 01.03.2022. The disease had been continued till 3rd wave of corona when ends on 28.02.2022 therefore as per order of Hon'ble Supreme Court, the period running from 15.03.2020 to 28.02.2022 has been excluded for the purpose of limitation. Therefore, learned Counsel submits that benefit of relaxation given by the Hon'ble Supreme Court on account of Covid-19 pandemic situation is to be given.

4 The learned Counsel submits that O.A. is filed on 15.02.2024. The limitation actually started on 13.04.2023 on account of review application made on 13.10.2022 by the Applicant on account of acquittal in criminal case on 03.10.2022 in criminal case and therefore there is a delay in filing this OA and it was only of 9 months.

We have perused the original O.A. as paragraph 8 is reproduced in the order of this Tribunal dated 25.11.2021 in the said O.A. This affidavit-in-reply dated 13.08.2021 on behalf of Respondent No.1, through Mr. Arvind P. Andhere, Desk Office holding the Additional Charge of the post of Sr. Dy. Assistant to D.I.G. (Estt.) in the office of Director General of Police, M.S. Mumbai. We again reproduce the said paragraph,</p> <p><i>“(viii) Thus, in view of the aforesaid position, had the promotion to the post of Armed P.I. was not given to Shri N.V.Koli from the S.C. category on the D.P.C. held for the year 2004, the next number from the S.C. category on that D.P.C. was of the applicant herein and as stated hereinabove, the seniority of Shri</i></p>

N.V.Koli has been refixed, from the S.B.C. category, and hence, now, it is found necessary to this office to review the decision of grant of deemed date of promotion to the post of Armed P.I. on the basis of the D.P.C. 2004 and then on that basis, a proposal to the State Government for examining his eligibility and fitness for grant of deemed date of promotion to the post of Armed Dy.S.P. will have to be submitted, being a competent authority. Hence, for doing all these exercise this office is seeking suitable time in this matter."

4. The order dated 30.12.2021 does not disclose where paragraph (viii) of the said affidavit was considered by the authority. In view of this we do not accept that it is full and final and correct compliance of the order of the Tribunal.

5. We would like to have affidavit-in-reply of the Contemnors and not any subordinate officers. We direct the D.G. to file affidavit as per the law and explain this situation.
