"With respect to Respondent no. 1, is directed to allow the applicant to participate in the selection process by ignoring the proclamation (copy whereon if at Exhibit-D, page 27 of the Paper Book of O.A) subject to applicant following all other conditions as to eligibility."

Learned P.O points out the short affidavit of Shri Pradeep Kumar for Respondent no. 1 dated 11.2.2020, and submits that O.A 933/2018 was filed initially by Shri Harsha Bhalearo and Shri Lingappa Sargar. Thereafter name of Shri Lingappa Sargar was deleted as per the submissions made by his Counsel, Shri S.\$ Dere. However, Respondent no. 1, erroneously wiothout taking note of the deletion considered that the said order dated 13.2.2019 is also applicable to Respondent no. 5 along with the then applicant Shri
