2. Learned Counsel seeks leave to add Dr. Rekha Gowardhan Gaikwad (Mudkhedkar) as respondent no.4. Leave as prayed for is granted. Necessary amendment be carried out forthwith.

3. It is the grievance of the applicant that though the category of SC (Female) she is more in meritorious than respondent no.4, she has not been selected and included in the list of recommended candidates and respondent no.4 has been recommended by the Maharashtra Public Service Commission (MPSC). Learned Counsel submits that the applicant has not been selected on the ground that she did not earn the required marks in the interview i.e. 41% marks.

4. Learned Counsel submits that since the present is not the direct recruitment, criteria of 41% minimum marks in the interview could not have been applied by the respondents. It is further contention of the learned Counsel that respondent no.5, who has been recommended by MPSC, does not possess the requisite experience as prescribed in the advertisement. In the circumstances, learned Counsel has prayed for interim relief to restrain the respondents from making appointment of respondent no.5 from the category of SC (Female) on the advertised post.

5. The contentions raised by the applicant are opposed by the learned CPO. Learned CPO has sought time for taking instructions in the matter. Learned CPO has contended that having regard to the objections raised, unless the entire information as well as relevant rules are on record, it may not be possible to reach to any *prima facie* conclusion. Learned CPO in the circumstances has opposed for granting any interim relief in the matter.

6. I have duly considered the submissions made on behalf of the learned Counsel appearing for the

applicant. Prima facie, I am not convinced with the arguments made by the learned Counsel that criteria of 41% marks in the interview is only applicable for the direct recruitment. Learned Counsel is supposed to *prima facie* satisfy that the present applicant was in all respects eligible to be appointed and her opportunity of being appointed is taken away because of some wrong information given by respondent no.5.

7. I am not convinced with the arguments made by the learned Counsel for the applicant in this regard. In the circumstances, I am not inclined to grant any interim relief at this stage. Hence, I deem it appropriate to issue notices to the respondents. Hence, the following order:

[ii] Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

Accordingly, the proposal for correction in date of birth of applicant is under consideration of Government and presently submitted to General Administration Department for their remark on 31.07.2023."

7. In view of the averments taken as above by the respondent Nos. 1 and 2 in their affidavit in reply, the present Original Application can be disposed of as has been prayed for by the learned counsel for the applicant. Hence, the following order :-

ORIGINAL APPLICATION NO. 532 OF 2023 (Prashant Chokhaji Nikalje Vs. State of Maharashtra & Ors.)

Heard Ms. Preeti Wankhade, learned counsel for the applicant and Smt. Sanjivani K. Deshmukh-Ghate, learned Presenting Officer for the respondent authorities.

2. The grievance of the applicant is that without considering the choices / preferences recorded by him and instated of giving him posting at any one of the said 10 places, the respondents have transferred him at some other place, which is inconvenient for him.

3. Learned counsel appearing for the applicant submitted that in fact the applicant was not due for transfer. He has completed only 4 years of his tenure at the existing place and as such also he was having every right to be on the existing post for next 2 years. Learned counsel further submitted that when the applicant has recorded 10 options and all these posts were lying vacant, the respondents have not explained as to why instead of transferring the

applicant in any one of the said place, he has been transferred at the other place. Learned counsel submitted that the place to which the applicant has been transferred is 100 kms. away from Khultabad. Learned counsel submitted that daughter of the applicant is suffering from physical impairment and she requires regular treatment. For the said purpose the applicant needs to frequently take her at Aurangabad. Learned counsel submitted that in such circumstances, the representation submitted by the applicant later on bringing out to the notice of the respondents the difficulties faced by the applicant, must have been considered by the respondents. Learned counsel in the circumstances, prayed for setting aside the impugned order and sought direction against the respondents to give posting to the applicant at any one of the place of his choice as recorded by him at the time of Annual General Transfers.

4. The contentions raised and prayers made in the O.A. are resisted by respondent Nos. 1 to 3 by filing their affidavit in reply. The respondent Nos. 1 to 3 in their joint affidavit in reply have denied the

allegations made by the applicant. The respondents have contended that considering the administrative need and the recommendations of Civil Services Board, the impugned order of transfer has been issued against the applicant.

5. Learned P.O. reiterated the contentions raised in the affidavit in reply. He submitted that no case is made out by the applicant so as to cause interference in the impugned order. Learned P.O. submitted that the Government employee cannot insist for his transfer at a particular place when his services are transferable. Learned P.O. further submitted that it is not the case even of the applicant, that there was any mala-fide intention in not considering the request of the applicant. The respondents in the circumstances have prayed for rejection of the application.

6. I have duly considered the submissions made on behalf of the applicant and respondents. At the outset it has to be stated that the Government employee cannot insist for his transfer or posting at a particular post or at a particular place. The options are invited for convenience of both the

applicant, as well as, the administration. However, it doesn't mean that the Government employee cannot be transferred at place other than the places for which the Government employee has recorded his options / preferences. Flexibility has to be left to the administrative authorities to take a decision in the matter of transfer. It is well settled that unless there is any violation of transfer guidelines or a case is made out for attributing mala-fides to such transfer, the Courts or Tribunals shall not interfere in the orders of transfer. In the instant matter, the applicant has failed to make out any such ground for grant of any interim relief as prayed by him. The Civil Services Board, which is the competent body constituted for the purpose of recommending the transfers and postings of the Government servants has recommended the transfer of the present accordingly, applicant and at said place the applicant has been transferred. In the circumstances, I see no reason to cause any interference in the impugned order.

7. At this juncture, it is submitted by learned counsel for the applicant that during pendency of

the present Original Application, the applicant has made a representation bringing to the notice of the authorities that some posts are yet vacant for which the applicant had given option and has prayed for modifying his transfer order to that extent. If this be so, the respondents are not precluded from considering the request of the applicant on its own merit.

8. With the observations as above, the Original Application stands disposed of without any order as to costs.
