Heard Smt. A.N. Ansari, learned Advocate for the applicant and Shri S.K. Shirse, learned Presenting Officer for the respondents.

2. It has been brought to the notice of the Tribunal by the learned Advocate for the applicant that the son of the applicant has not appeared in the examination in question, rather the name of father of the candidate, who appeared in the said examination, matches with the name of the applicant, and therefore, charges against him got framed in the joint departmental enquiry. After ascertaining facts from the ration card and the service record of the applicant, the respondent no. 2, the District Collector, Nanded, has been satisfied that the applicant Shri Yousufuddin Qamruddin, Peon, Collectorate, Nanded was implicated in the joint enquiry out of misgiving. Therefore, the respondent no. 2, the District Collector, Nanded had reported the matter to the State Government addressing a letter bearing No. २०१६/मशाका-१/आस्था-३/प्र.क., 9.9.2016 and recommended that case of the said Peon Shri Yousufuddin Qamruddin may be considered with sympathy and accordingly final decision in the matter of penalty be taken. However, while passing the order dated 17.12.2016

a penalty has been imposed on the original applicant Shri Yousufuddin Qamruddin also.

- 3. Affidavit in reply has been filed by one Shri Prasad s/o Prabhakarrao Kulkarni, Tahsildar (General), Collector, Office, Nanded. Therefore, affidavit in reply of respondent no. 1 has become necessary for deciding the present matter on merit.
- 4. Accordingly, the learned Presenting Officer is directed to get the affidavit in reply of respondent no. 1 for which he seeks time. Three weeks time is granted to the learned Presenting Officer for filing affidavit in reply of respondent no. 1.

- 2. The present matter has been admitted on 28.7.2021 and was fixed on 20.8.2021 for final hearing. On 20.8.2021 at the request of parties, the case was adjourned to 3.9.2021. On 3.9.2021 this Tribunal observed that the affidavit in reply of respondent nos. 1, 2, 4 & 5 has already been filed. Learned P.O. stated that the respondent no. 3 adopts affidavit in reply of other respondents. Therefore matter was adjourned to today i.e. on 11.10.2021 to file rejoinder, if any, by the applicant.
- 3. Learned Advocate for the applicant has clarified that the applicant does not have objection about revised pay fixation, however, recovery of excess amount already paid to him is his main cause of action.

4. Affidavit in reply filed by the respondents is basically on the line that recovery of excess payment made to employee in service can be made in installments, especially when the recovery is with respect to pay fixation under time bound promotion scheme / assured career progression scheme. In such cases undertaking is given by the employee for returning excess amount paid to him due to wrong pay fixation.

- 5. However, learned Advocate for the applicant wishes to cite case laws that in case of Class-IV employee, who has not carried out his pay fixation, should not suffer for recovery of excess amount paid to him. Revised pay fixation should be applied from prospective date.
- 6. However, the learned P.O. has put counter arguments. He submits that the pay fixation without verification by the Pay Verification Unit is done in the interest of employees so that they get the revised pay earlier, subject to verification from the Pay Verification Unit. However, it is in the public interest and according to public policy that nobody should get

benefit of wrong calculation of pay fixation. Therefore, undertaking is taken from the employees for refund of excess amount and accordingly amount of recovery is determined and has been initiated against the applicant as per the rules and guidelines in force.

- 7. Learned Advocate for the applicant has agreed to share the relevant case laws on which she is going to make out the case of the applicant with the learned P.O. for the respondents in advance before the next date of hearing. Learned P.O. for the respondents shall accordingly go through the said case laws, which would be supplied by the learned Advocate for the applicant, and incorporate his response to the same in addition to arguments made by the learned Advocate for the applicant today and restructure his arguments accordingly.
