The Applicant has challenged the order dated 15.12.2018 issued by the Respondent No.2 attaching him to Motor Transport Section, Beed till the conclusion of preliminary enquiry against him by filing the present Original Application.

2. The Applicant was initially appointed as a driver Police Constable in the year 1986 by order dated 01.03.1986. Thereafter, he has been posted at various police stations in Beed district. He was promoted as Police Head Constable in the year 2014. In the month of June 2015, he

was posted at police station Yusuf Wadgaon in the general transfer of the year 2015 and since then, he was working there. On 14.10.2018, Shri Zote, Assistant Police Inspector and incharge of the police station Yusuf Wadgaon orally ordered the Applicant to attend the training course at Police Head Quarter, Beed. Accordingly, he left police station on 15.10.2018 and joined the training course. When he was undergoing the training course at Beed, the incharge of the police station Yusuf Wadgaon submitted default report against him to the Superintendent of Police Beed alleging that the Applicant used to discharge the duties under drunken condition. On the basis of said default report, the S.P., Beed issued the impugned order and attached him to Motor Transport Department, Beed till conclusion of the preliminary enquiry.

3. It is contention of the Applicant that the impugned order is based on false report submitted by the incharge of the police station Yusuf Wadgaon. He has submitted explanation regarding the allegations made against him on 14.01.2019 stating that there is no any record about his drunkenness and he never underwent any medical test for alcohol consumption. It is his contention that the impugned order is illegal and therefore, he prayed to quash and set aside the impugned order by allowing the Original Application.

4. The Respondent No.2 has filed affidavit-in-reply and resisted the contentions of the Applicant. He has not disputed the fact that the Applicant was posted at Yusuf Wadgaon and he has been sent for training programme. It is his contention that the training programme is part and parcel of the police department and the Applicant was sent to training course as part of service. It is his contention that on the basis of report submitted by the incharge of the police station Yusuf Wadgaon, a preliminary enquiry has been initiated against the

Applicant and in order to conduct the enquiry in fair manner, it was necessary to attach the Applicant temporarily to Motor Transport Section, Police Head Quarter and accordingly impugned order has been issued. It is his contention that after preliminary enquiry regarding negligence, indiscipline and irresponsible conduct of the Applicant, a show cause notice has been issued to the Applicant by the Respondent No.2 calling upon him to show cause as to why his increment for three year should not be stopped. The Applicant was heard on 14.06.2019 and after considering his written and oral submission, the punishment of stoppage of increment for one year has been passed. It is his contention that after passing the order and on considering the report in the enquiry, the Police Establishment Board of Beed District decided to transfer the Applicant on administrative ground from Yusuf Wadgaon to Motor Transport Section, Police Head Quarter Beed in the interest of public at large and accordingly transferred him by order dated 27.5.2019. The Applicant joined the Motor Transport Section, Beed. In view of this, the present application is infructuous and therefore, the Respondents prayed to reject the Original Application.

5. I have heard Shri O.D. Mane, learned Advocate for the Applicant and Shri V.R. Bhumkar, learned Presenting Officer for the Respondents. I have perused the documents on record produced by both the parties.

6. Admittedly, the Applicant was initially appointed as Driver Police Constable in the year 1986 and thereafter, he was posted at various police stations in Beed district. In the year 2014, he was promoted as Police Head Constable. He has been posted at Police Station Yusuf Wadgaon in the month of June, 2005 and since then, he was working there. Admittedly, one Shri Zote, Assistant Police Inspector and incharge of the police station Yusuf Wadgaon submitted default report against the Applicant to the Respondent No.2 i.e. Superintendent of

Police, Beed on 31.10.2018 and 15.12.2018 which are at page nos.27 to 30 regarding indiscipline behaviour, misbehaviour and misconduct on the part of the Applicant while discharging the duties. Admittedly, the Superintendent of Police, Beed initiated preliminary enquiry in the default report submitted by the incharge officer of the police station Yusuf Wadgaon and during pendency of enquiry, he passed the impugned order and attached the Applicant to Motor Transport Section at Police Head Quarter, Beed.

7. Learned Advocate for the Applicant has argued that the Applicant never attended the police station under influence of liquor and he never misbehaved and misconducted with the senior officer and colleagues. He has submitted that the allegations made in the default report regarding drunkenness of the Applicant are false. He never punished for it. He has submitted that the Applicant was promoted during the pendency of the Original Application and these facts falsities the allegations made in the default report of Shri Zote, incharge of the police station Yusuf Wadgaon and therefore, he has prayed to quash and set aside the impugned order.

8. Learned P.O. for the Respondents has submitted that on the basis of default report submitted by Shri Zote, API and incharge of the police station Yusuf Wadgaon, a preliminary enquiry has been initiated against the Applicant and it has been found during enquiry that the Applicant had misbehaved while on duty and therefore, the Respondent No.2 issued show cause notice calling upon the Applicant to show cause as to why his increment for three years should not be stopped. The Applicant had given reply to the show cause notice. Personal hearing was given to the Applicant and after considering his written and oral submission, punishment of stoppage of increment for one year imposed on 15.06.2019. He has submitted that in order to conduct

the fair enquiry, the impugned order has been issued and the Applicant has been temporarily attached to Motor Transport Section, Beed in the interest of justice. Therefore, there is no illegality in the impugned order. He has further submitted that after imposition of punishment on the Applicant, the Police Establishment Board at Beed decided to transfer the Applicant from police station Yusuf Wadgaon to Motor Transport Section, Beed and accordingly transfer order has been issued on 31.5.2019. Accordingly, the Applicant has been relieved from Yusuf Wadgaon and he joined Motor Transport Section on 1.6.2019. He has submitted that in view of the transfer of the Applicant, the present Original Application become infructuous and therefore, he prayed to reject the Original Application.

9. On perusal of documents produced at page nos.27 to 30 it reveals that Shri Zote, API and incharge of the police station Yusuf Wadgaon, Dist. Beed submitted default report dated 31.10.2018 and 15.12.2018 to the Respondent No.2 alleging that the Applicant used to misbehave with him, his colleagues in drunken condition and he misbehaved at various occasion. On the basis of report submitted by incharge of the police station, Yusuf Wadgaon, the Respondent No.2. i.e. S.P., Beed initiated preliminary enquiry and in order to conduct enquiry in fair manner, he passed the impugned order attaching the Applicant to Motor Transport Section. The allegations made against the Applicant were of serious nature. In the enquiry, the statement of the colleagues of the Applicant will have to be recorded and therefore, the Respondent No.2 thought fit to attach the service of the Applicant to Motor Transport Section till conclusion of the enquiry in order to conduct the enquiry in fair manner. In my opinion, there is no illegality in the impugned order. The impugned order has been issued to conduct the enquiry in free and fair manner and therefore, I find no illegality in the

impugned order. Not only this, but during the pendency of the Original Application, enquiry has been concluded and the Applicant was punished. Not only this, but during the pendency of the O.A., in the general transfer the Applicant has been transferred by Police Establishment Board and posted at Motor Transport Department, Beed and accordingly the said order has been implemented. Therefore, the present Original Application has become infructuous.

10. In these circumstances, in my opinion, there is no illegality in the impugned order. Therefore, no interference is called for in it. There is no merit in the Original Application. Consequently, the same deserves to be dismissed.

11. In view of the discussion in the foregoing paragraph, the Original Application stands dismissed. No order as to costs.
