2. The applicant has approached this Tribunal claiming the following relief: -

“B] By passing appropriate order or direction the respondents may kindly be directed to sanction and pay to the Applicant an amount of Rs. 35,00,000/- (Rupees Thirty Five Lakh Only) towards damages for causing loss of job opportunity and loss of valuable time and energy spent by the applicant in preparation for the examination to the post of ‘Craft Instructor’ which got quashed due to erroneous advertisement framed by the respondents.”

3. Learned Advocate for the applicant has submitted that the applicant is claiming damages on the ground of cancellation of recruitment process for the post of Craft Instructor. He has further submitted that this Tribunal has quashed and set aside the advertisement issued by the respondents for filling 153

posts of Craft Instructor in the State in regular pay scale and 194 posts on consolidated monthly pay, by an order dated 6th May, 2016 in O.A. No. 566/2014, Annexure 'A-5', page-40, as the said advertisement was erroneous. The applicant had applied for the post of Craft Instructor in pursuance of the said advertisement. Because of the cancellation of the recruitment process the applicant lost his energy and time and also lost job opportunity and, therefore, the applicant is entitled to get relief as claimed in this Original Application. He has submitted that the claim of the applicant is based on the basis of the recruitment process and, therefore, it comes within definition of service matter as defined in Section 3 (q) clause (v) read with Section 15 & 28 of the Administrative Tribunals Act, 1985 and, therefore, he prayed to admit the Original Application.

4. Learned Presenting Officer has submitted that this Tribunal has no jurisdiction to entertain the present Original Application, as the applicant is claiming damages for which civil remedy is available before the appropriate forum. Therefore, he prayed to reject the Original Application.

5. On perusal of the relief sought by the applicant in the present O.A. it reveals that the applicant is claiming damages on account of loss of job opportunity and loss of valuable time and energy spent by him for preparation of the examination of the 'Craft Instructor'

by filing the present Original Application.

6. The provision of Section 3 (q) defines “Service Matters”, as under: -

3. Definitions.—In this Act, unless the context otherwise requires,—

(q) “service matters”, in relation to a person, means all matters relating to the conditions of his service in connection with the affairs of the Union or of any State or of any local or other authority within the territory of India or under the control of the Government of India, or, as the case may be, of any corporation [or society] owned or controlled by the Government, as respects—

(i) remuneration (including allowances), pension and other retirement benefits;

(ii) tenure including confirmation, seniority, promotion, reversion, premature retirement and superannuation;

(iii) leave of any kind;

(iv) disciplinary matters; or

(v) any other matter whatsoever;

7. On going through the aforesaid rule, it is crystal clear that the claim of the applicant is not coming

under the purview of the said definition of 'service matters'. The said provision provides the service matters means in relation to the person who is under the employment of the State or any authority mentioned therein and matters relating to the conditions of his service. Therefore, in my view the present matter does not come within the meaning of "service matters" as defined under Section 3 (q) (v) of the Act.

8. Not only this, but the present matter is not in relation to the concerned recruitment and, therefore, this Tribunal has no jurisdiction to entertain the present O.A. in view of the provision of Section 15 of the Administrative Tribunal Act, 1985.

9. Since the subject matter does not come within the jurisdiction of this Tribunal, the present O.A. cannot be entertained by this Tribunal. Therefore, same deserves to be rejected. Hence, the present Original Application stands rejected with no order as to costs.
