2. The Applicant has filed this Contempt Petition on the ground that the Respondents had not followed the direction given by this Tribunal in O.A.No.494 of 2016 which reads as follows:-

“(ii) The respondents are directed to consider the case of the applicant for grant of benefits of time bound promotional scale in view of relevant G.Rs. and in view of the decision of the Tribunal dated 27.1.2017 in O.A.no.838/2015, within a period of 3 months from the date of this order and to communicate the said decision to the applicant in writing accordingly.”

3. Learned Advocate for the Applicant has submitted that the Respondents had not complied with the order and therefore, notices have been issued by the Applicant before filing the Contempt Petition.

4. Learned C.P.O. for the Respondents has submitted that the Respondents had taken decision in the case of the Applicant on 21.2.2018 as per the direction given by this Tribunal in O.A.No.494/2016 on 22.11.2017 considering the different G.Rs. and complied with the order. Therefore no question of contempt of order of this Tribunal arises.

5. On perusal of record it reveals that this Tribunal passed the order in O.A.No.494 of 2016 on 22.11.2017 and directed the Respondents to consider the case of the Applicant for grant of benefits of time bound promotional scale in view of the decision of this Tribunal in O.A.No.838 of 2015 dated 27.1.2017. There is no dispute about the facts that the Government has rejected the claim of the Applicant in O.A.No.838 of 2015 i.e. in case of Shri R.T. Patil as per the direction given by this Tribunal in that O.A.

6. The Respondents have taken decision regarding time bound promotional scale to be granted to the Applicant in view of the direction given by this Tribunal and accordingly, held that the Applicant is entitled to get time bound promotional scale w.e.f. 6.12.2001 by relying on different G.Rs. issued by the Government.

7. These facts show that that Respondent had followed the directions given by this Tribunal and therefore no question of committing contempt of order of this Tribunal arises. Therefore no action regarding Contempt of order of this Tribunal can be taken against the Respondents.

8. In view of discussion in aforesaid paragraph, the contempt Petition stands rejected. No order as to costs.


admitted in view of Section 19 of the Administrative Tribunals Act, 1985.
