He, thus, received total 139 marks out of 150. In the merit list published, name of the applicant figured at Sr.No.3. In the list of recommended candidates, however, name of the present applicant was not included and consequently he has not been recommended for his appointment to the advertised post. As contended by the applicant, the

respondents have not recommended his name in the selected candidates on the ground that contrary to the conditions mentioned in the advertisement, the applicant has applied for one and the same post from 3 Districts; one from Amravati, another from Jalna and the present one from Aurangabad.

3. Learned Counsel for the applicant has invited my attention to the clauses in the advertisement, and more particularly, clause 11. Learned Counsel further submitted that since the applicant appeared only for one examination and secured a meritorious position, should not have been held ineligible for appointment on the ground on which the respondents have not included his name in the selected candidates. Learned Counsel in the circumstances while praying for issuing notice against the respondents has also insisted for grant of interim relief thereby seeking directions against the respondents restraining them from giving effect to the list of selected candidates published on 26-01-2022.

4. Learned P.O. has opposed for grant of any interim relief and has sought time for filing affidavit in reply by the respondents to the O.A. Learned P.O. has referred to clause 11.10 wherein making applications for one post from different districts is expressly barred. Learned P.O. submitted that in such circumstances no *prima facie* case is made out for grant of interim relief in favour of the applicant.

5. I have considered the submissions advanced by the learned Counsel appearing for the applicant and the learned P.O. representing the respondent authorities. I have also carefully gone through the conditions incorporated in the advertisement which was published on 30-11-2019. *Prima facie*, it appears that contradictory provisions are existing in the advertisement. Though in clause 11 of the said advertisement, filing of 2 applications for one post from different districts is expressly barred, and it is matter of record that the applicant submitted more than 1 applications for the same post from 2 districts,

the fact remains that he was issued with hall ticket only for one examination and he has secured a meritorious position in the said examination. In the circumstances, *prima facie* case is certainly made out by the applicant for protecting his interest till the affidavit in reply is filed by the respondents. I am, however, not inclined to stay the entire process, if direction is given to keep one post vacant, the purpose of the applicant will be served. Hence, following order:

ORDER

(i) Issue notice to the respondents returnable on 21-03-2022. In the meanwhile, if the process for appointment is commenced by the respondents, they shall keep one post vacant, till filing of their affidavit in reply.

(ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

(iii) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book

of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
