While he was working on the said post, he was allegedly trapped by the Anti-corruption Bureau on 27.6.2013. The criminal case was registered in that regard bearing Special Case No. 01/2014 before the Additional Sessions Judge at Amalner. On the basis of the criminal case filed against the applicant, the services of the applicant were terminated by the respondents vide order passed on 15.7.2012. The applicant, therefore, approached this Tribunal for quashment of the said order. In the meanwhile the criminal case against the applicant came to be decided by the learned Additional Sessions Judge, Amalner on 10.12.2019. The Criminal Court has acquitted applicant of the offences for which the applicant was prosecuted. After his acquittal the applicant preferred the representation dated 9.1.2020 praying for his

reinstatement and further consequential relief. Learned counsel submitted that the said representation has not yet been decided. In the affidavit in reply also said fact has been admitted by the respondents. In the circumstances, without going into the merits of the matter we deem it appropriate to dispose of the present O.A. with the following directions. Hence, the order: -

**ORDER**

The respondents are directed to decide the representation dated 9.1.2020 made by the applicant on its own merits within 8 weeks from the date of this order.

(ii) It is clarified that we have not entered into the merit of the matter and all issues are kept open.

(iii) The Original Application stands disposed of in above terms however, without any order as to costs.
