2. Learned counsel for the applicant in O.A. No. 1241/2024 submits that inadvertently wrong OA memo was filed and that has to be replaced. Learned counsel also seeks leave to correct prayer clause (B) by substituting Exhibit 'C' and 'D' as mentioned in the said clause as annexure-3 & annexure-5 in O.A. No. 1241/2024. Leave granted as prayed for. The necessary amendment be carried out forthwith.

### ::-2-:: **O.A. NOS. 1241 & 1248/ 2024**

- 3. Since in both these OAs the grievance raised by the applicants is same and the relief sought is also identical, we have heard both these matters together and deem it appropriate to pass this common order.
- 4. Learned counsel for the applicants in both these matters submitted that gross violations had occurred in the selection process which is disputed in the present matter and as such the interim relief has been pressed by the applicants.
- 5. Applicants had applied for the post of Medical Officers, Group–A in pursuance of the advertisement No. 01/2024 issued on 31.01.2024. Vide the said advertisement total 1729 posts were advertised, out of which 1446 posts were for the candidates holding qualification of MBBS and 283 posts were for the candidates holding the qualification of BAMS. The applicants in both these matters had applied for the said 283 posts to be filled in by the candidates holding the minimum qualification as BAMS. In the advertisement, which was issued on 31.01.2024, in clause no. 08 thereof the educational qualification is prescribed and in clause no. 09 thereof the entire selection process has been elaborated.

- 6. It is pointed out that in the criteria as provided in the said clauses 5% marks were provided for the experience possessed by the candidate. As is revealing from the said clauses 95% marks were towards the average of the marks secured by the candidate concerned in every year of Graduation.
- 7. It is contended that on 21.06.2024 the Commissioner of Health Services, Mumbai issued notification for the candidates holding the qualification as BAMS. It was notified that in view of large number of applications i.e. 20981 received for the said post, the Government has decided to fill in said posts by conducting the examination. Nature of the examination and syllabus was also notified along with the said notification.
- 8. It is the further case of the applicants that accordingly on 05.09.2024 the examination was conducted in 02 sessions. The examination was for 200 marks containing 03 subjects therein i.e.

- 9. All these applicants appeared for the said examination. Grievance of the applicants is that the respondents straightway declared the result of the examination on 05.10.2024. It is the contention of the applicants that before declaration of the result the model answer keys were not published and opportunity was not given to the candidates to raise objections, if any, to the said answer key. It is the further contention of the applicants that when the examination was conducted in 02 sessions, the respondents were under an obligation to adopt the procedure of normalization of the marks, but the same also has not been applied.
- 10. It is pointed that apparently there are mistakes in the questions containing in the examination papers. Some such mistakes were pointed out by some of the applicants by forwarding whatsapp messages and also by written complaints. Some of the questions were out of syllabus, whereas some of the options were such that no single option could have been selected since out of 04, 02 options may be the correct answer to the said question.

- 11. It is the grievance of the applicants that the complaints so made were not attended to by the respondents and straightway the result came to be declared. Learned counsel has further pointed out that when the result was declared on 05.10.2024, immediately on the same day the list of selected candidates was published.
- 12. Learned counsel submitted that the discrepancies pointed out by the applicants are fatal and unless these issues are addressed, there cannot be fair selection of the candidates. Learned counsel pointed out from the result that there is a tough competition and gaining 01 mark or losing 01 mark may affect the entire merit list. Learned counsel submitted that in the circumstances the intervention of this Tribunal is must or else the candidates, who really deserve to be selected will be losing the said opportunity in spite of holding merits. counsel in the circumstances prayed for staying the further process of selection till decision of the present applications.
- 13. Learned Presenting Officer appearing for the State authorities at the outset sought time to file

affidavit in reply stating that no instructions are received from the respondents and unless authentic information is received, it would not be possible for him to make his submissions or to dispute the submissions as are made by the learned counsel for the applicants. Learned P.O. submitted that ordinarily the recruitment process is never arrested by the Tribunals and in the present matters when it has attained the finality, according to him, it would unjust to restrain the respondents from proceeding further with the said process. He therefore prayed for rejecting the request for interim relief.

14. We have considered the submissions made on behalf of the learned counsel appearing for the applicants and the learned P.O. for the State authorities. From the submissions which we have recorded elaborately hereinabove insofar as the interim relief is concerned apparently the case seems to have been made out by the applicants. It is not in dispute that the written examination was held in 02 sessions on 05.09.2024. It is further not in dispute that the result of the examination came to be declared on 05.10.2024. The applicants have stated

on oath that in the period between 05.09.2024 to 05.10.2024 model answer key was not published and it is never published by the respondents. further averred on oath that the applicants did never get an opportunity to raise their disputes as about the discrepancies in the questions asked in the written examination and the options recorded for the said questions. It has been pointed out that some of the questions were out of syllabus and for some of the questions 02 options are the correct answers, whereas the candidates were called upon to select 01 option. Whether or not there is substance in the objections raised by the applicants cannot be decided by the Tribunal. It is however a matter of common knowledge that in such examinations ordinarily the procedure which is followed is of declaring the model answer key and inviting objections in that regard by the candidates, who appeared for the said examination. It is not uncommon that certain questions are required to be deleted from the question paper for the reason that the answers given are either not correct or more than one option can be the correct answers and in such process there is every likely-hood of gaining and

losing marks by the candidates. It has been pointed out and it appears true from the result sheet that several candidates have secured similar marks and marks of one question, if are added or reduced may make a vital difference.

- 15. According to us, these are serious lacunas, which would have impact on the selection of the candidates. Moreover, as has been mentioned in the advertisement, in pursuance of which the selection process has been further carried out, the experience clause therein has been ignored. As stated in the advertisement 5% marks are dedicated for The candidates, who have appeared experience. having such experience, are, thus put to disadvantageous position. In the circumstances, we find that the applicants have certainly made out a prima-facie case.
- 16. Learned P.O. however submitted that most probably almost all orders are issued in favour of all the candidates, the list of which has been declared on 05.10.2024. As against it, it is the information as is submitted by the learned counsel for the applicants, almost all the orders are not yet issued

and the selection process is at the stage of document verification.

17. The applicant in O.A. No. 1241/2024 has placed on record communication dated 07.10.2024 under the signature of the Joint Director (Finance & Administration), Commissionerate of Health Services, Mumbai to the Deputy Directors of Health Services all the Regions. As is revealing from the contents of the said communication the document verification of the candidates, who have been selected, was to be carried out on 09.10.2024 and 10.10.2024. There is therefore reason to believe that till today the selection process has reached to the level of document verification of the candidates concerned. In the circumstances, we deem it appropriate to pass the following order:-

- (i) Issue notice to respondents, returnable on 16.10.2024.
- (ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

Learned counsel for the applicant submits that the applicant while working as Additional Collector, by order dated 28.02.2024 came to be deputed as Registrar, Mahatma Phule Krushi Vidyapeeth, Rahuri, Dist. Ahmednagar for the period of three years with certain terms and conditions as per the Government Order dated 13.03.2024 (Annexure A-3). Learned counsel submits that the applicant's parent department is Revenue Department and he came to be deputed to Agriculture Department as Registrar of

an Agriculture University. Learned counsel submits that as per Annexure A-4 dated 14.03.2024 the applicant has joined the place of deputation and the said order was implemented w.e.f. 13.03.2024 afternoon.

- 4. Learned counsel for the applicant submits that by impugned order dated 08.10.2024 the Dy. Secretary, Government of Maharashtra, Agriculture, Animal Husbandry, Dairy Development and Fisheries Department has cancelled the said deputation and directed therein that the applicant should report and join his parent department.
- 5. Learned counsel for the applicant submits that in terms of Rule 40 of the Maharashtra Civil Services (Joining Time, Foreign Service and Payments During Suspension, Dismissal and Removal) Rules, 1981 (hereinafter referred as the Rules of 1981) particularly sub-rule 4, transfer of a Government servant to foreign service should be made on the standard terms and conditions as in Appendix II. No departure from the prescribed terms and conditions shall be permissible and thus guidelines for both the competent authorities and the foreign employers are given in Appendix III. Learned counsel has referred

Appendix II of Rule 40 of the Rules of 1981 particularly clause 1(ii) if his services are not required by the foreign employer, it shall be open to the foreign employer to revert him to the parent department, provided 3 months' notice is given to Government / competent authority by the foreign employer before effecting such reversion. Learned counsel has pointed out that in the instant case no such 3 months' notice has been given and all of sudden impugned order came to be passed.

- 6. After going through Rule 14, sub-rule (4), Appendix II clause 1(ii) of the Rules of 1981 and terms and conditions mentioned in the Government Order dated 13.03.2024 (Annexure A-3) clause 2(क), I find much substance in the submissions made on behalf of the applicant by learned counsel. Even in the Government Order dated 13.03.2024 (Annexure A-3) in clause 2(क), 3 months' notice prior to reversion is necessary. However, it seems that the same has not been followed in this matter.
- 7. In view of the same, the parties are directed to maintain status quo as on today till the next date of hearing.

- 8. Learned Presenting Officer is directed to call record about cancellation of deputation and pertaining to transfer of the applicant in connection thereto.
- 9. Issue notices to the respondents, returnable on 25.10.2024.
