- 2. In the present matter compassionate appointment is refused to the applicant on the ground that his deceased father was a Government servant working on the post of Co-operative Officer Grade-I, and it falls in the cadre of Group-B Officers. According to the respondents, the legal heirs of the Government employees falling in the cadre of Group 'C' and 'D' only can seek the appointment on compassionate ground. It is not in dispute that the deceased Government servant was drawing salary in the pay scale of Rs. 5500-9000 at the time of his death.
- 3. Whether the officer drawing wages in the aforesaid pay scale of Rs. 5500-9000 would fall in the cadre of Group-B officers was the issue for determination before the Hon'ble Division Bench of the Bombay High Court in W.P. No. 5440/2009 (Dinesh Shamrao Sonawane Vs. State of Maharashtra) decided on 05.02.2010. In the said matter also the compassionate appointment was refused to the

applicant/petitioner therein on the ground that the deceased Government servant in whose place the compassionate appointment was sought was drawing the salary in the pay scale of Rs. 5500-9000. The Hon'ble Bombay High Court has rejected the said contention while delivering the judgment in the aforesaid W.P. The discussion made and findings recorded by the Hon'ble Bombay High Court in paragraph Nos. 4 & 5 of the said judgment are relevant to be reproduced in the present matter, which read thus: -

- "4. In this Writ Petition, the stand taken on behalf of the respondents in that since late Smt. T.D. Sonawane was working as Craft Instructor in the Pay Scale of Rs.5500- 9000, she would be covered in Croup –B category specified in Government Resolution dated 02.07.2002. In that view of the matter, the petitioner was not eligible to get appointment on compassionate ground in terms of Government Resolution dated 28-03-2001 as that facility is extended only to heirs and legal representatives of the persons who were employed in Group –C or Group –D category. This is the only objection taken in the reply affidavit.
- 5. To examine the correctness of this submission, we would straightway refer to Government Resolution dated 02- 07-2002. Clause -1 of the said Government Resolution defines the Group -A category. We are not concerned with the said definition. According to the petitioner, the petitioner would be covered by Group -C category, whereas according to the respondents, the petitioner would be covered by Group -B category. Insofar as Group-B category is concerned, it stipulates that in cases where the pay scale is not less than Rs.9000/- and not more than Rs.11500/-, the same will be covered by Group -B category. Insofar as that in cases where the pay scale is

not less than Rs.4400/- and not more than Rs.9000/-, the same will be covered by Group -C category. As aforesaid, it is not in dispute that the pay scale of late Smt. T.D. Sonawane was Rs.5500-9000/-. The natural meaning to the assigned to the above clauses, in our opinion, is that if the pay scale is between Rs.4400/up to Rs.9000/-, such cases would be covered by Group-C category, whereas if the pay scale is between Rs.9001/- up to Rs.11500/-, the same will be covered by Group -B category. If any other interpretation is given to the said clauses, it would create anomalous situation. In much as, a person with the pay Scale of Rs.9000/- will be covered in Group -B category as well as Group -C category since pay Scale of Rs.9000/- is mentioned in both categories. Such interpretation cannot be countenanced. Thus understood, the stand taken by the respondents that the petitioner is ineligible as his case is covered in Group -B category, cannot be sustained. That stand will have to be stated to be rejected since admittedly the pay scale of the petitioner's predecessor was Rs.5500-9000."

4. The aforesaid judgment of the Hon'ble Bombay High Court was challenged before the Hon'ble Apex Court, however, the Hon'ble Apex Court did not cause any interference in the judgment of the Hon'ble High Court. The aforesaid judgment has thus attained the finality. The aforesaid judgment is followed in W.P. No. 1221/2017 decided by another Division Bench. In the common judgment rendered by this Tribunal in O.A. No. 198/2016 with O.A. No. 828/2017, Tribunal has discussed the aforesaid two judgments of the Hon'ble Bombay High Court and in view of the law laid down in the aforesaid judgments, allowed the aforesaid OAs.

### :: - 4 - :: O.A. NO. 1081/2022

5. In the instant matter, the applicant has been refused the compassionate appointment only on the ground that the deceased Government servant in whose place the appointment on compassionate ground is sought since was receiving the wages in the pay scale of Rs. 5500-9000 must be held to be falling in the cadre of Group 'B' officers, whose legal heirs are not made entitled to seek the appointment on compassionate ground. In view of the law laid down by the Hon'ble Division Bench of Bombay High Court in W.P. No. 5440/2009 cited supra the defense as has been raised on behalf of the respondents has to be rejected and the present O.A. deserves to be allowed. In the result the following order is passed: -

#### ORDER

- (i) The impugned communication/order dated 01.02.2021 is quashed and set aside.
- (ii) The respondents are directed to include the name of the present applicant in the waiting list maintained of the candidates eligible for to be appointed on compassionate ground.
- (iii) The seniority of the present applicant in the waiting list shall be reckoned from the date of his making application with the concerned authority.

(iv) The Original Application is allowed in the aforesaid terms. There shall be no order as to costs.

2. By filing the present O.A. the applicant is claiming arrears towards the wages as per Government Notifications dated 15.2.2003 and 28.9.2010. It is not in dispute that the applicant is working as Part Time Sweeper in the office of respondent No. 4. It is also not in dispute that respondent No. 4 has started paying the applicant in accordance with the to Government Notification dated 28.9.2010 w.e.f. 7.3.2018. The respondents in their affidavit in reply have fairly submitted that the claim of the applicant for difference in arrears of the earlier period has to be considered and accordingly the proposal has been forwarded by respondent No. 4 to respondent No. 1. In the chart which is there at page No. 27 of the O.A., which is part of the proposal moved by respondent No. 4 to respondent No. 2, the name of the applicant appears at Sr. No. 16 and the arrears are worked out to the tune of Rs. 69016/-. The applicant is claiming the said amount by filing the present Original Application. In view of the fact

that the applicant is vested with the right to receive the wages as per the Government Notifications dated 15.2.2003 and 28.9.2010 and accordingly the arrears have been worked out, the Original Application deserves to be allowed. Hence, the following order is passed: -

### ORDER

- (i) The respondents are directed to release the amount of Rs. 69016/- in favour of the applicant within a period of three months form the date of this order.
- (ii) The Original Application is allowed in the aforesaid term. There shall be no order as to costs.

- 2. Present applicant had applied for the post of Police Patil for village Amdari, Tq. Sengaon, Dist. Hingoli. Applicant successfully passed the written examination for the said post and was included in the list of selected candidates. However, at the time of documents verification it was noticed by the concerned authority that the on date advertisement i.e. on 6.12.2017, the applicant was below age of 25 years and on that ground the respondents have refused the appointment to the present applicant. Aggrieved by the said order the applicant has approached this Tribunal.
- 3. Learned counsel for the applicant submitted that correct date of birth of the applicant is

3.6.1990, however, in the school record it has been mentioned as 6.3.1993. Learned counsel submitted that after rejection of claim of the applicant on the aforesaid ground, she approached the Hon'ble Bombay High Court, Bench at Aurangabad by filing Writ Petition No. 1727/2018 (Janabai Bhanudas Gadade vs. the State of Maharashtra & Ors.). Hon'ble High Court disposed of the said writ petition vide it's order dated 10.4.2019 by giving directions to the Education Officer to correct the date of birth of the applicant in the school record, if such application is made, and decide such application on its own merit. Accordingly, the applicant got the certificate from the Village Panchayat, certificate Tahsildar and thereafter the from the authorities corrected the date of birth of the applicant in the school record as 3.6.1990 instead of 6.3.1993.

4. Learned counsel submits that the applicant has thus brought on record sufficient evidence demonstrating that on the date of issuance of the advertisement i.e. on 6.12.2017, the applicant had completed age of 25 years and in such

circumstances appointment could not have been refused to the applicant on the ground of having the age below 25 years. Learned counsel further submitted that the post of Police Patil of village Amdari, Tq. Sengaon is still vacant. Learned counsel has therefore sought direction against the respondents to give appointment to the applicant on the post of Police Patil of said village in view of her corrected date of birth.

5. The respondents have failed in filing the affidavit in reply. Learned Presenting Officer however submitted that on the date of issuance of the advertisement the only authenticate document showing date of birth of the applicant was the school leaving certificate of the applicant, wherein her date recorded as 6.3.1993. of birth is In the circumstances, according to learned P.O., no error has been committed by the respondents in refusing the appointment to the applicant being underage candidate. Learned P.O. further submitted that the subsequent correction got done by the applicant may not be of any use to the applicant since on the

date of filing application no such evidence was in existence.

6. I have duly considered the submissions advanced on behalf of the applicant, as well as, the respondents. Applicant is aggrieved by the order dated 16.1.2018 passed by the Sub Divisional Magistrate, Sengaon, who was also the President of the Committee for recruitment of Police Patils. The said order reads thus:-

तसेच जाहिरातीत नमुद मुद्दा क्र.22 q) नुसार लेखी परीक्षा ही उमेदावराची कोणतीही कागदपत्र तपासणी न करता घेतली जाणार असल्याने केवळ लेखी परीक्षेस बसू दिल्यामुळे उमेदवाराला निवडीबाबत कोणताही हक्क राहणार नाही. तसेच R) नुसार उमेदवाराने भरलेल्या माहिती आधारे त्यास प्रवेशपत्र देऊन परीक्षेस पात्र करण्यात येईल निवड झालेल्या उमेदवाराची (online) अर्जाप्रमाणे त्याची सर्व मूळ प्रमाणपत्र / कागदपत्रे याची सत्यता पडताळणी करण्यात येईल. सत्यता पडताळणीच्या वेळेस उमेदवाराने (online) भरलेल्या अर्जात नमुद केलेल्या माहिती व्यतिरीक्त सादर केलेल्या इतर कागदपत्राचा विचार केला जाणार नाही तसेच पडताळणी करतांना उमेदवाराने (online) भरलेल्या अर्थात नमुद केलेल्या बाबीचे प्रमाणपत्र / कागदपत्र तो सादर करण्यास असमर्थ ठरल्यास किंवा अर्जासोबत दिलेली माहिती / अगर कागदपत्र खोटी सादर केल्याचे किंवा खरी माहिती दडवून ठेवल्याचे निदर्शनास आल्यास त्याला भरती प्रक्रियेतून बाद करण्यात येईल व याबाबत उमेदवाराची कोणतीही तक्रार ऐकली जाणार नाही.

तसेच संदर्भीय जाहिरातीतील विशेष सुचना क्र. 12 नुसार निवड प्रक्रिया सुरु झाल्यानंतर उमेदवाराने अर्जत दिलेली माहिती / अगर खोटी कागदपत्रे सादर केल्याचे किवा खरी माहिती दडवून ठेवल्याचे निदर्शनास आल्यास त्या उमेदवारास निवड प्रक्रियेच्या कोणत्याही टप्प्यावर अपात्र करण्यात येईल. तसेच नियुक्ती झाली असल्यास कोणतीही पूर्व सूचना न देता त्याची नियुक्ती समाप्त करण्यात येईल व त्याच्या विरुद्ध कायदेशिर कारवाई करण्यात येईल असे नमूद आहे.

त्याअर्थी श्रीमती जनाबाई गडदे रा. आमदरी ता. सेनगाव जि. हिंगोली यांना संदर्भीय जाहिरातीत नमुद विहित दिनांकाला 25 वर्ष पूर्ण होत नसल्यामुळे सदरील पोलीस पाटील भरती 2017 च्या मुलाखतीमधून त्यांचा उमेदवारी अर्ज अपात्र करण्यात येत आहे.

From the aforesaid order it is quite evident that the school leaving certificate was the only document produced by the applicant at the time of scrutiny/verification of the documents, wherein date of birth of the applicant is recorded as 6.3.1993. Learned S.D.M. relying on the said document rejected the candidature of the applicant on the ground of being underage candidate.

7. Only after rejection of her candidature that the applicant has exerted for getting corrected her date of birth in school record. However, all such effects subsequently made may not take the cause of the applicant further so as to hold the impugned order illegal or unjust or unsustainable. On the date of scrutiny of the documents, as I have noted hereinabove, insofar as the age of the applicant is concerned, only document before the competent authority was the school leaving certificate, wherein her date of birth was mentioned as 6.3.1993. Though the applicant had subsequently corrected her date of birth, it appears to me that, that may not help the applicant for making out any case for setting aside the impugned order. No illegality has

been committed by the S.D.M. in rejecting the claim of the applicant. I, therefore, see no reason for causing any interference in the impugned order. Hence, I pass the following order:-

### ORDER

The Original Application stands dismissed without any order as to costs.
