I further most humbly say and submit that, the applicants have concealed the material facts regarding the other conditional clauses said advertisement dated 08.02.2018 in the particularly Clause No. A, B and E which contained that, the said posts of police peon mentioned in the chart have been announced by calculating the possible/proposed till vacancies the end of 31.12.2018 and the candidates appearing in the final selection list in the order of category wise merit will be appointed to the category wise candidates as soon as the posts become vacant on the establishment of this entity. It is also specifically contended in this clause that, the inclusion of a candidate's name in the final selection list should not be construed as conferring the right to appointment.

10. I say and submit that, the candidate mentioned by the applicants namely Smt. Doprada Pandurang Dhumale is at Sr. No. 39 in the final list who is senior to the applicants. The applicant No. 1 is at Sr. No. 40 in **final list**. The applicant No. 2 is at Sr. No. 6 in **waiting list**. The applicant No. 3 is at Sr. No. 43 in **final list**. The applicant No. 4 is at Sr. No. 4 in **waiting list** and the applicant No. 5 is at Sr. No. 42 in **final list**. Therefore, as per the said final list the selected candidate will be appointed on the posts which will be vacated as per seniority and after the final selected candidates and candidates in waiting list will be recruited in service. Therefore, the respondents have no any

fault or role in the process of appointment of the applicants which is shown adversely in the present application. No any adverse action has been taken by the respondents against the applicants.

3. The respondents have not denied the claim of the applicants. It is their contention that it was clarified to all the candidates that the appointments would be made in order of merit as the vacancies would occur. The respondents have specifically contended that none of the candidates junior to the present applicants has yet been appointed from the said category. A specific question was asked to the learned counsel, whether any candidate. having less marks than the present applicants has been given appointment from the category of S.T.?, The learned counsel submits that nothing such has happened. In the circumstances it appears to us that the relief as has been prayed in the present O.A. cannot be granted. 2. The grievance of the applicant is that despite his representation and request, he has been given posting on his promotion at the inconvenient place. The applicant claims to be a differently abled person. Earlier the applicant was working at Nilanga in Latur District and on promotion has been posted at Beed. It is the contention of the applicant that even before issuance of promotion order, he was requesting the respondents for retaining him in Latur District on his health ground. Since, however, his request has not been considered, the applicant has preferred the present Original Application.

3. The learned counsel for the applicant submitted that considering fact that the the belongs to differently abled applicant person category, his case requires to be considered

differently. Learned counsel submits that at the relevant time as was told to the applicant, the post was not available at Latur since Shri S.N. Gaikwad was given posting at the said place on promotion. The learned counsel submits that now it has come on record that the promotion of Shri S.N. Gaikwad has been cancelled and consequently the post at Latur is still vacant. In the circumstances, learned counsel has prayed for directions against the respondents to consider the request of the applicant for his posting at Latur.

4. Presenting Learned Officer opposed the contentions raised on behalf of the applicant. Learned P.O. submitted that the applicant is in District Latur since about 20 years. Learned P.O. further submitted that on promotion the employee concerned has to join at the place where he has been given posting on promotion or else he has to refuse the promotion. Learned P.O. submits that the Civil Services Board, which is a competent independent body, has recommended the posting of the applicant at Beed. In such circumstances, no case is made out by the applicant for grant of interim prayer.

#### O.A. NO. 412/2023

5. I have duly considered the submissions made on behalf of the applicant and the respondent authorities. It is not in dispute that the applicant has worked in Latur District for a quite long period. On promotion the employee concerned has to join at the place where he is posted after his promotion and if he is unwilling to join on the post, he has to deny the promotion. As is revealing from the record, after promotion the applicant resumed at Beed and he is pursuing his request thereafter.

6. The cases of the employees falling in the category of disabled are to be considered sympathetically and sensitively. The applicant has joined at the transferred place and has been working there. Having regard to the fact that the applicant bears the physical disability, if it is possible and if otherwise there is no impediment, the respondents shall consider the request of the applicant on its own merit and communicate him the decision.

7. With the above observations, the present Original Application stands disposed of. There shall be no order as to costs.
