- 5. So far as the G.R. dated 21.09.2017 is concerned, it appears that vide paragraph No.21 the Government has considered and permitted the substitution only in case of death of the person seeking compassionate appointment whose name is included in waiting list and not in any other case.
- 6. In view of aforesaid directions in the case of **Dnyaneshwar S/o Ramkishan Musane Vs. the State of Maharashtra & Ors. reported in 2020 (3) ALL MR 550**, learned P.O. is hereby directed to take specific instructions from General Administration Department, State of Maharashtra with regard to the deletion of aforesaid restriction, which is part of G.R. dated 20.05.2015 and make appropriate submissions on the next date of hearing.

- 2. Since in all these applications the grievance raised and the reliefs claimed by these applicants are identical, we have heard all these applications together and deem it appropriate to pass this common order.
- 3. The grievance of the applicants is that in the seniority list published on 15.6.2023 their seniority has been adversely disturbed and persons junior to

them have been erroneously shown above them in the seniority list. Learned counsel for the applicants pointed out that some of the applicants have already raised challenge to the said seniority list before this Tribunal and this Tribunal has passed certain interim orders in their favour. All these orders are placed on record.

4. Learned counsel for the applicants submitted that now the applicants are served with the show cause notices for their reversion to the lower post. Learned counsel submitted that in the interim order passed by this Tribunal in O.A. No. 526/2023, this Tribunal has considered the grievance of the applicant therein. Learned counsel submitted that the applicants in the present OAs stand at par with the applicants in the said matter. Learned counsel submitted that one of the applicants has already submitted reply to the show cause notice and others are in the process of submitting the said reply. Learned counsel further submitted that however, there is strong apprehension that the respondents may at any time pass an order reverting these applicants to the lower post. In the circumstances,

learned counsel has prayed for interim relief, thereby restraining the respondents from taking any further action in pursuance of the show cause notice so issued.

- 5. Learned Chief Presenting Officer submits that for want of instructions he is unable to make his submissions as about the facts involved in the present matters. Insofar as legal position is concerned, learned C.P.O. submitted that no blanket orders can be passed in such matters, unless the entire material comes on record. He has, therefore, prayed for rejecting the request for grant of interim relief so made by the applicants.
- 6. We have duly considered the submissions made on behalf of the applicants. We have also gone through the documents placed on record. The grievance raised and the relief sought in the present matters is identical with the challenge raised and the prayers made in O.A. No. 526/2023. In O.A. No. 526/2023 this Tribunal has granted interim orders in favour of the applicant therein.

7. Having considered the submissions advanced on behalf of the applicants and on perusal of the documents filed on record, there appears prima facie substance in the grievance raised by the applicants that their seniority has been improperly disturbed. In the present matters, the applicants are served with the show cause notices for their reversion because of change in their seniority in the seniority list now published. In the circumstances, the applicants have certainly made out a case for grant of interim relief in their favour. We are however, not inclined to grant blanket stay as has been prayed for by the applicants. Instead we deem it appropriate to direct the respondents to maintain status quo in respect of the present position of the applicants till filing of the affidavit in reply by the respondents. Hence, the following order: -

ORDER

(i) Issue notice to respondents, returnable on 08.01.2024. Respondents are directed to maintain status quo in respect of the present position of the applicants till filing of the affidavit in reply by them.

- 2. Learned Counsel has sought review of the order passed by the Tribunal on 30-03-2022 in O.A.No.108/2019. It is the contention raised on behalf of the applicant that had the respondents accommodated respondent no.4 to fill the vacancy arose in Open category, the applicant was having chances of his appointment from DT(A)/VJ(A) category. According to the applicant the Tribunal while deciding the O.A. vide the judgment under review failed in considering the said aspect and that is the apparent error on the face of record.
- 3. We have gone through the order passed by this Tribunal in O.A., review of which is sought by the applicant. In paragraph 5 onwards the Tribunal

has recorded its analysis and in paragraph 6 the conclusion is recorded. After having gone through the analysis so made and conclusion recorded by the Tribunal, in the light of the contentions raised in review application it does not appear to us that any apparent error has occurred while delivering the said judgment. Review application, therefore, deserves to be dismissed. Hence, the following order:

2. The applicant applied for the post of Physical Instructor in Training pursuance of the advertisement published on 10-05-2023 read with corrigendum dated 17-05-2023. Vide the said advertisement 3 posts are advertised. One is reserved for VJ(A) second is for OBC and third is reserved for EWS candidate. Applicant belongs to In the written examination the EWS category. applicant secured 108 marks. Another candidate from EWS category, namely, Ashika Kanak Baraliya received 116 marks and was therefore selected for the seat reserved for EWS category. VJ(A) candidate, however, could not become available. It is the contention of the applicant that in view of the provision under clause 6.5 of the advertisement for

non-availability of VJ(A) candidate the applicant was liable to be selected being next candidate in the merit list. In the circumstances, applicant has preferred the present O.A. seeking directions against the respondents to hold him entitled for appointment on the seat reserved for VJ(A) candidate.

- 3. Applicant has raised one more ground of objection that by issuing corrigendum the respondents have provided 100% reservation for the post of Physical Training Instructor. According to the applicant it is impermissible and against the Constitutional provisions.
- 4. In view of the submissions made, we have perused clause 6.5 of the advertisement, which reads thus:

5. Referring to the aforesaid clause, it has been argued that for non-availability of the candidate belonging to VJ(A) category, the seat reserved for the said category could have been filled in by giving appointment to the applicant who comes from EWS category and who is at the third place in the merit The interpretation so made by the learned list. Counsel of the aforesaid provision is difficult to be accepted. Reading of the aforesaid clause would mean that the seat reserved for the candidates belonging to VJ(A), NT(B), NT(C) and NT(D) are interchangeable. Meaning thereby that in case the seat is reserved for the candidate belonging to VJ(A) category but no candidate is available from the said category and if the candidate is available possessing adequate merit belonging to any of the other categories i.e. NT(B) or NT(C) or NT(D) such a candidate can be accommodated in place of the VJ(A) candidate or vice-versa. The aforesaid provision in no case can be interpreted to mean that for non-availability of VJ(A) candidate the seat reserved for the said category can be filled in by the candidate coming from EWS category. Therefore,

there appears no substance in the grievance raised by the applicant and the prayer made in the O.A.

- Another ground of objection raised by the 6. applicant is that there cannot be 100% а reservation. Learned Counsel for the applicant has submitted that there are 3 posts advertised of Physical Training Instructor; one is for EWS, another is for OBC and third one is for VJ(A) According to the learned Counsel this candidate. amounts to 100% reservation which is impermissible.
- 7. The aforesaid contention also cannot be accepted having regard to the pleadings in the O.A. Advertisement is issued inviting applications for several posts and not only for the post of Physical Training Instructor. It is further specifically mentioned in clause 6.1 of the advertisement that the reservations are prescribed as per the demand made by the Government.

8. It is further significant to note that without raising any such objection the applicant has participated in the recruitment process. After

having participated in the recruitment process, the applicant cannot now raise any such objection. Moreover, such a ground cannot be raised by the applicant who himself is claiming a seat from the reserved category.

9. Considering the facts as aforesaid, it does not appear to us that any case is made out by the applicant even for issuance of notice to the respondents. O.A., therefore, deserved to be dismissed summarily. Hence, the following order is passed:

ORDER

O.A. is dismissed. No order as to costs.
