The present Original Application is filed challenging the impugned communication / order dated 03.04.2023 (Annexure-C), whereby the respondent No. 1 the Government has directed the respondent No. 3 not to act upon the transfer order of the applicant dated 31.03.2023 (Annexure-B) at Sr. No. 14, whereby the applicant has been transferred on promotion from the post of Assistant Engineer, Grade-I, Jihe Kathapur Project, Sub-Division No. 4, Koregaon to Executive Engineer, Urdhva Painganga Project Division No. 8, Nanded. No reason is mentioned in the said impugned order / communication dated 03.04.2023.

4. It is the contention of the applicant that there are in all 29 such Assistant Engineers including the applicant, who have been promoted under the order of transfer dated 31.03.2023 (Annexure-B). Except the applicant, all others are allowed to join on their respective promotional posts.

5. In the affidavit in reply filed on behalf of respondent Nos. 1 to 3 it is contended that due to administrative reasons the impugned order is issued. Issue before this Tribunal is as to whether the applicant can be deprived of promotional posting. Prima-facie, it seems that the applicant has been singled out thereby depriving him of benefit of promotional post without stating any cogent reasons in the impugned order.

6. Learned Presenting Officer has also placed on record a copy of communication dated 08.05.2023 received by the office of C.P.O. from the respondent No. 1, whereby it is stated that new posting order of the applicant is under consideration.

7. However, how long the said process would take is not clear. In such circumstances, at this stage,

interim relief in terms of prayer clause 9(D) is granted till completion of pleadings, which is as follows :-

"D] Pending hearing and final disposal of this Original Application, the impugned communication / order dated 03rd April, 2023 issued by the respondent No. 2 bearing SLS1121/Adm.No. 268/Part4/2021/Aa(Class-1) be stayed and for that purpose necessary direction be issued."

proceeding of Paper-I as V15-11762 and Paper-II as W15- 21762 of examination held on 11.9.2022 as was attended by applicant and was conducted by respondent, MPSC as per Advertisement no. 1/2022 dated 7.1.2022 in Aurangabad Center.

d. The direction may kindly be given to respondent, MPSC to give the certified/ authenticated copies of answer-sheets of applicant of Paper - I as VIS-11762 and Paper II as W15 - 21762 of examination held on 11.9.2022 as was attended by applicant and was conducted by respondent, MPSC as per Advertisement no. I/ 2022 dated 7.1.2022 in Aurangabad Center as per her on-line request to respondent, MPSC."

4. Perusal of the O.A. does not specify any contravention or breach of Rules in conducting the examination held for the post of Assistant Public The applicant is not declared Prosecutor (APP). qualified. In view of the same, the applicant sought copies of answer sheets to verify marks obtained by her. In the entire O.A., there is no allegation against the respondents affecting the right of the applicant in getting employment as APP. If the copies of answer sheets are not provided, the applicant has appropriate efficacious remedy under RTI. The dispute raised by the applicant does not fall within the jurisdiction of this Tribunal under Section 15 of the Administrative Tribunals Act, 1985, which can
