2. The present application is filed seeking condonation of delay, which has occurred in filing the accompanying Original Application.

3. The applicant has filed the present O.A. seeking the following relief :-

"A. The Original Application may kindly be allowed.

B. In view of the above facts and circumstances, this Hon'ble Tribunal would be pleased / sec. 19 of Administrative Tribunal Act, 1985 to quash and set aside the letter dated 11.4.2018 and to direct the respondents to decide representation dated 17/2/2018 and 14/2/2018 and grant the revised pay scale and pensionary benefits w.e.f. from 1991.

C. In view of the above facts and circumstances, this Hon'ble Tribunal would be pleased / sec. 19 of Administrative Tribunal Act, 1985, to quash and set aside the letter dated 11/4/2018 and order dated 1/9/2014 issued by respondents and grant the revised pay scale and pensionary benefits w.e.f. from 1991.

D. Pending hearing and final disposal of this application direct the respondents to quash and set aside the letter dated 11/4/2018 and to direct the respondents to decide representation dated 17/2/2018 and 14/2/2018 and grant the revised pay scale and pensionary benefits w.e.f. from 1991.

E. Any other just and equitable relief may kindly be granted in favours of the applicant. ”

4. It is the contention of the applicant that since his representation was rejected in the year 2018 the cause of action for approaching this Tribunal arose thereafter. We are however not convinced with the submission so made. It has also to be looked into whether representation was made within reasonable period by the applicant or it was also made belatedly. The representation, which has made belatedly after inordinate delay, rejection of the said representation may not provide any cause of action for filing O.A. more particularly for the delay which has occurred in filing O.A.

5. In the present matter as has been argued by the learned counsel the prayer is to grant the benefit of second time bound promotion to the applicant. As is revealing from the pleadings of the learned counsel the right has accrued in favour of the applicant in the year 2013. He was granted first benefit of time bound scheme in the year 1991. Thereafter since the applicant has not passed the necessary examination he has to wait for benefit of second time bound and as per the pleadings of learned counsel it was liable to be paid in the year 2013. The representation in that behalf has been made by the applicant on 14.2.2018 i.e. after inordinate delay of 5 years. On going through the copy of said representation it appears that it is

too vague. It is also difficult to find out as to what exact relief is claimed by the applicant by the said representation. We did not find prayer of the applicant as about grant of second benefit of time bound scheme. In the O.A. reliefs are sought in literal meaning from the year 1991. Apparently the claim of the applicant appears stale. The applicant was not diligent in agitating his claim.

6. It is the contention of the learned counsel that right has accrued because of judgment of Hon'ble Bombay High Court in **Writ Petition No. 2605/2017 (The Association of the Sub-ordinate service of Engineers, M.S. & Ors. Vs. The State of Maharashtra & Ors.)** dated 6.2.2019. Copy of the said order is tendered across the bar. We are surprised to note that the said judgment is of February, 2019 and present O.A. and M.A. are filed on 2.7.2019 & 5.8.2019 respectively. However, still we feel that opportunity needs to be given to the applicant for presenting his claim.

7. With the observations as above we allow the present M.A. so that the applicant may get opportunity to prosecute his O.A. however subject to costs of Rs. 1,000/-.

8. Accompanying O.A. be registered in accordance with law and be placed on board on 30.9.2022.
