pointed out that the respondent Nos.1 & 2 have filed joint affidavit in reply, wherein they have considered the impugned order as transfer order of the applicant, may be on the basis of the proposal submitted by the respondent No. 3 to 2 and onward transmission to respondent No. 1. On the other hand the respondent No. 3 i.e. the Collector, Jalgaon has filed affidavit in reply, wherein it is stated that the impugned order is about the regularization of the promotion and the applicant has been given the posting at Malegaon, Dist. Nashik, since the Departmental Enquiry was initiated against him and it was pending.

Learned Chief Presenting Officer as directed by this Tribunal has shown this Tribunal record and proceedings and on perusal of the same, I find that in the meeting of the Civil Services Board dated 31.05.2022, there are no reasons mentioned as against the transfer of the applicant specifically in terms of the allegations made against him and the Departmental Enquiry came to be initiated against the applicant.
- 4. Learned counsel for the applicant submits that in view of the contradictory affidavits in reply on

behalf of respondent Nos. 1 and 2 on one side and respondent No. 3 on the other hand and in the minutes of the Civil Services Board there is no reference with the special reasons transferring the applicant from Jalgaon to Malegaon, Dist. Nashik, the impugned order has been stayed by this Tribunal by order dated 29.06.2022. Learned counsel submits that the applicant is suffering from physical deformity of 51% and the applicant is going to be retired in the month of April 2025.
