- 3. Statement of learned C.P.O contains an indirect expression that the A.C.B is an independent investigating agency and is not to be supervised by Commissioner of Police or any other law enforcing agency and all the Commissioner of Police can do is to request and wait. Therefore, the work of pursuing A.C.B has to be done by D.G.P and by the Government.
- 4. The stance of Commissioner of Police appears to be real.
- 5. Learned C.P.O was called to state as to what steps Government would take, to overcome the tangel which is not displayed before us. We have noted that many cases come before us where the investigation at the level of A.C.B is delayed inordinately. May be that A.C.B has some or many excuse for that, however, every possible effort has to be made for eliminating delay at each stage and step.
- 6. Learned C.P.O states that he needs to take instruction from the D.G.P as well from Home Department.
- 7. We expect that the instructions be taken by learned C.P.O from Addl. Chief Secretary, Home Department, Mantralaya, Mumbai, at the request of learned C.P.O
- 8. We expect that learned C.P.O shall have a meeting with the Addl. Chief Secretary, Home Department, Mantralaya, Mumbai for working out modalities to eliminate the delay caused at the stages of investigation, sanction of filing of case as well as delay in deciding as to continuation/revocation of suspension of various Police Officer who are suspended. Hearing is adjourned.
