ORDER

- 1. Applicant who is working as Forester in Sanjay Gandhi National Park, Borivali, Mumbai challenges order dated 06.08.2024 passed by the Respondent No.1 transferring him from the post of Forester, Maghathane, Forest Range Krushnagiri Upwan Range, Borivali, Mumbai Suburban District to the post of Forester, Sudkoli Forest, Fansad (Wild Life), Thane.
- 2. Learned Counsel has submitted that Applicant was transferred earlier to Maghathane, Forest Range Krushnagiri Upwan Range, Borivali by order dated 29.07.2020. Though he has completed three years the reason for transfer mentioned in order dated 06.08.2024 (page 13) is not sustainable under the Maharashtra Government Servants Regulation and Transfers and Prevention of Delay in Discharge of Official Duties Act, 2005 (hereinafter referred to as 'the ROTA 2005' for brevity). Learned Counsel has submitted that it is midterm transfer and under Section 4(4)(ii) of the ROTA 2005 special reasons and exceptional circumstances are required to be recorded and in the present case, there is neither exceptional circumstance nor special reasons are recorded. Learned Counsel has further challenged



the competency of Respondent No.1, the Chief Conservator of Forest and Director, Sanjay Gandhi National Park, Boriwali on the following grounds:

- (i) Respondent No.1 cannot use his powers for transferring the employee out of his jurisdiction.
- (ii) Respondent No.3, the Chief Conservator of Forest (Territorial), Thane Forest Circle, Thane is the competent authority to issue transfer order of the Applicant.
- (iii) As per Section 7 of the ROTA 2005 the State Government is the competent authority to issue transfer order of the Applicant from one jurisdiction to another jurisdiction.
- (iv) As Applicant is working on Group-C post hence his case falls under clause (c) of Section 6 of the ROTA 2005.
- (v) No CSB meeting was conducted while passing the order of transfer.
- (vi) Applicant is due to retire in December, 2025. By letter dated 27.05.2024, Exhibit-B Applicant made request giving two options for his transfer (i) Forester, Ghodbunder (Yeur Forest Range) &
- (ii) Forester, Superintendent, Sinhvihar. However, none of the options were considered.
- (v) Applicant's wife is suffering from migraine.
- 3. Learned P.O. for the Respondents has submitted that CSB meeting was conducted on 30.04.2024. He has submitted that applicant is working in Sanjay Gandhi National Park, Borivali since last 23 years. He has completed his tenure. There are also complaints made against the Applicant. Learned P.O. has submitted that Respondents had valid reasons and special circumstances are made out to transfer the applicant mid-term by invoking the powers under Section 4(4)(ii) of the ROTA 2005. Learned P.O. has submitted that the problem of migraine suffered by the applicant's wife is not a serious illness. Learned P.O. has submitted on instructions that in place of Applicant, one Mr. Vishal Sawant has joined on 09.08.2024 on promotion. Learned P.O. has submitted that the Department has served the transfer and relieving order to the Applicant. However the Applicant has refused to accept the same and instead submitted leave application.



- 4. By counter submissions learned Counsel has submitted that as per Clause (b) of the Table appended to Section 6 of the ROTA 2005 it is the Hon'ble Forest Minister in consultation with the Secretary of the said Department who is the immediate superior authority to effect such special transfer. Learned Counsel has also submitted that order dated 06.08.2020 passed by Respondent No.1 is not served on the applicant. He has pointed out that under Rules 29 and 30 of the Maharashtra Civil Services, (General Conditions of Services) Rules, 1981, wherein in Rule 29 it is stated that relieving Government servant to intimate the probable date of joining to the Government servant to be relieved and Rule 30 states that how the date of handing over charge is determined.
- 5. Learned Counsel seeks leave to amend the O.A. by adding Mr. Vishal Sawant, who is promoted on applicant's post and has joined on 09.08.2024, as Party Respondent No.4 in the array of Respondents.
- 6. Leave granted. Amendment be carried out and copy be served upon the concern forthwith.
- 7. Considering the facts of the case which are placed before me, by the learned Counsel for the Applicant and learned P.O. for the Respondents, I am of the view that some time is required to be given to the Respondents to place the relevant facts on record. Applicant who is at present not working anywhere is directed to join the new place of posting temporarily, because the person cannot be without work when he or she is in Government service. Considering that there is word against word made by both the parties, both the parties are directed to state the same on affidavit.
- 8. The office objections, if any, are to be removed and court fees to be paid, if not already paid.
- 9. Issue notice before admission returnable on 26.08.2024.

- 10. Applicant is authorized and directed to serve on Respondent intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of O.A. Private service is allowed. Respondents are put to notice that the case may be taken up for final disposal at the stage of admission hearing.
- 11. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
- 12. By Hand delivery, speed post, courier notice to be served and acknowledgement be obtained and produced along with affidavit of compliance in the Registry within one week. Applicant is directed to file Affidavit of compliance and notice.
- In case notice is not collected within seven days or service report on affidavit is not filed three days before returnable date, the Original Application shall be placed on board before the concerned Bench under the caption "for Dismissal" and thereafter on the subsequent date the Original Applications shall stand dismissed.
