2. This application is filed challenging the impugned transfer order of the applicant dated 15.07.2022 (part of Annex. 'A-2' collectively at page No.12 of P.B.), whereby the applicant has been transferred from the Police Station, Chikalthana to Police Control Room, Aurangabad (Rural), Aurangabad and the applicant is seeking interim relief of stay to the execution and implementation of the said impugned transfer order.
