8. After having considered the Misc. Application and submissions as above, I find that Original Application is filed being aggrieved by not giving No Objection Certificate by the respondent No.4 vide impugned order dated/letter 09.06.2021 (Annex. 'A-3'). Perusal of the said impugned order/letter dated 09.06.2021 (Annex. 'A-3') would show that, it is stated therein that promotion of other eligible Government Servants will be affected if the request of the applicant for inter-division transfer is granted. In view of same, the grievance which is sought to be raised by this Misc. Application is already there on record. If the Misc. Application is allowed by way of intervening by these various applicants, this will amount to giving permission to the parties to agitate as Public Interest Litigation which is not the purpose of the Original Application filed before this Tribunal under Section 19 of Administrative Tribunals Act.

9. In view of above, in my considered opinion, the applicants cannot be said to be necessary parties for the reasons stated by them. In view of same, I don't find any merit in this application. Hence, the Misc. application is rejected. No order as to costs.
