It is clear that application was submitted for NEET PG Examination 2022 on 16-01-2022 i.e. prior to making application for "No Objection Certificate" from Deputy Director, Health Services which was made on 15-02-2022. Therefore, technically the applicant is non-compliant of the provisions of paragraph 4.1 of the Government Resolution dated 19-03-2019. This issue has been already elaborated in order passed on 10-10-2022.

3. The applicant was directed to submit copy of G.R. dated 26-03-2020, reference of which has come in the remarks column of page no.112 of paper book which reflects reasons for deciding eligibility of the candidates. Clause 9.1 of the aforesaid G.R. reads as follows:

The above shows that the applicant is non-compliant of above provision too.

The learned Counsel for the applicant has also submitted one compilation of documents which contains an advisory dated 14-04-2022 issued by Director General of Health Services, Government of India. The advisory is for the State Government to have uniform bond policy so that candidates do not face inconvenience. He has made specific reference to paragraph 2 and 3 of the said advisory which is at page 9 of the compilation. The compilation is taken on record, which contains application of the applicant for NEET PG 2022 also.

5. Learned Counsel for the applicant also submitted that as the applicant has not completed 3 years' bond period after completing PG Diploma course therefore if

he is selected to PG Degree course then the applicant is prepared to execute bond of additional one year after completing PG Degree course making total bond period to 8 years to compensate for shortfall of one year bond after completing Diploma course. This proposal along with proposed interim relief needs to be decided by Division Bench.
