2. In both these applications, since the issues raised and prayers made are identical, I have heard both these applications together and deem it appropriate to decide these applications by common reasoning.

3. Learned counsel for the applicants at the beginning of his argument pointed out that similar issue has been dealt with by this Tribunal in **O.A.** No. 651/2021 (Dr. Shivaji s/o Dadarao Birare Vs. the State of Maharashtra & Ors.) decided on 17.4.2023. Learned counsel pointed out that same prayers as are made in the present applications were made in

the said O.A. and the same defense, which has been raised by the respondents in the present matters, was raised therein. Learned counsel submitted that in such circumstances the present applications being covered by the judgment of this Tribunal delivered in O.A. No. 651/2021 on 17.4.2023, present O.As. also be allowed.

4. Facts as are stated by the learned counsel for the applicants are not disputed by the learned Presenting Officer appearing for State authorities. Shri Thorat, learned P.O. fairly submitted that the facts in the present applications and prayer made in the present matters are identical with O.A. No. 651/2021.

5. Learned counsel for the applicants thereafter pointed that the order passed in O.A. No. 651/2021 is based on one earlier judgment delivered by principal Bench of this Tribunal at Mumbai and said judgment has not been challenged before any higher forum.

::-3-:: <u>O.A. NO. 419 & 420 BOTH</u> <u>OF 2022</u>

6. I have gone through the pleadings in the OAs, as well as, prayers made therein. I have also perused the judgment rendered by this Tribunal in O.A. No. 651/2021. It is the contention of the applicant that as per clause 3(a)(xii) of G.R. dated 10.11.2009, the Associate Professors on completing 03 years substantive service is entitled to draw Grade Pay of Rs. 10,000/- in the pay scale of Rs. 37,400/- to Rs. 67,000/-. It is not in dispute that the applicants in both these cases have secured regular promotion to the post of Associate Professor in their respective branches and have successfully completed 03 years' period of service on the said had made representations to post. Applicants respondent no. 1 seeking implementation of G.R. dated 10.11.2009 and to extend Grade Pay of Rs. 10,000/- to them w.e.f. year 2013. However, since the respondents have not responded to the said representations, the applicants have preferred the present O.As.

7. In O.A. No. 651/2021 decided by this Tribunal on 17.4.2023 similar request was made seeking

directions against the respondents to extend Grade 10,000/- in light of G.R. Pay of Rs. dated 10.11.2009 from the date the applicants therein completed 03 years' service in substantive capacity with Grade Pay of Rs. 9000/-. In the said O.A. it was the contention raised on behalf of the respondents that unless Associate Professor is given substantial appointment on the post of Professor, he cannot claim Grade Pay of Rs. 10000/-. At the time of hearing of said O.A. the reliance was placed on behalf of the applicants on the judgment rendered by this Tribunal at principal seat in O.A. no. 829/2015 with O.A. No. 830/2015, wherein also the similar issue was for consideration of this Tribunal. I deem it appropriate to reproduce para nos. 5 & 6 from the judgment in O.A. no. 651/2021, which read thus:-

> "5. I have duly considered the submissions advanced on behalf of the applicant, as well as, on behalf of the respondent authorities. I have perused the documents filed on record and more particularly relevant G.R. In O.A. No. 829/2015 with O.A. No. 830/2015 the Division Bench of Principal Seat of this Tribunal at Mumbai has dealt with the provisions under the said G.R. and I deem it appropriate to reproduce paragraph No. 3, as well

as, paragraph No. 5 of the said judgment, which read thus:

The Pay Band for the post of Associate Professor is Rs. 37400-67000 with grade pay of Rs. 9000/-. Learned Counsel for the Applicants stated that the Government had issued a G.R dated 10.11.2009, to implement the Sixth Pay Commission for Teachers in Government Medical / Dental and Ayurvedic Colleges. As per clause 3(a)(xii) of this G.R, an Associate Professor on completing 3 years of service in the Academic Grade Pay (AGP) of Rs. 9000/possessing and а M.D/M.S/D.N.B/D.B/M.Ch/Ph. D degree in the relevant discipline shall be eligible to be appointed and designated as Professor, subject to other conditions of academic performance as laid down by the U.G.C and, if any, by the University. A.G.P for Professor is Rs. 10,000/-. Learned Counsel for the Applicants argued that the Applicants fulfilled the requirement of the aforesaid G.R and were granted A.G.P of Rs. 10,000/- after completion of three years as Associate Professor. However, by the impugned orders dated 22.6.2011 the Applicants were informed that they were not eligible to get A.G.P of Rs. 10,000/- after completion of 3 years' service as Associate Professor and were asked to refund the 'excess' payment. Learned Counsel for the Applicants argued that the impugned orders have been passed

on the basis of letter dated 29.3.2010 from the Respondent no. 2. This letter has attachment giving guidelines regarding how to implement the recommendations of the University Grants Commission (U.G.C) for medical teachers. In item no. 11, it is clarified that clause 3(a)(xii) in G.R dated 10.11.2009, prescribes the qualifications for an Associate Professor for promotion to the post of Professor. A person is eligible to be promoted after 3 years of service as Associate Professor, subject to his being found fit, availability of post etc. Learned Counsel for the Applicants argued that this is complete misreading of the G.R dated 10.11.2009, which is regarding revision of pay scale for inter-alia, medical teachers and not about promotion. This will be clear from the scheme of this G.R. In clause 2(2)(iii), it is stated that there will be different stages of Academic Grade Pay, which shall ensure that teachers will have multiple opportunities for upward movement during their career. Also in para 2(3)(a) of the aforesaid G.R, an Assistant Professor after 4 years of service and having M.D / M.S etc. qualification moves to A.G.P of Rs. 7000/-. Learned Counsel for the Applicants stated that the Respondent no. 3 had issued a letter dated 30.6.2016 to all Government Medical Colleges, wherein two earlier Government letters, regarding grant of AGP to Associate Professors in Government Ayurvedic Colleges of Rs. 10,000/- after 3 years of service in terms of G.R dated 10.11.2009 is mentioned. Learned Counsel for the Applicants stated that G.R dated 10.11.2009 is applicable to Government

Medical, Dental and Ayurvedic Colleges. If on the basis of this G.R, Associate Professors in Ayurvedic Colleges were given A.G.P of Rs. 10,000/- after 3 years of service, the same cannot be denied to the Applicants.

5. We have carefully perused the G.R dated 10.11.2009. It is regarding 'Revision of Pay Scales of Medical Education and Drugs Department-Teachers in Government Medical/Dental and Ayurvedic Colleges. In para 12, it is stated that:-

> "1.2 The question of implementing Government of India's scheme of revision of pay scales of teachers and equivalent cadres in colleges and other relevant guidelines was under active consideration of the State Government. The State Government has now decided to implement the revise pay scales of all teachers and equivalent cadres w.e.f 1.1.2006 as per the Central Government (U.G.C) scheme while other allowances per the State as *Government employees; to keep the age* of superannuation and leave package unchanged and the terms and conditions of services are as detail below for medical education." Para 2(2)(iii) reads:-

> "(iii) The pay of teachers and equivalent positions in Colleges shall be fixed according to their designations in two pay bands of Rs. 15600-39100 and Rs. 37400- 67000 with appropriate

"Academic Grade Pay" (AGP in short). Each Pay Band shall have different stages of Academic Grade Pay which shall ensure that teachers and other equivalent cadres covered under this Scheme subject to other conditions of eligibility being satisfied, have multiple opportunities for upward movement during their career."

Two things are clear, viz. the State Government had decided to implement the U.G.C package regarding pay scales in toto, except the age of superannuation, and the scheme envisaged multiple opportunities for upward movement during the career of a teacher. This 'multiple opportunities' will clearly mean, that there will be opportunities for financial upgradation, other than actual promotion. This interpretation is strengthened if the provisions of clause 2(3)(a) are considered as a whole. In sub clause (ii), it is mentioned that an Assistant Professor, on completion of 4 years, will be eligible to get AGP of Rs. 7000/- from earlier AGP of Rs. 6000/-. Only condition is that he should have a degree of M.D/M.S etc. Sub clause (xi) reads:-

> "(xi) Assistant Professors completing 3 years of teaching in AGP of Rs. 8000 shall be eligible, subject to other conditions that may be prescribed by the UGC and the university, to move to the Pay Band of Rs. 37400-67000 with AGP of Rs. 9000 and to be designated as Associate Professor."

It is clear that an Assistant Professor, who has worked for 3 years in AGP of Rs. 8000/is designated as Associate Professor and his AGP is increased to Rs.9000/-. Sub clause (xii), relied upon by the Applicant is logical extension of the scheme that an Associate *Professor, after 3 years, will be designated as* Professor and his grade pay would be enhanced to Rs. 10,000/- of course, at this stage, Government can place conditions of academic performance as laid down by U.G.C and University. However, the State does Government not seem to have implemented U.G.C guidelines in this regard viz. condition of academic performance. In fact, no affidavit has been filed by the Respondent no. 2 or 3 in these Original Applications and the task has been left to the Dean of the Government Medical College, who is unlikely to be acquainted with the matter, which is in the domain of the Respondent no. 2, i.e. the Government in Medical Education & Drugs Department. However, if there were any conditions of academic performance before an Associate Professor on completion of 3 years, could be given grade pay of Rs. 10,000/- it was for the Respondents to ensure that such conditions were satisfied. However, the Respondents have taken a stand that clause 3(3)(a)(xii) of the G.R dated 10.11.2009 is regarding promotion to the post of Professor. Looking into scheme of G.R dated 10.11.2009, this stand of the Government does not appear to be correct and The view taken by us is rejected. is strengthened by the letter dated 30.6.2016 issued by the Respondent no. 3 to all

Government Medical Colleges. The relevant portion reads:-

"शासनाच्या संदर्भ ३ व ४ येथील पत्रान्वये आयुर्वेद संचालनालयच्या नियंत्रणात असलेल्या आयुर्वेद तसेच अनुदानित महाविधान यातकार्भरत असलेल्या सहयोगी प्राध्यपकांना ज्यांची रू ९,०००/- शैक्षणिक ग्रेडवेतनात तीन वर्षे किंवा पेक्षा जास्त सेवा झालेली आहे अश्या सहयोगी प्राध्यापकांना रू १०,०००/- शैक्षणिक ग्रेड वेतन देऊन नामाभिधानित प्राध्यापक म्हणून संबोधण्यात यावे असे नमूद केलेले आहे."

It is clear that Associate Professors in Ayurvedic Colleges on completion of three years have been given AGP of Rs. 10,000/-. There is no reason, why the same should not be done for Associate Professors in Government Medical Colleges, when the same G.R is applicable to both set of teachers."

In view of the interpretation made by the б. Division Bench of the aforesaid circular, there remains no doubt that the applicant is entitled for the Grade Pay as has been claimed by him. The Division Bench has elaborately dealt with the intention behind issuance of the said G.R. It is submitted by learned counsel for the applicant that the decision in the aforesaid OAs has not been challenged by the State before the Hon'ble High Court. Learned counsel further submitted that on the contrary the Government has executed the orders passed in O.A. No. 829/2015 with O.A. No. 830/2015. In view of the fact as aforesaid, the Government cannot take any contrary view in the matter of present applicant. In the circumstances, I see no substance in the objections as are raised by the respondents in their affidavit in reply, as well as, in their arguments."

8. As has been submitted by the learned counsel for the applicants, common judgment delivered in O.A. No. 829/2015 with O.A. NO. 830/2015 has not been challenged before any higher forum meaning thereby that the said judgment had attained the finality. In premise of the facts as aforesaid, I see no difficulty in allowing both these applications for the same reasons recorded in O.A. No. 651/2021, relevant portion of which is reproduced hereinabove.

9. In view of the facts as aforesaid, the present Original Applications are allowed in terms of prayer clause (B) in respective applications. No order as to costs.

3. Learned CPO has sought time to file reply to the present M.A. Learned CPO submitted that respondents are yet to file their affidavit in reply to the O.A. also. Learned CPO submitted that the

applicants have unnecessarily filed the present application when the said process will be taking some time during which entire O.A. can be finally heard and disposed of. Learned CPO submitted that within two weeks the affidavit in reply will be filed by the respondents and the respondents may not have any objection to take the matter for hearing immediately thereafter.

4. Learned CPO further pointed out that yet the result of the written examination is not declared. After the result is declared, successful candidates will be required to appear for practical test and then the interviews will be taken and only thereafter the list of the candidates to be promoted will be declared. Learned CPO submitted that within the time which is likely to be consumed for completing all such processes, the present O.A. would be disposed of. Learned CPO in the circumstances has prayed for rejecting the present application. Learned CPO further submitted that otherwise also the Tribunal has sufficiently protected the interest of the present applicants by making promotion orders, if made, subject to outcome of the present O.A. and

in view of that no further order requires to be passed.

5. Grievance of the applicant is that the respondents have unreasonably enlarged the scope of feeder cadre by allowing several such officers who having regard to the existing rules cannot be permitted to compete for the post of Police Sub Inspectors. Some such names are pointed out by the learned Counsel.

6. After having heard learned Counsel for the applicant and the learned CPO, it appears to me that unless the explanation and authentic information comes on record through respondents as about the contentions raised in the O.A., the Tribunal may not be in a position to arrive at any concrete conclusion.

7. Learned CPO has undertaken to file the affidavit in reply within 2 weeks from today. Time is granted to file the affidavit in reply in M.A. as well as the O.A. till 26-10-2023. If the time is required for filing the rejoinder etc. by the applicant, it may be granted for 1 or 2 days and not more than that.

2.having heard the After present Original Application for some time, it is transpired that the relevant documents are required to be there on record. It is the contention of the applicants that they have been working with respondent no. 3 and respondent no. 4 for the period of more than 10 years and in each year they have rendered services for 240 days and, as such, they are entitled for regularization of their services. Learned counsel for the applicants pointed out that similarly situated workers working at J.J. 336 Hospital were regularized by G.R. dated 17.12.22015. Learned counsel further pointed out that remaining workers working in J.J. Hospital having worked for more than 10 years have approached the principal Bench

of this Tribunal at Mumbai by filing O.A. No. 756/2020 and the Tribunal has passed order on 14.2.2022 in their favour thereby directing the respondents therein to regularize the services of said applicants.

3. In the present matter the respondents have come out with a defense that none of the applicants have worked for 240 days in each year and are not complying with the criteria. However, no record is produced by the respondents of the services rendered by the present applicants. When respondents have taken a defense that none of the applicants have worked for 240 days in each year, the respondents must be possessing such record with them and on the basis of said record said statement is made. The applicants cannot be expected to have such record.

4. In view of above, I direct respondent nos. 3 & 4 to produce the data in regard to the services rendered by the applicants during the period from 1995 onwards. Learned counsel pointed out that dates of entry in service of the applicants are

different starting from year 1995. Respondents shall produce the record in that regard by the next date.
