2. Learned counsel for applicant the on instructions submits that so far as special allowances with regard to the Morning Courts are concerned, the respondent No. 1 has already sanctioned the said special allowances for the Morning Courts to the members of applicants association and also paid to them. Learned counsel submits that in view of the same, the applicants association do not want to press the prayer clause 12(A) to the extent of Morning Courts.

3. I have heard both the parties for some time.

4. Learned counsel for the applicant submits that in terms of Notification dated 19.10.2010 particularly Rule 5(b), "the Director of Prosecution

shall appoint as many Assistant Public Prosecutors as may be required to conduct the cases before the Morning Court, who shall be entitled to get twenty percent of their basic pay in addition to their officiating pay". Learned counsel submits that subclause (b) is not in the Maharashtra Evening Courts Rules, 2009. Learned counsel has pointed out that in terms of clause 8 of the said Maharashtra Evening Rules, 2009, "when the serving Judicial Officers are appointed to preside over the Evening Courts, they shall be paid twenty percent of the Basic Pay plus Dearness Pay plus Dearness Allowances in existing scale or twenty percent of basic pay in revised scale as per Sixth Pay Commission as the Special Allowances.". So far as retired Judge if appointed as Evening Curt Judge shall be entitled to an allowances / honorarium as my be specified by the Government by order. Further in the same clause (8) it is also stated that every member of the staff appointed in the Evening Courts shall receive twenty percent of his Basic Pay plus Dearness Pay as a Special Allowances with the Dearness Allowance in unrevised scale or twenty per cent of basic pay in scale revised as per Sixth Pay Commission and every

member of the staff who is the retired person if appointed as a Member of the Evening Court shall be entitled to allowances / honorarium as may be specified by the Government by order. However, there corresponding provision is no in the Maharashtra Evening Courts Rules, 2009 as per the Maharashtra Morning Courts Rules, 2010 for the Assistant Public Prosecutors (Members of the applicant Association).

5. In this context, learned counsel for the applicant is requested to take specific instructions from the applicants Association as to whether the APPs who has worked in the Morning Courts also directed to work in the Evening Courts.

6. Learned Presenting Officer is hereby directed to take instructions from the concerned respondent/s as to whether working Judges or the retiring Judges assigned with the Morning Courts work were also assigned with the duties in the Evening Courts and so also the staff members and if so, whether they have been paid the special allowances for working in both the Courts.
