- 2. Ld. Advocate for the applicant states that the appellate authority has issued the impugned order dated 7.3.2014 (Exhibit R-1 page 16-17) without affording opportunity of personal hearing.
- 3. Ld. PO states that the applicant was given occasion to submit his explanation in writing on 3 occasions, which he did not do so. Therefore, Ld. PO states that she opposes giving personal hearing to the applicant.
- 4. Ld. Advocate for the applicant submits that the applicant is ready to give explanation in writing as well as appear in person before the competent authority. Ld. Advocate for the applicant relies on the head note of the judgment & order of the Hon'ble Bombay High Court, Aurangabad Bench in Anil Amrut Atre Vs. District & Sessions Judge, Aurangabad, 2002(3) Mh.L.J.750, which reads as follows:

"Rule 23(2) of the Maharashtra Civil Services (Discipline and Appeal) Rules, 1979 mandates the Appellate Authority to consider whether the provision of the Rule has been followed. The expression "consider" in rule 23(2) will include within its sweep application of mind, personal hearing and recording of reasons. It is obligatory on the Appellate Authority to apply its mind and to pass an appropriate order speaking order after affording personal hearing to the delinquent."

5. The impugned order appears to be issued without hearing the applicant in person and the same is set aside. The respondent no.2 is directed to accept written submissions of the applicant, call him for personal hearing and decide his case on merits. The compliance should be communicated in 3 months. The applicant is at liberty to raise any issue, if required. The competent authority is therefore, directed to modify the order suitably on merits. OA disposed off accordingly.
