Indeed, Hon'ble Supreme Court by order dated 10.01.2022 passed in Suo Moto Writ Petition (Civil) No.03/2020 directed that were limitation would have expired during the period between 15.03.2020 till 28.02.2022, notwithstanding the actual balance period of limitation remaining, all person shall have a limitation period of 90 days from 01.03.2022 in view of COVID-19 Pandemic situation, as such, This O.A. ought to have been filed upto 01.06.2022. However, it is filed on 25.07.2022, thus delay is of hardly two months and not eight months. The Applicant is retired Government servant.
- 5. In view of above, I am inclined to condone delay. M.A. is accordingly allowed with no order as to costs.
