2. When the present matter is taken up for consideration and after we heard the arguments advanced by the learned counsel for the applicant and the learned Presenting Officer for the respondents for some time, it appears that the present matter has become infructuous. The main prayer of the applicant is that the new Recruitment Rules published by the Government vide Notification dated 27.2.2021 shall not be made applicable to the recruitment process which has been initiated pursuant to the advertisement dated 21.2.2019.

3. In para 4 of the affidavit in reply filed by the respondents it has been clarified by the respondents that the State Government is not intending to apply the new Recruitment Rules of 2021 to the process which has already been started in the year 2019.

4. In Original Application No. 1133/2018 filed at the principal seat of this Tribunal at Mumbai interim relief was granted thereby restraining the respondents from carrying

out the recruitment process so far as Tutor post is concerned. The learned counsel has placed on record the final order passed in that O.A. It is taken on record. The said O.A. has been dismissed by the principal seat of this Tribunal vide order passed on 6.6.2022. Since the said O.A. has been dismissed, the interim relief granted therein has become inoperative. Therefore the respondents must have carried the recruitment process further and by this time it must have been completed. However, it is submitted that the process is still going on. We, therefore, direct the respondents to complete the said process in all respect within 4 weeks from today.

2. Since common issues are raised, we have heard all these matters together and we deem it appropriate to pass the common order in all these matters.

3. Learned Counsel appearing for the respective applicants brought to our notice that in the similar set of facts and circumstances, this Tribunal has granted relief earlier in some of the matters thereby directing the Maharashtra Public Service Commission (MPSC) to call the applicants therein for interview subject to outcome of the said O.As.

4. As has been argued by the learned Counsel, the applicants in the O.A.NO.787/22, 788/22, 796/22, 803/22 have applied for the subject of Pathology and applicant in O.A.NO.804/22 has applied for the subject of Physiology. It is the common contention that for both the aforesaid subjects as per the guidelines received from Medical Council of India one year's experience of working on the post of Senior Resident may not be mandatory. Learned Counsel therefore submitted that the pre-condition to have

one year's experience of working on the post of Senior Resident cannot be pressed in the present matters by the respondents. Learned Counsel for the applicants have therefore prayed for interim relief directing the respondents to call the present applicants also for interviews and consider their candidature for appointment on the subject posts.

5. Learned CPO has sought time for filing affidavit in reply.

6. Since the interviews are scheduled in near future, the request of the applicant for interim relief needs to be considered. From the documents filed on record there appears prima facie case in favour of the applicants. Moreover, in the similar matters this Tribunal has earlier granted interim relief as has been prayed in the present matters. We, therefore, deem it appropriate to pass the following order:

ORDER

(i) Respondent MPSC is directed to call the present applicants also for interview and keep the result of the said candidates in sealed cover. In the meanwhile if any appointments are made to the posts of Assistant Professor in the subject of Pathology & Physiology, the same shall be subject to outcome of the present O.As.

(ii) In the meanwhile, issue notices to the respondents, returnable on 28-09-2022.

(iii) Tribunal may take the case for final disposal at this stage and a separate notice for final disposal shall not be issued.

(iv) Applicants are authorized and directed to serve on Respondents intimation / notice of date of hearing duly authenticated by Registry, along with complete paper book of case. Respondents are put to notice that the case would

The applicant is holding the qualification of Diploma in Civil Engineering and was appointed against the post earmarked for the candidate suffering disability, as the applicant suffers 40% disability on account of Cerebral Palsy and partial hearing impairment. Learned counsel for the applicant submitted that in the seniority list prepared by respondent No. 1 however, the correct information was not mentioned insofar as the nature of disability of the applicant is concerned. Learned counsel pointed out that in the seniority list it was mentioned that he belongs to the category of person with locomotor disability. Learned counsel submitted that on the very next date of publishing the seniority list the applicant made a representation to the respondents seeking correction in the nature of disability of the applicant as mentioned in the seniority list. Learned counsel submitted that the contention of the applicant has

been accepted and the necessary correction has now been effected. Learned counsel further submitted that in the meantime the promotions were effected and though there were three posts reserved for the persons with disability falling in the category of (d) & (e) as mentioned in Disability Act, 2016 and though the applicant was falling in the said category he was not considered for the promotion. Learned counsel submits that now again the process for promotion has commenced. The applicant has, therefore, approached the Tribunal claiming the following reliefs: -

“A) The Original Application may kindly be allowed.

B) Non-consideration of the claim of the applicant for promotion to the cadre of Sub-Divisional Officer from amongst the Junior Engineers against the earmarked vacancies for persons with Disabilities may kindly be held and declared unjust and illegal, being contrary to the statutory provisions and Govt. Resolutions issued in that behalf.

C) The respondents may kindly be directed to consider the claim of the applicant for promotion and also for grant of a deemed date of promotion to the cadre of Sub-Divisional Officer w.e.f. 3.12.2021 to which he has unjustly been deprived by not adhering to the roaster.

D) Pending hearing and disposal of this O.A., the respondents may kindly not to take up further process of promotion to the cadre of Sub-Divisional Officer, unless the claim of the applicant is considered in terms of Roaster for Persons with Disabilities.

3. Learned counsel has prayed for interim relief restraining the respondents not take up further process for promotion to the cadre of Sub-Divisional Officer, unless the claim of the applicant is considered in terms of Roaster for Persons with Disabilities.

4. Learned Chief Presenting Officer has sought time for filing affidavit in reply, since he does not have any instructions from the respondents. It is further submitted by the learned C.P.O. that it cannot be feasible to stay the entire process for promotion. If the Court/Tribunal reaches to the conclusion that *prima facie* case is made out by the applicant to the extent of the applicant adequate relief may be granted. During the course of the arguments to the query made by us, learned counsel submitted that in the previous process of promotion three posts were reserved for the (d) & (e) category for disability persons, however, only two posts were filled in. Learned counsel submitted that had the nature of disability been correctly mentioned for the present applicant perhaps he would also have been considered and promoted.

5. After having considered the submissions advanced by both the parties and after having considered the documents, it appears to us that there is no such information placed on record, in support of contention of the applicant that backlog of the person with disability falling in the category of (d) & (e) is existing for the present process of promotion. It was further asked by us to the learned counsel whether

any senior to the applicant was left out in the previous process of promotion, learned counsel submits that according to the instruction received by him no such senior has been left out. In the circumstances, it appears to us that most likely case of the applicant may be eligible to be considered in the process, which has been now commenced for the promotion. However, taking care of apprehension in the mind of the applicant we direct the respondents to ensure that if the applicant is possessing seniority in the category of persons having disability of (d) & (e) nature, his claim also be considered while effecting further promotions.

6. Respondents may also finalize names in zone of consideration for promotions for person with disability taking into account vacancy positions in each class of personal disability including the number of vacancies carried forward in the form of backlog, if any.

7. We direct the learned Chief Presenting Officer to clarify whether the respondents are following the process for effecting the promotions as per the proportion made for the physically disable candidates separately or as per the general seniority list.

8. Issue notice to the respondents, returnable on 10.10.2022.

9. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

10. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

11. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
