I have perused the record and proceedings and heard Shri V.V. Joshi, the learned *A* avocate for the applicants and Ms S. Suryawanshi, he learned P.O. for the respondents.

The learned P.O. sought further ime to file affidavit-in-reply. That request was to ned down because sufficient opportunity was alrea by given but more importantly it was because of the facts such as they are. The learned P.O. even v ithout the reply strongly opposes the M.A. conten ling inter-alia that the delay was inexcusable.

The O.A. was brought by two applicants essentially for deemed date. Both of them are retired ASIs. The details have been furnissed as to how this Tribunal itself in the case of similarly placed applicants in O.A. No.1215/2013, Shri Jagdish T. Andhale & 8 Ors V/s. State of M tharashtra & 2 Ors and some other O.A.s, granted relief as indicated in the common order date 14,7.2014. The State brought R.A. No.23/2014 which came to be dismissed by an order of 1.9.20.4 by the Second Division Bench of which I was also to Member.

There are other facts mention ed in the M.A. to infact show as to how the applicar ts were initially promoted and then reverted again and as to how they had conducted themselves in the matter. In fact there is a distinct aspect of the matter which if probed will even require consideration of the fact at issue that there may not be any delay at all. However, even if I were to proceed on the be sis that the delay was there, the issue still survives as to whether a case is made out for condonatin hereof. In the context of a factual situation such as it is which has been summarized above, I ar of the opinion that the applicant cannot be assi led of a conduct which could be described as SO contumacious as to forfeit the rights to claim judicial. ndulgence. The legal position in th s branch of law avors an approach which is liberal 1 ather than rigid and justice oriented rather than tech lical.

In that view of the matter, herefore, in my view a case is made out for condonat on of delay. The delay is, therefore, condoned. The applicants and the office are directed to process the O.A. so as to place it before the bench for decision according to law.

The Misc. Application is allowed with no order as to cost.


