The Original Application has been filed by the applicant challenging the impugned order of transfer dated 9.12.2022 (Annexure 'A-4') issued by respondent No. 1, thereby transferring the applicant from the post of Deputy Director, Town Planning, Development Plan, Special Unit, Aurangabad Municipal Corporation to the post of Deputy Director, Town Planning, Maitri Kaksha, Maharashtra Rajya Laghu Udyog Vikas Mahamandal, Mumbai, on vacant post. The applicant is seeking interim stay to execution and implementation of the said order.

3. Respondent No. 1 has filed CAVEAT. In view of that learned Chief Presenting Officer seeks time for filing affidavit in reply and producing relevant documents on record. He further submitted that the applicant has been relieved from his present post. The copy of relieving order dated 9.12.2022 (Annexure 'A-6') is produced on record by the applicant himself.

4. Learned counsel for the applicant however, submitted that the applicant is holding the responsible post of Deputy Director, Town Planning, Development Plan, Special Unit, Aurangabad Municipal Corporation and he is the head of the said special unit. There is no mention of handing over the charge by the applicant to anybody. Moreover, nobody is placed or posted in his place at Aurangabad. In the circumstances, the applicant has not handed over the charge of his post to anybody.

5. Learned counsel for the applicant further submitted that the applicant apprehends that the respondents may try to bring the case of the applicant under second proviso to Sub-rule (1) of Rule 36 of the Maharashtra Civil Services (Joining Time, Foreign Service and Payments During Suspension, Dismissal and Removal) Rules, 1981, which provision is as under: -

36. Transfer to foreign service not permissible without consent.- (1) No Government servant may be transferred to foreign service against his will :

Provided that, -- --

Provided further that this sub-rule shall not apply to the transfer of a Government servant recruited in service on or after 30th July, 1977 to the service of a body incorporated or not, which is wholly or substantially owned or controlled by Government.

6. As on today, according to the applicant, no requisite sanction order for transfer is served upon the applicant issued by the Government as contemplated under Rule 40 (1) of the Maharashtra Civil Services (Joining Time, Foreign Service and Payments During Suspension, Dismissal and Removal) Rules, 1981 before his transfer to foreign service as per the impugned order.

7. Upon enquiry in respect of handing over the charge, learned C.P.O. is unable to respond in spite of Caveat on record. In view of the same, learned counsel for the applicant apprehends that the respondents may create some back dated documents as regards handing over the charge. Learned C.P.O. to take note of the said submission.

8. As there is Caveat on record, in my opinion, it would be just and proper to grant reasonable time to the respondents to file affidavit in reply, if any and to place on record requisite documents at least on or before next date. In the facts and circumstances, the prayer for interim relief is kept open and will be considered on the next date.
