Learned counsel submits that it appears that in order to show compliance of the same, the applicant was kept on that post for a short period of

2. When the present matter is taken up for consideration, learned counsel seeks leave of this Tribunal to place on record the missing documents, which are mentioned in the list of documents, but inadvertently remained to be filed. Exhibit A-1 to A-3 are such documents. The applicants are permitted to place those documents on record.

3. The grievance of the applicants is that though seniority list of the officers in the cadre of Executive Engineers has not yet been finalized, the haste is being made of issuing the orders of promotions to the post of Superintending Engineer and the information for that purpose has been sought by the respondents. It is the further contention of the applicants that officers, whose information has been sought leading to inference that they are the persons likely to be considered for their

promotions, are junior to the present applicants. Learned counsel submitted that when the provisional seniority list was published the applicants have raised such objections and these objections are yet to be decided and final seniority list is yet to be published. Learned counsel further submitted that in such circumstances unless the final seniority list is published the promotions cannot be effected. Learned counsel sought to contend that the candidates who are likely to be promoted and more particularly respondent Nos. 4 to 17 who are likely to be promoted are junior to the present applicants. It is contended that their fortuitous service is also counted while reckoning their seniority, which is impermissible. Learned counsel submits that in the circumstances, while issuing the notices to the respondents, the respondents be restrained from issuing the promotion orders in favour of respondent Nos. 4 to 17 till decision of the present O.A.

4. Shri V.R. Bhumkar, learned Presenting Officer has opposed for grant of any such relief. It is submitted that the apprehension in the mind of the applicants is misplaced. Though the matter is in process it is the contention made by the learned Presenting Officer that provisional seniority list will be finalized. It is further contended that it has not been finalized because of some

pendency of the litigation before the Hon'ble Apex Court. Learned Presenting Officer submits that there is no likelihood of denying or rejecting the claim of the applicants if they are really senior. Learned Presenting Officer submits that in such circumstances and more particularly without giving opportunity to these respondents and even to the private respondents to make their submissions it would be unjust and improper to grant any such relief.

5. We have duly considered the submissions made on behalf of the applicants and the State authorities. Learned counsel for the applicants has tendered across the bar communication dated 9th February, 2024 which reveals that the information has been sought by the department for the purpose of effecting promotions to the post of Superintending Engineer. There appears substance in the contention made on behalf of the applicants that unless the objections raised by them are decided, respondent Nos. 4 to 17 cannot be promoted to the post of Superintending Engineer.

6. From the documents filed on record it was sought to be submitted by learned counsel that these documents sufficiently demonstrate that in the seniority list the present applicants are likely to be placed above

respondent Nos. 4 to 17. Though the learned P.O. has submitted that unless objections are decided and the final seniority list is published promotions are not likely to be issued, the document dated 9th February, 2024, which is tendered today by the learned counsel during the course of his arguments reveal circumstances otherwise and as we have noted above the information has been called of these officers by expressly mentioning that the information is being sought for the purpose of effecting promotions to the post of Superintending Engineer. In the circumstances, we deem it appropriate to pass the following order: -

ORDER

(i) Issue notice to the respondents, returnable on 03.04.2024. **By way of ad-interim relief till then the respondents shall not take final decision as about the promotions to be granted to respondent Nos. 4 to 17.
