The said committee has submitted the report and on the basis of the said report a show cause notice has been served upon the applicant calling her to show cause as to why her appointment shall not be cancelled for not possessing the valid experience as prescribed in the advertisement. The applicant had replied the said notice on 12.03.2024. However, till this date no further action seems to have been taken and nothing is communicated to the applicant. In the circumstances, the applicant has approached this Tribunal claiming the following reliefs:-

“A) To hold and declare that, the applicant has been rightly appointed on the post of Deputy Director Industrial Safety & Health, Group-A as per merit.

B) To quash and set aside the letter dated 28/02/2024 issued by the respondent No. 1.

D) Any other relief deems fit and proper may please be granted in favour of the applicant.

INTERIM RELIEF

A) Pending hearing and final disposal of this original application, the respondent no. 1 may kindly be directed to issue appointment order to the applicant on the post of Deputy Director Industrial Safety & Health, Group-A.

B) Any other relief deems fit and proper may please be granted in favour of the applicant.”

3. Learned counsel for the applicant submitted that the applicant is holding the requisite experience as prescribed in the advertisement and he has invited our attention to the documents placed on record in regard to the experience possessed by the applicant. Learned counsel submitted that the documents explicitly reveal that the applicant is holding the experience as required for the said post. Learned counsel further submitted that the applicant is now apprehending that in her place some other candidate may be posted and hence learned counsel has prayed for interim relief thereby directing the respondents not to fill up the post reserved for SC female candidate till decision of the present Original Application.

4. Learned Chief Presenting Officer has opposed for grant of any such relief. At the first instance, learned Chief Presenting Officer has sought time to file affidavit in reply. Learned Chief Presenting Officer submitted that one Original Application has been filed before the Nagpur Bench of this Tribunal concerning to the said advertisement and in the said O.A. directions were issued by the Nagpur Bench to the respondents therein

for producing on record the report of the committee which investigated the experience certificates of the candidates concerned.
