2. By filing accompanying O.As. the applicants had sought quashment of the communication dated 2.2.2009 and consequential order dated 11.12.2019. Prayer has also been made for re-fixation of the pay of the applicants by granting benefit of 03 non

compoundable increments and higher grade pay on the basis of the Government Resolution dated 10.11.2009 w.e.f. 4.2.2010.

- 3. Though in the Misc. Applications the delay is stated to be only of 116 days, however, it appears to be much more than that. Insofar as prayer clause (B) in the O.As. is concerned the delay appears to be more than 6 to 7 years. Insofar as prayer clause (A) is concerned, it appears to me that there is delay of 2 to 2 ½ years.
- 4. The learned counsel for the applicants submits that relief sought in the O.As. is a continuous cause of action. The applicants are still in service, the delay may be condoned in the interest of justice.
- 5. The respondents have opposed for condoning the delay stating that the same has not been appropriately calculated. Learned Presenting Officer submits that the applicants have not made out any case or any cause to condone the delay. Learned P.O. further submitted that in absence of any cogent and justifiable reason the delay cannot be condoned. Learned P.O. submitted that because of inaction and laches on part of the applicants in approaching the Tribunal and for not citing any such reason for

condoning the delay, the Misc. Applications are to be rejected.

6. I have considered the submissions made on behalf of the parties. From the prayers in the O.As., there may not be any dispute about the fact that the applicants are seeking some benefits in regard to the salary payable to them and the increments for which they claim their entitlement. Insofar as fixation and re-fixation of pay with increments is concerned, it has to be stated that there always remain a continuous cause of action, though it is advisable that the candidate should approach the Tribunal within the period of limitation. Therefore, O.As. cannot be kept out of consideration only for the reason of delay. In the circumstances, I am inclined to allow the present Misc. Applications. Hence, I pass the following order:-

### ORDER

- 1. Delay caused in filing accompanying O.As. condoned.
- 2. Misc. Applications stand disposed of with no order as to costs.
- 3. Accompanying O.As. be registered according to law.

- 4. After registration of O.As., issue notice to the respondents, returnable on 28.11.2023.
- 5. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- 6. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- 7. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
- 8. The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.
