2. It appears that the present applicant is not promoted from D category to the post of Junior Clerk in C category as respondent nos. 5 to 7 were senior to him.

The issue involved in the present O.A. is as to whether employees of Class – D category can be promoted to Class – C category in the different cadres once they have given option for specific cadre in Class – C category. The Circular dtd. 10.12.1990 (Annex. A. 5 page 37) would show that once option is given for promotion to a particular cadre Class-C category, the same cannot be changed. The present applicant avers that the concerned respondent has accordingly refused to consider the names of S/shri Rameshwar Dhanwade and Arun Janardhan Bhandare in the meeting of the Departmental Promotion Committee dtd. 20.9.2016 (Annex. A.9 page 57) as they have

earlier given option for of Laboratory Assistant and, therefore, they could not be considered for the post of Junior Clerk. The copies of their options are filed at pages 42 & 43 of the O.A.

3. However, so far as the res. no. 5 to 7 are concerned, their option letters at pages 39 to 41 of O.A. would show that they have earlier opted for promotion to the post of Laboratory Assistants, but they were, in fact, considered and promoted to the post of Junior Clerk. Thus, it appears that the respondents applied different standards as regards the same category candidates.

4. In the affidavit in reply (page 67) filed by Dr. Bhaskar Shankarrao Khaire, Professor (Ophthalmology), in the office of the Dean, S.R.T.R. Government Medical College, Ambajogai, Dist. Beed at para 12 it is averred as under :-

“12. As regards to the contents of Para No. VI (11) of Original Application, I say and submit that as Mr. Dhanwade and Mr. Bhandare have not given to options for the promotion to the post of Clerk cum Typist hence their names were not considered for in the list of candidates to be promoted to the post of Clerk cum Typist.”

5. However, as against this submission that these 2 employees did not give any option for the post of Clerk cum Typist, in rejoinder (pages 111 and 113) we have

copies of affidavit which show that option is given by these 2 employees dtd. 30.6.2016.

6. In the circumstances, Dr. Bhaskar Shankarrao Khaire, Professor (Ophthalmology), in the office of the Dean, S.R.T.R. Government Medical College, Ambajogai, if in employment by this time, shall explain regarding this anomaly by filing additional affidavit in reply. In case said Dr. Bhaskar Shankarrao Khaire is superannuated in the meantime, the Dean of S.R.T.R. Government Medical College, Ambajogai (res. no. 3) shall file additional affidavit in reply on the above line by the next date.
