2. Applicant is resident of Village Karwadi, Post Pardi, Tq. Ardhapur, which falls in Sajja Pardi. The recruitment is being carried out for the post of Kotwal in Taluka Ardhapur for Talathi Sajja Dabhad, Loni (B), Pardi (M), Mendhla (B) and Malegaon. Advertisement is published on 02-09-2023. In the said advertisement one of the clauses mandates that the candidate applying to the post of Kotwal must be the resident of the Sajja for which he is applying. Learned Counsel for the applicant submitted that the condition so incorporated in the contrary to Rules advertisement is the for Recruitment and Employment of Kotwals, 1959 ("Rules of 1959" for short). Learned Counsel

submitted that Recruitment Rules, more particularly, Rule 10 thereof provides that the candidate concerned must be having complete knowledge and information of the Sajja concerned and he must be ready and willing to reside in any of the villages in the said Talathi Sajja during the course of his appointment as Kotwal of the said Sajja.

3. Learned Counsel submitted that post of Kotwal in Pardi Sajja is shown to be reserved for Scheduled Tribe (ST) [General]. Learned Counsel submitted that since the applicant does not belong to ST category and belongs to Nomadic Tribes-C [NT (C)] category, though he is the resident of the said village he cannot apply for the post of Kotwal. Learned Counsel further submitted that post of Kotwal for Sajja Mendhla (B) is, however, reserved for candidates belonging to NT(C) category. Applicant, in the circumstances, has prayed for direction by way of interim relief against the respondents to allow the applicant to apply for the post of Kotwal for Sajja Mendhla (B). Learned Counsel submitted that the applicant is ready to submit an undertaking as required to reside at Sajja Mendhla (B) if he is selected and appointed as Kotwal of the said Sajja.

- 4. Learned P.O. has opposed the submissions made on behalf of the applicant. It is submitted that the condition so incorporated cannot be said to be contrary to the Recruitment Rules of 1959. Learned P.O. submitted that even otherwise the person to be appointed as Kotwal is expected to be having complete knowledge of villages in the Sajja and he must be ready to reside in the said village during the period of his appointment as Kotwal. Learned P.O. submits that both the aforesaid conditions can be fulfilled only if the applicant is resident of the said Sajja. As such, said condition has been incorporated in the impugned advertisement and it cannot be said to be in breach of the Recruitment Rules of 1959 or contrary to the same. She has, therefore, prayed for rejecting the request of the applicant for interim relief.
- 5. I have carefully gone through the Recruitment Rules of 1959 and the advertisement dated 02-09-2023. Apparently, condition as has been included in the advertisement requiring the candidate

concerned to be resident of the same Sajja for which he is making an application appears contrary to the provisions under Recruitment the Rules. Recruitment Rules provide that the person concerned must be resident of the said Taluka and must be having knowledge of the Sajja for which he is seeking his appointment as Kotwal and after his appointment he must be ready to reside in the said village during his tenure as Kotwal.

- 6. As noted hereinabove, the applicant is ready to furnish an undertaking that he will reside in Sajja Mendhla (B) if he is selected and appointed as Kotwal of the said Sajja. Applicant has also submitted that he being the resident of the adjoining village, he is having complete knowledge and information of Sajja Mendhla (B).
- 7. Having regard to the submissions so made, it appears to me that *prima facie* case is certainly made out by the applicant to accept the alternative request made by him. The applicant is resident of Village Karwadi, Post Pardi, Tq. Ardhapur. As such, he can be permitted to apply for the post of Kotwal

for Sajja Mendhla (B), which is reserved for the candidates belonging to NT (C) category.

8. For the reasons stated above following order is passed:

Dharmabad, which falls in Sajja Shelgaon. recruitment is being carried out for the post of Kotwal in Taluka Dharmabad for Talathi Sajja Balapur, Vilegaon, Atala, Naygaon (D), Bellur (B) and Salegaon (D). Advertisement is published on 31-08-2023. In the said advertisement one of the clauses mandates that the candidate applying to the post of Kotwal must be the resident of the Sajja for which he is applying. Learned Counsel for the applicant submitted that the condition incorporated in the advertisement is contrary to the Rules for Recruitment and Employment of Kotwals, 1959 ("Rules of 1959" for short). Learned Counsel

submitted that Recruitment Rules, more particularly, Rule 10 thereof provides that the candidate concerned must be having complete knowledge and information of the Sajja concerned and he must be ready and willing to reside in any of the village in the said Talathi Sajja during the course of his appointment as Kotwal of the said Sajja.

Learned Counsel submits that the applicant 3. belongs to OBC category. Learned Counsel further submitted that post of Kotwal for Sajja Atala, though, is reserved for OBC, in view of the conditions incorporated in the advertisement he cannot apply for the said post since he is not resident of the said Sajja or any of the villages in the said Sajja. Learned Counsel in the circumstances has prayed for staying the effect and operation of the advertisement dated 31-08-2023 or in the alternative direction to the concerned authorities to accept the candidature of the applicant for Sajja Atala since he is resident of village Shelgaon where there is no vacancy of Kotwal. Applicant submits that he is complying with the eligibility criteria as provided in the Rules of 1959.

- 4. Learned P.O. has opposed the submissions made on behalf of the applicant. It is submitted that the condition so incorporated cannot be said to be contrary to the Recruitment Rules of 1959. Learned P.O. submitted that even otherwise the person to be appointed as Kotwal is expected to be having complete knowledge of villages in the Sajja and he must be ready to reside in the said village during the period of his appointment as Kotwal. Learned P.O. submits that both the aforesaid conditions can be fulfilled only if the applicant is resident of the said Sajja. As such, said condition the impugned has been incorporated in advertisement and it cannot be said to be in breach of the Recruitment Rules of 1959 or contrary to the same. She has, therefore, prayed for rejecting the request of the applicant for interim relief.
- 5. I have carefully gone through the Recruitment Rules of 1959 and the advertisement dated 02-09-2023. Apparently, condition as has been included

advertisement requiring the candidate concerned to be resident of the same Sajja for which he is making an application appears contrary to the provisions under the Recruitment Rules. Recruitment Rules provide that the person concerned must be resident of the said Taluka and must be having knowledge of the Sajja for which he is seeking his appointment as Kotwal and after his appointment he must be ready to reside in the said village during his tenure as Kotwal. Learned Counsel submits that the applicant will submit the necessary undertaking and he is ready to reside in village Atala if he is selected and appointed on the said post. It is further contended that the applicant being resident of village in same taluka, he is having complete knowledge of Sajja Atala.

6. Having considered the submissions made on behalf of the applicant and respondents, it appears to me that there is substance in the alternative prayer made by the applicant and it deserves to be accepted. In view of the fact that the applicant is resident of the same taluka, he is eligible to apply for the post of Kotwal for any of the villages falling in

the said taluka. Applicant is claiming to be belonging to OBC category, he therefore, can apply for the post of Kotwal for Sajja Atala which is reserved for the candidate belonging to OBC category. The applicant has thus made out a prima facie case for accepting his request to the aforesaid extent and the interim relief to that extent can be granted in his favour. Hence, the following order:

- [i] Issue notices to the respondents, returnable on 09-10-2023.
- [ii] Subject to outcome of the present O.A., Respondent nos.2 to 4 are directed not to reject the candidature of the applicant on the ground that he is not resident of Sajja Atala, if the applicant makes an application for the post of Kotwal for the said village, if he is otherwise complying with other eligibility conditions for the said appointment.

Heard Shri R.R. Shinde, learned counsel for the applicants and Shri V.R. Bhumkar, learned Presenting Officer for the respondent authorities.

- 2. Respondent No. 3 has issued an advertisement on 28.08.2023 inviting applications from the eligible candidates for various posts to be filled in the Public Health Department of the State of Maharashtra. One of the posts advertised is of 'Dietician'. In the advertisement for the post of dietician the qualification prescribed is degree of B.Sc. (Home Science) of statutory university. It is the grievance of the present applicants that as because they are holding the degree of B.Tech. (Food Science) of the Vasantrao Naik Marathwada Agriculture University, Parbnai, they are deprived of an opportunity of making an application for the said post.
- 3. Shri Shinde, learned counsel appearing for the applicants submitted that B.Tech. (Food Science) and B.Sc. (Home Science) are the equivalent degrees. Learned counsel submitted that the same issue was raised in one previous recruitment process and the

matter was referred to Vasantrao Naik Marathwada Agriculture University, Parbnai. Thereupon, Committee of experts was appointed and the said Committee has given a verdict that B.Tech. (Food Science) is equivalent to B.Sc. (Home Science). Learned counsel submitted that the degree, which was being conferred by the Agriculture University, Parbhani of B.Tech. in Food Science, nomenclature of the same has been changed and now it is known as B.Tech. (Food Technology). Learned counsel also pointed out that even in the Health Department of the State the appointments are made on the post of Dietician of the persons holding the degree of B.Tech. (Food Science). Learned counsel in the circumstances prayed for directions to respondents to allow the applicants to apply for the said post and to participate in the further selection process by way of interim relief. Learned counsel for the applicants submitted that last date for filling online application is 18.9.2023.

4. Learned Presenting Officer has opposed the contentions raised on behalf of the applicants. Learned PO submitted that the recruitment rules provide the qualification as degree of B.SC. (Home Science) of Statutory University and adhering to that qualification, the same qualification has been prescribed in the

advertisement. Learned PO further submitted that the applicants have not challenged the recruitment rules or have not come out with any prayer seeking declaration that degree of B.Tech in Food Science or Technology shall be held equivalent to the degree of B.Sc. (Home Science). Learned PO further submitted that now the entire process has been outsourced by the State Government and even scrutiny of the applications will be done by the Agency to which the process of recruitment has been Learned PO further submitted that the outsourced. appointment on which the applicants have relied upon was a temporary appointment and the same norms be applied cannot while making permanent It is further contended that the appointments. documents produced on record by the learned counsel for the applicants in supports of his contention that there is Government order to the effect that B.Sc. (Home Science) and B.Tech. (Food Technology) are equivalent degrees cannot be accepted for the reason that in the said order the equivalence was to be considered with the degree of B.Sc. (Agriculture) and in that context reference Learned P.O submitted that the said has come. Government order therefore may not be of much help to the present applicants. Learned PO submitted that now at the advanced stage of the recruitment process if the

request of the applicants is accepted, respondents may be required to even postpone the recruitment process and then all similarly placed candidates will have to be given an opportunity. For all these reasons, learned PO has opposed for granting interim relief.

- 5. I have duly considered the contentions made on behalf of the applicants and the State authorities. I have also perused the documents filed on record. It is not in dispute that in the Recruitment Rules for the post of Dietician the qualification prescribed is of the Degree of B.Sc. (Home Science) of any statutory University. It is thus evident that the qualification, which has been prescribed in the advertisement, is in tune with the Recruitment Rules.
- 6. Applicants have come out with the case that B.Tech. (Food Technology) or B.Tech. (Food Science) are the equivalent degrees to B.Sc. (Home Science) and as such, the candidates possessing the degree of B.Tech. (Food Science) are also required to be permitted to compete for the post advertised vide the aforesaid advertisement and cannot be deprived of an opportunity to participate in the selection process of the said recruitment.

- 7. Learned counsel has relied upon one Government order, as well as, opinion given by the Agriculture University, Parbhani in support of his contentions. It is true that the Government Order, prima-facie, supports the contention of the applicants and the opinion given by the expert committee, which has been reflected in the correspondence of Agriculture University also reveal that the degrees of B.Sc. (Home Science) and B.Tech. (Food Technology) both are equivalent degrees.
- 8. The question however, is whether the applicants possessing the degree of B.Tech (Food Science) can be permitted to compete for the post of Dietician when in the advertisement qualification prescribed for the said post is B.Sc. (Home Science). Had in the advertisement the qualification would have been prescribed as B.Sc. (Home Science) or the degree equivalent thereto, there could be some basis for considering the argument made on behalf of the applicants that the applicants cannot be deprived from competing the post of Dietician only on the ground that they do not possess the degree of B.Sc. (Home Science) and instead hold the degree of B.Tech. (Food Science). It is well settled that the question in regard to equivalence of educational qualification is technical question based on proper assessment and evaluation of the relevant academic standard and

practical attainment of such qualification. When the qualification has been prescribed as Degree of B.Sc. (Home Science) of statutory university that cannot be obliterated by allowing the candidates who do not have that qualification. Further it cannot be lost sight of that the last date of filling online application is 18.9.2023. As has been submitted on behalf of the respondents even the work of scrutiny of the applications has also been outsourced. According to the terms and conditions in the advertisement the Software is prepared for online scrutiny of the applications. To permit any change in the qualification prescribed in the advertisement would require consequential changes. Secondly, if the present applicants are allowed to participate in the selection process, the respondents will have to provide such opportunity to all other candidates possessing degree of B.Tch (Food Science) or Food Technology or any other degree equivant to B.Sc. (Home Science). This would inevitably result in delaying the selection process presently undertaken by the respondents.

9. Having considered all above circumstances, I am not inclined to grant the interim relief as has been prayed by the applicants. However, since the issue raised in the matter do deserve consideration, I deem it

appropriate to issue notice to the respondents in O.A. Hence the following order: -

### ORDER

- (i) Issue notice to respondents, returnable on 12.10.2023.

Nanded. Applicant is resident of village Malegaon, Tq. Ardhapur. It is the grievance of the applicant that for 02 reasons he has

been deprived from offering his candidature for the post of Kotwal as advertised, first that the condition has been imposed in the advertisement that a person seeking appointment must be resident of the said Sajja for which appointment is sought by him and other that Sajja of which the applicant is resident of, post is reserved for the category of EWS (Women) and as such he cannot apply for the said post.

4. In the Rules for the Recruitment and Employment of Kotwals, 1959 (for short Rules of 1959) there is no such eligibility criterion prescribed and only condition is that the candidate, who is seeking appointment as Kotwal, must be having knowledge and information about said village and he must be ready to reside at the said village during the period of his appointment. Learned counsel submitted that both the eligibility conditions prescribed in the advertisement are contrary to the rules and hence cannot be sustained. The learned therefore, staving counsel, praved for the implementation of the advertisement till decision of the O.A. In the alternative, learned counsel has

prayed that since the applicant is ready to reside in any village for which the applications are invited and he has knowledge of all those villages, he may be permitted to apply for the subject post for Sajja Dabhad.

5. Learned Chief Presenting Officer has opposed the submissions as are made by the learned counsel for the applicant. Insofar as the contention of the applicant that he cannot apply for the post for his own village, where he is residing since the post of Kotwal is reserved for the category EWS (Women) is concerned, learned C.P.O. submits that a conscious decision has been taken as per the reservation policy by the competent body as per the prescribed procedure. Learned C.P.O. submitted that insofar as the condition imposed that the person must be resident of same village also cannot be said to be contrary to the Recruitment Rules, 1959, since for all practical purposes the Committee, which was appointed for the said Taluka has taken a conscious decision and even otherwise the Recruitment Rules provide that the person concerned must have the knowledge of the said village and he shall be ready

to reside there. According to learned C.P.O., no interim relief, therefore, can be granted in the present matter.

I have duly considered the submissions made 6. by the learned counsel for the applicant and the learned C.P.O. for the respondent authorities. Insofar as the first contention of the applicant is concerned that since the post is reserved for EWS (Women) category, opportunity of the applicant is taken away, is against the constitutional provision and hence, cannot be entertained. According to reservation policy, the reservations are in advance fixed for the villages and challenge to the said decision cannot be raised before this Tribunal. Insofar as second aspect is concerned, there appears substance in the contention of the applicant. If the applicant is ready to reside in the village if he is appointed as Kotwal of said village and if he possesses knowledge of the said village, there may not be any impediment for making his application and seeking appointment on the said post. As has been submitted, the applicant can apply for the post of Kotwal for Sajja Dabhad since the said post is

reserved for S.C. category and the applicant belongs to that category. Moreover the applicant is ready to submit necessary undertaking that he will reside in the said village if he is appointed as Kotwal. Applicant has, thus, made out a prima-facie case for grant of interim relief to that extent. Hence, the following order:-

### ORDER

- (i) Issue notice to the respondents, returnable on 9.10.2023.
- (ii) Subject to outcome of the present O.A., Respondent nos. 2 to 4 are directed not to reject the candidature of the present applicant on the ground that he is not resident of Sajja Dabhad, if the applicant makes an application for the post of Kotwal for the said village, if he is otherwise complying with other eligibility conditions for the said appointment.
- (iii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- (iv) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper

book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

- (v) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
- (vi) The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.
- (vii) S.O. to 9.10.2023.

- 2. The O.A.No. 354/2023 is not on board. At the request of learned counsel it is taken on board.
- 3. Learned C.P.O. has submitted affidavit in reply on behalf of respondent Nos. 1,2 and 4 to 6 in O.A.No. 355/2023. The same is taken on record and copy thereof has been served on the learned counsel appearing for the applicants.
- 4. When the present matters are taken up for consideration, learned counsel for the applicants has prayed for disposing of the present matters finally by giving direction to the respondents to complete the enquiry in all respects within the time

bound period. Learned C.P.O. for the respondent consented for disposing of the matters finally.

- 5. After having considered the prayers made by the applicants as has been stated by the learned counsel for the applicants, during pendency of the Original Applications the enquiry has been completed and the enquiry report has been submitted and now the matters remain only to submit reply/say of the applicants to the report of enquiry and then the final decision is to be taken by the Disciplinary Authority.
- 6. Learned counsel for the applicants submits that though the petitions are filed for seeking quashment of the enquiry proceedings, in view of the fact that the enquiry has been completed in the meanwhile period, the applicants are now not intending to proceed with these applications and prayed that the directions be given to the respondents to complete the enquiry in all respects by stipulating some period therefore, the request is worth considering. The leaned C.P.O. has consented

for final disposal of matters. In view of the submissions made, the following order is passed.

### ORDER

- (i) Both the Original Applications stand disposed of.
- (ii) Respondents are directed to complete the Departmental Enquiry against the present applicants in all respects within four weeks from the date of this order. Needless to state that decision of the Disciplinary Authority can be subject matter for judicial scrutiny.

- 2. This is an application preferred by the applicants seeking leave to sue jointly.
- 3. For the reasons stated in the application, and since the cause and the prayers are identical and since the applicants have prayed for same relief, and to avoid the multiplicity, leave to sue jointly granted, subject to payment of court fee stamps, if not paid.
- 4. Accompanying O.A. be registered and numbered, after removal of office objections, if any. The present M.A. stands disposed of accordingly without any order as to costs.

### **ORAL ORDER:**

Heard Shri P.P Uttarwar, learned counsel for the applicants and Shri I.S. Thorat, learned Presenting Officer for the respondent authorities.

2. The dispute raised by the applicants is in respect of the recruitment on the post of Kotwal in Taluka of District Nanded for advertisement has been issued on 2.9.2023. Father of applicant no. 1 had worked on the post of Kotwal of village Raiwadi. He got retired on attaining the age of superannuation. Father of applicant no. 2 died while working as Kotwal, whereas father of applicant no. 3 had also worked on compassionate ground since his father i.e. grandfather of applicant no. 3 had worked as Kotwal. It is the grievance of the applicant no. 4 that village in which he is residing, post of Kotwal is reserved for S.C. and as such he cannot make an application for the said post.

- 3. Learned counsel for the applicants invited my attention to the advertisement published to submit that the advertisement as has been published is liable to be set aside on more than one grounds. Learned counsel submitted that the advertisement has been published in the newspaper, which does not have large circulation and as such the advertisement cannot be said to have received wide circulation.
- 4. It is the further contention of the learned counsel that the condition as has been imposed that the person to be appointed as Kotwal must be resident of the village to which his appointment will be made, is contrary to the Recruitment Rules of Kotwal, 1959 (for short the Recruitment Rules, 1959) and no such condition could have been imposed in the advertisement. In other Talukas advertisements, which have been published, are having some different conditions and there is no uniformity in the advertisements published at different Talukas. Learned counsel, in the for circumstances, praved staying the implementation of the advertisement dated 2.9.2023 till decision of the present Original Application.

- 5. Insofar as the contention as about preference in appointment on compassionate ground, the learned counsel has relied upon Government Resolution dated 20.5.2010. Learned counsel further submitted that since the posts are reserved for particular caste or tribe, the candidates not belonging to the said caste or tribe are deprived from making an application for the said post. Learned counsel submits that insofar as applicant no. 4 is concerned, the post is reserved for S.C. and the applicant no. 4 is not belonging to S.C. category and as such as per the advertisement he cannot submit his candidature for the post of Kotwal.
- 6. Learned Presenting Officer has opposed the submissions so made by the learned counsel for the applicants. Learned P.O. submitted that the G.R. on which reliance has been placed by the learned counsel is no more in existence and has been superseded by the subsequent G.R. dated 5.9.2013. Other grievance as has been raised on behalf of the applicants, learned P.O. submitted that the applicant no. 1 is resident of village Raywadi and he can very well apply for the post of Kotwal as

advertised for the said village. Learned P.O. submitted that in all Talukas the Rules have been duly followed with little variance in the procedure adopted by the said Taluka. Insofar as Loha Taluka is concerned, conscious decision has been taken by the Committee appointed for the said purpose to incorporate a condition that the person to be appointed must be resident of that Sajja. In a Sajja, there are 03 villages and the person aspiring for the post for the said villages may be resident of any of said 03 villages. So far as applicant no. 1 is concerned, he may not have any hurdle for applying Learned P.O. submitted that the the post. reservations are prescribed as per the settled norms and the Committee appointed for the said purpose DRAW has by adopting system prescribed reservation for the villages.

7. After having considered the submissions made on behalf of the applicants and the respondent authorities, it does not appear to me that any case is made out by the applicants for grant of interim relief as has been prayed by them. Relief insofar as appointment on compassionate ground is concerned,

which was on the basis of G.R. dated 20.05.2010, it has been submitted by learned P.O. that the said G.R. has been superseded by subsequent G.R. dated 05.09.2013. Insofar as condition as has been imposed in the advertisement that the candidate must be resident of particular village for which he is applying for the post, prima-facie, do not appear in consonance with the Recruitment Rules of 1959. Recruitment Rules provide that candidate concerned must have knowledge about the village and must be ready to reside in the said village. No other condition could have been imposed in the advertisement concerned.

8. Applicant No. 4 though submitted that he is deprived of making application for his village, but reason, as has been quoted by him is different i.e. the post is reserved for S.C. category. Reservations are prescribed as per the policy of reservation. The said policy decision cannot be a subject matter before the Tribunal. In the circumstances, I do not see any reason for accepting the request of the applicants for interim relief, thereby staying the effect and operation of the impugned advertisement.

Request for interim relief thus stands rejected. Hence, I pass the following order:-

### ORDER

- (i) Issue notice to the respondents, returnable on 9.10.2023.
- (ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.
- (iii) Applicants are authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.
- (iv) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
- (v) The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicants are directed to file affidavit of compliance and notice.
- (vi) S.O. to 9.10.2023.
- (vii) Steno copy and Hamdast is allowed to both parties.
