Learned Counsel submitted that even prior to issuance of the said G.R. and thereafter also the applicant had been pursuing the said claim with the Government and in those efforts the time was consumed and the applicants could not approach this Tribunal within the stipulated period of limitation. Learned Counsel submitted that the right accrued in favour of the applicants because of

the G.R. dated 07-10-2016 issued by the Government, the applicant cannot be deprived of the fruits of the said G.R. only on the ground that the applicants committed some delay in approaching this Tribunal. Learned Counsel has, therefore, prayed for condonation of delay which has occurred in filing accompanying O.As.

3. Learned P.O. has resisted the request so made. Learned P.O. has submitted that if the applications are perused there is no specific reason assigned in justification of the delay which has occasioned in approaching the Tribunal. According to the learned P.O. in absence of any such reason made out in the applications, the applications are liable to be rejected.

4. I have duly considered the submissions advanced by the learned Counsel for the applicant and the learned P.O. I have gone through the documents filed on record. Delay appears to be of a period more than 6 months. Perusal of the G.R. dated 07-10-2016 makes it clear that some benefits have been extended in favour of the Government employees like the present applicants. Whether the

applicants would be entitled for such benefits or not entitled only can be decided after hearing the O.A. However, merely on some technical grounds the request for condoning the delay which is not of longer period cannot be rejected. In such matters the delay deserves to be condoned, so that the applicants get an opportunity to prosecute their claim on merits. Hence, the following order:

- [ii] Delay caused in preferring the accompanying O.As. is condoned.

3. Learned counsel has placed reliance on the judgment of the Hon'ble Bombay High Court in the case of Dnyaneshwar S/o Ramkishan Musane Vs. the State of Maharashtra & Ors. (W.P. No. 6267/2018 decided on 11.3.2020). Learned counsel submitted that the aforesaid provision in the concerned Government Resolution has been disapproved and directed to be deleted by the Division Bench in the year 2019. Having regard to the facts involved in the present matter it apparently appears that the rejection of the request cannot be sustained. When the claim of applicant No. 2 was pending for consideration and in the meanwhile since son of applicant No. 2 i.e. applicant No. 1 became major and applied for substitution, in view of law laid down by the Bombay High Court in the aforesaid matter, the respondents could not have declined or reject the request of the applicant.

4. During pendency of the present O.A. applicant No. 2 was informed vide communication dated 15.6.2021 that since she has crossed the age of 45 years, her name has been removed from the list of candidates eligible to be appointed on compassionate ground on Class-IV post.

In the circumstances, it was the contention of the Presenting Officer that learned the prayer for substituting the name of applicant No. 1 in place of applicant No. 2 has become infructuous. Argument so made is liable to be rejected. The documents on record show that when the request for substituting the name of applicant No. 1 in place of applicant No. 2 was made, the name of applicant No. 2 was existing in the waiting list. In fact, in view of the judgment of the Hon'ble Bombay High Court in the case of Dnyaneshwar S/o Ramkishan Musane Vs. the State of Maharashtra & Ors. (cited supra), which came to be delivered on 11.3.2020, before removing the name of applicant No.2 from the waiting list of the candidates entitled for appointment on compassionate ground, the respondents must have allowed the application for substitution and must have substituted the name of applicant No. 1 in place of applicant No. 2. In the circumstances, though the respondents have removed the name of applicant No. 2 from the waiting list of the candidates eligible for compassionate appointment, merely on that ground the substitution cannot be rejected. The order of removing the name of applicant No. 2 from the waiting list has been passed after the judgment was delivered by the Hon'ble Bombay High Court in the case of Dnyaneshwar S/o Ramkishan Musane Vs. the State of Maharashtra &

2. The facts of the case are as under: -

The Government servant by name Shri Suresh Aasaram Khedkar died while in service on 7.10.2008. The wife of deceased employee i.e. applicant No. 2 viz. Nirmala wd/o Suresh Khedkar applied for appointment on compassionate ground within the stipulated period of one year. At the relevant time, applicant No. 1 was minor. The name of applicant No. 2 was included in the waiting list kept at the office of respondent No. 3 in the list of candidates eligible to be appointed on compassionate ground. In the meanwhile applicant No. 1 became major and hence request came to be made for substitution of his name in place of applicant No. 2 for the compassionate appointment. The said application has been rejected vide the impugned order dated

#### :: - 2 - :: O.A. NO. 77/2020

10.5.2019 on the ground that there is no provision in the G.R. dated 21.9.2017 for such substitution.

3. Learned counsel has placed reliance on the judgment of the Hon'ble Bombay High Court in the case of Dnyaneshwar S/o Ramkishan Musane Vs. the State of Maharashtra & Ors. (W.P. No. 6267/2018 decided on 11.3.2020). Learned counsel submitted that the aforesaid provision in the concerned Government Resolution has been disapproved and directed to be deleted by the Division Bench in the year 2019. Having regard to the facts involved in the present matter it apparently appears that the rejection of the request cannot be sustained. When the claim of applicant No. 2 was pending for consideration and in the meanwhile since son of applicant No. 2 i.e. applicant No. 1 became major and applied for substitution, in view of law laid down by the Bombay High Court in the aforesaid matter, the respondents could not have declined or reject the request of the applicant.

4. During pendency of the present O.A. applicant No. 2 was informed vide communication dated 15.6.2021 that since she has crossed the age of 45 years, her name has been removed from the list of candidates eligible to be appointed on compassionate ground on Class-IV post.

#### :: - 3 - :: O.A. NO. 77/2020

In the circumstances, it was the contention of the Presenting Officer that learned the prayer for substituting the name of applicant No. 1 in place of applicant No. 2 has become infructuous. Argument so made is liable to be rejected. The documents on record show that when the request for substituting the name of applicant No. 1 in place of applicant No. 2 was made, the name of applicant No. 2 was existing in the waiting list. In fact, in view of the judgment of the Hon'ble Bombay High Court in the case of Dnyaneshwar S/o Ramkishan Musane Vs. the State of Maharashtra & Ors. (cited supra), which came to be delivered on 11.3.2020, before removing the name of applicant No.2 from the waiting list of the candidates entitled for appointment on compassionate ground, the respondents must have allowed the application for substitution and must have substituted the name of applicant No. 1 in place of applicant No. 2. In the circumstances, though the respondents have removed the name of applicant No. 2 from the waiting list of the candidates eligible for compassionate appointment, merely on that ground the substitution cannot be rejected. The order of removing the name of applicant No. 2 from the waiting list has been passed after the judgment was delivered by the Hon'ble Bombay High Court in the case of Dnyaneshwar S/o Ramkishan Musane Vs. the State of Maharashtra &

Ors. (cited supra). For the reasons stated above the application deserves to be allowed. Hence, the following order: -

3. In this matter the respondents have not yet filed affidavit in reply. However, only for that reason the present matter cannot be kept pending. Factual aspect can be ascertained by the respondents before extending the relief for which the Tribunal is holding the applicant entitled.

4. The learned counsel has relied upon the judgment of the Hon'ble Division Bench of Hon'ble Bombay High Court, Bench at Aurangabad recently delivered on 12.10.2022 in the case of **Shri Ramesh**

Eknath Suryawanshi and Others Vs. the State of Maharashtra through its Chief Secretary and Others, WP No. 10272/2022, as well as, the judgments earlier delivered by this Tribunal at principal seat at Mumbai and by this Bench in support of his case and has prayed for allowing the application.

5. The learned Presenting Officer fairly conceded that the judgments relied upon by the learned counsel for the applicants are supporting the contentions raised and prayers made by the applicants. Learned P.O. submitted that the respondents will ascertain the facts and if applicant is found eligible the benefit will be extended to the applicant. The learned PO therefore submitted for passing appropriate orders.

6. It is not in dispute that the applicant has retired after attaining the age of superannuation on 30<sup>th</sup> June, 2021. It is also not disputed that the respondents have refused the request made by the applicant for grant of next increment, which fell due on the next day of his retirement.

7. I deem it appropriate to reproduce herein below para nos. 3 & 4 of the judgment delivered by the Hon'ble Bombay High Court, Bench at Aurangabad on 12.10.2022 in the case of **Shri Ramesh Eknath Suryawanshi and Others** (cited supra), which read thus :-

> "3. The issue raised is no longer res integra, having been concluded by the learned Division Bench of the Madras High Court, vide judgment dated 15.09.2017, in WPNo.15732/2017, filed by P.Ayyamperumal Vs. The Registrar, Central Administrative Tribunal and others, which judgment has been sustained by the Hon'ble Supreme Court, vide order dated 23.07.2018, in Special Leave Petition (Civil) Diary No.22283/2018. Even this Court has passed several orders granting such benefits, which have been sustained by the Hon'ble Supreme Court.

> 4. In view of the above, this petition is partly allowed. The petitioners are entitled to the notional addition of the last yearly increment for the purpose of calculating their pension, gratuity, earned leave, commutation benefits etc. In so far as arrears of the benefits are concerned, the petitioners would be entitled for the same for a period of three years, preceding the date of filing of this petition or as per actuals, whichever is less. Such arrears should be calculated and be paid to the petitioners, on or before 30.12.2022."

8. It will also be useful to refer to the discussion made by the principal seat of this Tribunal at Mumbai in the case of Shri Sadashiv Kashinath Inamke & Ors. Vs. the State of Maharashtra & Ors., O.A. No. 950/2019 with other OAs on 5.7.2022. Considering the earlier judgments on the issue the Tribunal has recorded following finding in para 15 of the said judgment, which reads thus :-

> "15. In view of the aforesaid legal position, the Applicants cannot be deprived of benefit of increment which was due on 1st July of the concerned year. All that learned P.O. submits that since the Applicants have approached belatedly, the actual monetary benefits be restricted to three years preceding to filing of Original Applications. I find merit in her submission on the point of arrears. Indeed, the Applicants have filed these proceedings long after retirement when they aot knowledge of the judgment of the Hon'ble Supreme Court giving benefit of increment due on next day of retirement. Be that as it may, insofar as arrears are concerned, it will have to be restricted to three years preceding to the date of filing proceeding."

9. In view of the judgments relied upon by the learned counsel for the applicants there has remained no doubt that the employees who stood

retired on 30<sup>th</sup> June of their respective year of retirement on attaining the age of superannuation, must be held entitled for next increment which fell due on immediately next day of their retirement and all the consequential benefits deserve to be granted in their favour. Hence, the following order :-

## <u>O R D E R</u>

(i) The applicant is held entitled for increment which fell due on 1<sup>st</sup> July, 2021 and all the consequential benefits which may flow, if such increment is extended in his favour, the respondents shall ascertain the factual matrix and if it is noticed that the applicant got retired on 30<sup>th</sup> June, 2021 without being any departmental enquiry pending against him or for any other reason simply on attaining the age of superannuation, extend the said benefit in favour of the applicant within 8 weeks from the date of this order.

(ii) There shall be no order as to costs.
