- 2. In O.A. 216/16, this Tribunal by judgement dated 10.04.2019 set aside the impugned orders dated 07.09.2019 and 13.10.2015 and issued directions to the Government Respondents to reinstate the Applicant within one month from the date of judgement.
- 3. Smt. K.S. Gaikwad, learned P.O. submitted that the department contemplates to file Writ Petition against the order passed by this Tribunal and for that purpose, the opinion of Law and Judiciary Department has sought. At the same time, she submits that if the Law and Judiciary Department gives adverse opinion, in that event, the department will implement the order. She, therefore, requested for grant of time. She has pointed out that because of ongoing vacation, the file could not be proceeded earlier.
- 4. Whereas, the learned Advocate for the Applicant opposed the application by contending that the department had availed enough time to implement the order.

No further time will be granted.
