- 3. Learned P.O. submitted that Government employee cannot insist for posting at a particular place. Learned P.O. has submitted that no case is made out by the applicant showing that respondents have exercised powers *mala fide* or in arbitrary manner while transferring the applicant on promotion at Pune. Learned P.O. has, therefore, prayed for rejecting the M.A.
- 4. I have considered the submissions made by the learned Counsel and the learned P.O. The applicant is opposing his posting at Pune on the ground that his father is suffering from Cancer, his mother is ailing and other family difficulties. Record produced by the applicant himself reveals that the applicant has given options for his posting at Boriwali, Panwel, Nashik, Pachora etc. Considering the fact that, before a month of issuance of the order of transfer applicant was ready to be transferred at Boriwali, Panwel, Nashik, Pachora etc., he must show some specific reasons for his unwillingness to join duty at Pune. So far as the issue of treatment of his father is concerned, it can be better done at Pune.

5. Moreover, the applicant cannot insist for his posting at a particular place. It is the prerogative of the Government to transfer an employee at a particular place in view of the administrative need. If every employee who is transferred makes a representation and seeks posting of his choice, it may not be possible for the administration to give choice posting to everyone. Unless mala fides apparent on the face of record are shown or any gross violation of the transfer rules or guidelines are noticed, Tribunals or Courts are not expected to interfere in such transfer orders. I, therefore, see no reason for accepting the request of the applicant. Hence, the following order:

ORDER

Prayer for interim relief is rejected. M.A. stands dismissed. No costs.
