2. This is an application seeking amendment in the Original Application. The following prayer clause is sought to be added in the O.A. :-

"(i-a) This Hon'ble Tribunal be pleased to hold and declare that the service rendered by the applicants during their contractual employment deserves to be treated as regular employees by regularizing their service from initial date of appointment and grant continuity of service from their first date of appointment for all the proposes including back wages in the interest of justice."

3. The learned counsel for the applicants submits that the prayer, which is now sought to be added, is in consonance with the prayers made in the O.A. He further submitted that no nature of O.A. is likely to be changed if the amendment is allowed. He therefore prayed for allowing the application for amendment.

4. The learned Presenting Officer opposed the application stating that the amendment is sought at the fag

end of hearing and there is no explanation as to why the amendment was not sought by the applicant at the earlier stage. The learned P.O. therefore opposed for allowing the application for amendment.

5. It is true that the amendment could have been sought at the earlier stage. However, since the amendment is in consonance with the prayers made in the O.A., only on ground that the amendment is sought at the fag end of hearing of the O.A., it cannot be rejected. Hence we pass the following order :-

ORDER

- (i) M.A. No. 458/2022 is allowed with no costs.
- (ii) The applicant to carry out the necessary amendment in O.A. within one week from the date of this order and supply amended copy of O.A. to the other side.
- (iii) It would be open for the respondents to file additional reply, if they so desire, to the amended portion of O.A.
- (iv) O.A. to come on board on 22.11.2022 for filing additional reply, if any, and for hearing.

2. The applicant is at present working on the post of Naib Tahsildar. The applicant entered into the Government service as Talathi in the year 1991. He was promoted to the post of Circle Officer in the year 2012 and thereafter promoted to the post of Naib Tahsildar in the year 2020. In 2011 the applicant sought transfer from Udgir Sub-Division to Latur Sub-Division on request. Initially, in the Latur Sub-Division seniority of the applicant in the cadre of Talathi was fixed at the bottom in the cadre of Talathi. The applicant raised objection, which was accepted and his seniority was corrected as stated in the application. Learned Counsel appearing for the applicant submitted that thereafter the applicant was promoted to the post of Circle Officer and thereafter to the post of Naib-Tahsildar.

3. Learned counsel referring to the judgment delivered by the Nagpur Bench of this Tribunal in the case of **Shri Dnyaneshwar S. Kapkar Vs. State of Maharashtra & Ors., O.A. No. 749/2015 decided on 10.03.2017**, submits that against the law laid down in the said judgment in the seniority list published on 12.8.2022 the applicant is given a lower position in the cadre of Talathi as on 1.1.2021. The applicant is, therefore, apprehending that he may be subjected to reversion. The applicant has, therefore, approached this Tribunal with following prayers: -

“A) This Original Application may kindly be allowed thereby restraining the Respondents in general and the Respondent No. 1 in particular from cancelling promotion given to the applicant from the cadre of Circle Officers to the cadre of Naib Tahsildars vide order dated 31/12/2020 (Annex. A-8) and further directing the respondents to continue to extend to the applicant all service benefits on the basis of the said order of his promotion.

B) This Original Application may kindly be allowed thereby directing the Respondents to count applicant's seniority in the cadre of Talathi w.e.f. the year 1991 i.e. w.e.f. the year of his entry therein and not to count it from the year 2011.

C) This Original Application may kindly be allowed thereby directing the respondents to extend to the applicant all the consequential service benefits to which he would be entitled in view of grant of Pryaer Clauses “A” and “B” in his favour.

D) Costs of this Original Application may kindly be awarded to the applicant.

E) Any other appropriate relief as may be deemed fit by this Hon'ble Tribunal may kindly be granted.

The applicant is seeking following interim reliefs: -

“F) Pending the admission, hearing and final disposal of this Original Application the Respondents in general and the REsp. No. 1 in particular may kindly be restrained from cancelling applicant's promotion to the cadre of Naib Tahsildars.

AND/OR

G) Pending the admission, hearing and final disposal of this Original Application the Respondents may kindly be directed to continue the applicant in the cadre of Naib Tahshildars and not to revert him to the cadre of Circle Officers.”

4. Learned counsel for the applicant submitted that the respondents have grossly erred in changing the seniority of the applicant in the cadre of Talathi after the period of more than 9 years. Learned counsel further submitted that for the aforesaid reasons the applicant apprehends that the respondents will revert the applicant. He, therefore, prayed for grant of *interim relief*, as prayed in the application.

5. Learned Chief Presenting Officer has sought time to file affidavit in reply. Learned Presenting Officer submitted that without instructions from the respondents it may not be proper on his part to make any submission. Learned CPO in principle, however,

objected for granting interim relief justifying the action taken by the State.

6. We have considered the submissions advanced by the learned Counsel appearing for the applicant and the learned Chief Presenting Officer for the respondents. We have also perused the documents filed on record by the parties.

7. From the record, it appears that the applicant entered into the Government service as Talathi in the year 1991. It further appears from the record that in the year 2011 the applicant got changed his Sub-Division on request from Udgir Sub-Division to Latur Sub-division. It also appears from the record that the act on the part of respondents to place the applicant in seniority list of Latur Division at the bottom in the cadre of Tahsildar was objected by the applicant and said objection was sustained. It further appears from the record that in the year 2012 the applicant was promoted to the post of Circle Officer. It also transpires from the record that the applicant got further promotion on the post of Naib Tahsildar in the year 2020.

8. At this stage, there is no reason to disbelieve the documentary evidence placed on record by the applicant. Considering these documents, the apprehension in the mind of the applicant cannot be said to be misplaced since again he has been placed on lower position in the seniority list published in the

current year. It appears to us that *prima face* case is made out by the applicant and balance of convenience also lies in favour of the applicant. We are, therefore, inclined to pass the following order: -

ORDER

(i) Issue notice to respondents, returnable on 18.11.2022.

(ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

(iii) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

(iv) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.

(v) The service may be done by hand delivery, speed post, courier and acknowledgment be obtained and produced along with affidavit of compliance in the Registry before due date. Applicant is directed to file affidavit of compliance and notice.

(vi) The respondents shall not revert the applicant from the present post of Naib-Tahsildar until further orders by this Tribunal.

2. The present applicant has passed MBBS from D.Y. Patil Medical College, Kolhapur in November, 2001 and has also completed PG Diploma in Clinical Pathology from Government College, Pune. The applicant now intends to take admission for PG course as in service candidate. For in service candidates 20% seats are reserved as per the Government Resolution dated 26.9.2022.

3. The applicant has applied praying for her recommendation for PG course as in service candidate. Respondent No. 3 has held the applicant not eligible for in service quota and held her eligible only for study leave in general quota for degree pathology. In the remarks column the reference of Government Resolution dated 19.3.2019 and 26.3.2020 is given.

4. It is the grievance of the applicant that the prayer so made by her has been denied by the respondent No. 3 for wrong reasons. It is her contention that the candidates who have secured less meritorious position than her in the NEET examination have been held eligible as in service candidate, but she has been held not eligible. Shri Shamsunder Patil learned counsel appearing for the applicant invited our attention to the list of in service Medical Officers, who have applied for PG course as in service candidates, which is at page Nos. 28 to 44 of the paper book. Learned counsel pointed out that the candidates who have not served in any of the tribal, remote or difficult area have also held eligible for in service quota. He cited the example of the candidates at Sr. No. 20 namely Anup R. Naik and submitted that though the said candidate also does not seem to have worked in any of the tribal/remote or difficult area, he has not been held not eligible on the said ground, but on the ground that NOC was not obtained before NEET PG examination. The learned counsel further submitted that for Scheduled Caste in-service candidates 02 seats are reserved for admission in PG Course in Pathology. The learned counsel submitted that the applicant being only Scheduled Caste candidate seeking appointment to PG course in Pathology as in-service candidate there was no reason for holding the applicant not eligible. The learned counsel, in the circumstances, prayed for interim relief in favour of the applicant thereby directing the respondents to provisionally admit the

applicant for PG Course in Pathology as in-service candidate, subject to outcome of the present OA.

5. The learned CPO has opposed for grant of any such relief. He has submitted that since the applicant has not at all worked in any of the tribal/remote or difficult area and has been throughout working in Urban area, she cannot be recommended to the PG course as in-service candidate. He further added that in view of the GR dated 19.3.2019 and more particularly clause 6.3 thereof the applicant is however entitled for study leave for completing the PG course in Pathology.

6. We have carefully considered the submissions advanced on behalf of the applicant, as well as, the respondents. As per the GR dated 26.9.2022, 20% of the total seats of the PG Degree course, as well as, PG Diploma courses are reserved for in-service candidates. In the said GR Clause no. 2 thereof provides that for selection of in-service candidates for admission in PG Course the guidelines given in the GR dated 19.3.2019 would be followed. We have carefully perused the GR dated 19.3.2019. Perusal of the said GR leaves no doubt that for recommendation as in-service candidates to get admission for PG course on deputation the candidates concerned must have worked for 3 years in most remote, difficult and rural areas. List of such areas and the Institutions / Hospitals and Health Institutions is provided in another GR of the same date of 19.3.2019. The

applicant has admittedly not worked in any of the remote, difficult or tribal area. The applicant has worked for more than 8 years in the Urban area i.e. in the Government Hospital at Ahmednagar. It is thus evident that she is not entitled for being recommended as in-service candidate to get admission to PG course on deputation. However, in clause 6.3 of the GR dated 19.3.2019 it has been provided that if any candidate has worked for more than 5 years in the Government Hospitals or Institutions, such Medical Officer for doing P.G. is entitled for study leave of 2 years and would also be entitled for leave at his or her credit (Earned Leave, Half Pay Leave or Commuted Leave) for the period of 4 months and such candidate also can be granted extra-ordinary leave for remaining period of 8 months and such candidate will be entitled for the leave salary of the post from which he/she applies for the PG course.

7. Having regard to the aforesaid provisions it does not appear to us that any *prima-facie* case is made out by the applicant so as to accept her request for grant of interim relief in her favour. We are therefore not inclined to grant any interim relief in favour of the applicant as has been prayed for in the application. However, for adjudication of the issues raised by the applicant we deem it appropriate to issue notices to the respondents. Hence the following order:-

ORDER

(i) Issue notice to respondents, returnable on 28.11.2022.

(ii) Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

(iii) Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

(iv) This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal (Procedure) Rules, 1988, and the questions such as limitation and alternate remedy are kept open.
