2. The Original Application is filed challenging the impugned order of transfer of the applicant dated 9.12.2022 (Annexure A-8 page 72 of paper book) issued by respondent no. 2 i.e. the Director General of Police, Maharashtra State, whereby the applicant has been transferred from the post of Assistant Police Inspector, Aurangabad (Rural) to Mumbai City as Assistant Police Inspector.

3. The applicant entered into service as Police Sub Inspector in the year 2012. After completing requisite training, in the year 2013, he was posted in Jalna District in Aurangabad Range. He worked there till 2015. Thereafter the applicant was transferred to Osmanabad District in Aurangabad Range itself, where he worked till 2020. On

29.10.2020 the applicant was transferred to Aurangabad (Rural) on administrative ground. After this transfer initially the applicant worked for some period in Control Room. Thereafter by order dated 10.2.2021 (Annexure 'A-1') ssued by respondent no. 3, the applicant was posted at Khultabad Police Station. During the said tenure, the applicant was promoted to the post of Assistant Police Inspector. Before issuance of promotion order dated 28.4.2021 (Annexure A-2), the respondent no. 2 by letter dated 26.2.2021 (Annex. A-3) called for option being posted in particular Revenue Division. In view of the Revenue Division Allotment for appointment by nomination and promotion to the posts of Group "A" and Group "B" (Gazetted and Non-gazetted) of the Government Maharashtra Rules, 2015 (for short Rules of 2015) and amendments to the said rules effected vide Notifications dated 16.7.2015, 19.10.2016, 15.6.2017 & 19.7.2017 (Annex. A-4 collectively) the applicant in proforma Annex. A-5 gave option for Aurangabad Revenue Division and particularly Units of Aurangabad City, Aurangabad Range and Nanded Range for his posting on the post of API. Upon his promotion as API he was not only

allotted Aurangabad Revenue Division but was further posted in Aurangabad Range. Respondent no. 2, however, by the impugned order dated 9.12.2022 (Annex. A-8) transferred the applicant from Aurangabad (Rural) to Mumbai City.

4. It is the contention of the applicant that normal tenure of the post of API is laid down under section 22N(1)(c) of the Maharashtra Police Act as follows: -

"22N. Normal tenure of Police Personnel, and Competent Authority.

(1) Police Officers in the police force shall have a normal tenure as mentioned below, subject to the promotion or superannuation :

(a) -- -- -- --

(b) -- -- --

(c) for Police Officers of the rank of Police Sub-Inspector, Assistant Police Inspector and Police Inspector a normal tenure shall be of two years at a Police Station or Branch, four years in a District and eight years in a Range, however, for the Local Crime Branch and Special Branch in a District and the Crime Branch and Special Branch in a Commissionerate, a normal tenure shall be of three years.-"

5. Further according to applicant, in terms of Rule 9 (1) (b) of Rules 2015, he shall be entitled to complete service of minimum 6 years in the allotted Revenue Division.

6. The applicant is working on the post of API at Khultabad Police Station in Aurangabad Range since 28.4.2021 and before that from 10.2.2021 on the post of PSI. He has not completed 2 years tenure at the said Police Station or 4 years tenure in District or 8 Aurangabad vears service in Aurangabad Range as contemplated U/s 22N(1)(c) of Maharashtra Police Act nor has he completed 6 years service as per rule 9(1)(b) of Rules 2015, by which the applicant is governed. In view of that the impugned transfer order of the applicant is midterm and mid-tenure.

7. The impugned order of transfer though issued on 9.12.2022 (Annexure 'A-8') respondent No. 2 has termed it as general order of transfer. Definition of general transfer laid down in Section 2(6)(a) of the Maharashtra Police Act means posting of a Police Personnel in the Police Force from one post, office or

department to another post, office or department in the month of April & May of every year after completion of normal tenure as mentioned in Subsection (1) of Section 22N.

8. In the circumstances as above, the learned counsel for the applicant seeks interim order of stay to the execution and implementation of the impugned order of transfer as it is in contravention of provisions of Maharashtra Police Act, as well as, Rules of 2015.

9. The learned Chief Presenting Officer vehemently opposed the submissions raised on behalf of the applicant and placed on record the minutes of meeting of the requisite Police Establishment Board No. 2 dated 9.12.2022, G.R. dated 27.5.2022 and specification sheet in respect of various postings and transfers of the applicant.

10. In view of the aforesaid documents, the learned C.P.O. vehemently urged before me that specification sheet would show that the applicant has completed 8 years tenure in Aurangabad Range from 4.10.2013 till 31.5.2022. During the said

period he was posted initially at Jalna from 4.10.2013 to 3.10.2015, in Osmanabad district from 6.10.2015 to 30.10.2020 and in Aurangabad Rural from 25.11.2020 till date. By 31.5.2022 applicant has completed 8 years tenure in Aurangabad Range. In view of the same, according to him, applicant was due for transfer in general transfers to be effected now in view of meanwhile GR dated 27.5.2022 issued by GAD prohibiting transfers up to 30.6.2022 and exceptionally allowing transfers with permission of Hon'ble Chief Minister. In view of the same, according to learned C.P.O., impugned transfer order is legal and proper and no *prima facie* case is made out by the applicant to grant stay to the impugned transfer order.

11. Having considered the contentions raised in the O.A. together with annexures and rival submissions of both sides, it is evident that *prima facie* the impugned transfer order revolves around provisions under Section 22N(1)(c), as well as, Rule 9(1)(b) of Rules of 2015 and amendments therein during the period from 2015 to 2017.

12. Perusal of documents produced by learned C.P.O. on behalf of respondents would show prima facie that impugned transfer order of the applicant and others has been issued with the approval of Police Establishment Board No. 2, which is competent authority per Section 22N(2), as Explanation, for Police Personnel up to the rank of Police Inspector for transfer out of the respective Range or Commissionerate or Specialized Agency. By the impugned transfer order applicant has been transferred from Aurangabad Range to Mumbai City.

13. Perusal of the documents and pleadings would show that after completion of training, applicant was posted at Jalna district on 4.10.2013. Jalna district falls in Aurangabad Range. Subsequently, applicant worked in Osmanabad district from 6.10.2015 to 30.10.2020, which also falls in Aurangabad Range and thereafter from 25.11.2020 till date applicant is working in Aurangabad rural, which also comes in Aurangabad Range.

14. Initial appointment of applicant on the post of PSI falls in Group 'B' category, but it is non-gazetted post. There is no pleading as to whether at the time of his initial appointment, option under then prevailing rules viz. the Divisional Cadre Structure Divisional Cadre Allotment and for direct appointment by nomination to the posts of Group "A" and Group "B" (Gazetted and Non-gazetted) of the Government Maharashtra Rules, 2010 was obtained from the applicant or not. However, it is a fact that at the time of his promotion from PSI to API, which was issued on 28.4.2021 (Annex. A-2) option of Revenue Division was called for and the applicant gave option of Aurangabad Division. In Aurangabad Division there are 2 Ranges namely Aurangabad Range and Nanded Range. The applicant gave 3 options i.e. for Aurangabad City, Aurangabad Range and Nanded Range. If that is so, as per rule 9(1)(b) of rules of 2015, the applicant is entitled to stay in this Division up to 6 years. There is also rule 8 in rules of 2015, which speaks about tenure after a candidate being appointed by nomination. Said rule 8 of rules 2015 reads thus :-

:: - 9 - :: O.A. NO. 1113/2022

"8(1) A candidate appointed by nomination, -

(b) in Group 'B' cadre shall be required to complete service of minimum nine years in the allotted Revenue Division."

15. In the present case the applicant was directly appointed as a PSI. If rule 8(1)(b) of rules of 2015 is taken into consideration then the applicant shall be required to complete service of minimum 9 years in the allotted Division.

16. In view of above, it appears that the tenure of Government servant in the cadre of Group-B Gazetted and Non-gazetted, as well as, Group – A is also governed by Rules of 2015, as well as, concerned provisions of Transfer Act. In this case the applicant being Police Officer, the provisions of section 22-N of the Maharashtra Police Act would be applicable.

17. In this background, if the minutes of meeting of Police Establishment Board No. 2 are considered the said minutes refers only to the provisions of the transfers under Maharashtra Police Act and Rules of 2015 are not referred. If 2015 rules are considered for examining the case of the applicant, prima-facie, it seems that there is contravention at least of rule 9(1)(b)

thereof, which provides 6 years tenure within Aurangabad Division. If this is taken into consideration, the applicant can be posted either in Aurangabad Range or Nanded Range, which both come under Aurangabad Revenue Division.

18. Therefore, prima-facie, in my considered opinion, the legality of the impugned order is required to be considered from various angles and till then it would be just and proper to grant interim stay for execution and implementation of the impugned order of transfer till filing of affidavit in reply by the respondents. It is ordered accordingly.

19. Issue notice to the respondents, returnable on 13.1.2023.

20. Tribunal may take the case for final disposal at once and separate notice for final disposal shall not be issued.

21. Applicant is authorized and directed to serve on respondent/s intimation/notice of date of hearing duly authenticated by Registry, along with complete paper book of the case. Respondents are put to notice that the case would be taken up for final disposal at the stage of admission hearing.

22. This intimation/notice is ordered under Rule 11 of the Maharashtra Administrative Tribunal
